## Joint Report by Head of Finance &amp; Executive Director (Environment)

**PURPOSE OF REPORT**

This report details the Income and Expenditure to 2 September 2013 and the projected outturn to 31 March 2014.

**1. BACKGROUND / MAIN ISSUES**

- 1.1 The Committee approved the budget at the meeting of 1 May 2013. This report provides the monitoring position and projected outturn for the Financial Year 2013/2014.

**2. PROPOSALS**2.1 Financial Statement 2013/14

On the basis of Appendix 1, it is anticipated that a surplus of £315 will be generated in 2013/14 and the Fund's estimated Revenue Account Balance will be £84,492 at 31 March 2014.
