#### **39. MINUTES OF PREVIOUS MEETINGS**

#### (i) Show Racism the Red Card

The Convener was delighted to announce that David McPhee of Housing and Community Care was to be admitted to the Hall of Fame of the national antiracism charity *Show Racism the Red Card* in recognition of the exceptional commitment he has shown to the work of the charity's anti-racism campaign over many years.

#### (ii) Scottish Police Authority Draft Strategic Plan

The Convener reported that the Scottish Police Authority had now embarked upon a period of consultation on its Draft Strategic Plan. The draft Plan set out the strategic direction for both the Scottish Police Service and the Scottish Police Authority for the coming year. The consultation closes on 22 February 2013.

## 40. COMMUNITY PAYBACK ORDERS – ANNUAL REPORT 2011/12 (Art. 258/12)

There was submitted a report by the Executive Director (Housing and Community Care) (13/50) (1) providing an update on the implementation and operation of Community Payback Orders in Perth and Kinross in accordance with the requirements of the Criminal Justice and Licensing Act (Scotland) 2010, and (2) advising of the overall success in the reduction of reoffending within Perth and Kinross.
