Minute of hybrid meeting of the Perth Common Good Fund Committee held in the Council Chamber, 2 High Street, Perth on Monday 27 November 2023 at 1.00pm.

1. WELCOME AND APOLOGIES

The Convener welcomed all those present to the meeting and apologies were noted above.

2. DECLARATIONS OF INTEREST

There were no declarations of interest made in terms of the Councillor's Code of Conduct.

3. MINUTE OF MEETING OF THE PERTH COMMON GOOD FUND OF 27 SEPTEMBER 2023 FOR APPROVAL

The minute of meeting Perth Common Good Fund of 27 September 2023 was submitted and approved as a correct record.

4. MATTERS ARISING

No matters were raised.

5. COST OF LIVING GRANT

There was submitted a report by the Head of Cultural and Community Services (23/333); requesting the Perth Common Good Fund Committee to come to an agreement concerning provision for additional Cost of Living support across the duration of winter.

Resolved:

- (ii) It was agreed by the Committee that there was a need to raise awareness of availability of the Common Good Fund through Council Communication channels to assist with the cost of living crisis.

6. APPLICATIONS FOR FINANCIAL ASSISTANCE

There was submitted a report by the Head of Cultural and Community Services (23/251) asking Perth Common Good Fund Committee to consider two small grant applications and two capital grant applications.

Small Grants:

- (i) Wednesday Tea Dance Christmas Party be awarded a grant of £450 in support of their annual Christmas Party held at the Perth Civil Service Club.
- (ii) Holiday@Home be awarded a grant of £2000 in support of their 3-day Activities in July 2024.

Capital Grants:

- (i) Moncrieffe Primary School Parent Council be awarded £11,877 to go towards extending their current trim trail at the school to include a wooden gazebo that will act as an outdoor classroom for students.
- (ii) Perth Highland Games be awarded £3,560 to go towards purchasing a new stage for their Highland Games Dancing competition.

APPLICATIONS FOR FINANCIAL ASSISTANCE

Report by Head of Cultural and Community Services (Report No.24/27)

1. PURPOSE

1.1 The report asks Perth Common Good Fund Committee to consider an application towards St John's Kirk Carillon; four small grant applications and one cost of living grant application.

2. RECOMMENDATION

- 2.1 It is recommended that the Committee:
 - considers the grant applications and agrees any financial assistance to be awarded.

4. BACKGROUND / MAIN ISSUES

- 4.1 Perth and Kinross Council owns land and property which forms part of the Common Good of the former burghs in Perth and Kinross and has a statutory duty in terms of section 15 of the Local Government etc. (Scotland) Act 1994 to administer this land and property "having regard to the interests of the inhabitants" of those former burghs. This duty also applies to the administration of the associated Common Good Funds.
- 4.2 The Common Good Funds have traditionally demonstrated their support to local residents and organisations by distributing grants. These grant awards allow individuals and local organisations to carry out a wide range of community-based activities.
- 4.3 Applications to Common Good Funds vary across the different former burghs of Perth and Kinross. The Perth Common Good Fund is larger and receives a

- much higher number of applications than the other Funds. Therefore, additional criteria are applied to assist with assessing applications (See Appendix 1).
- 4.4 The 2023/24 Budget for the Perth Common Good Fund was approved at the Committee meeting on 6 February 2023 (Report 23/37 refers). A summary of the approved Financial Assistance budget, committed grant funding, and the budget remaining, is provided below:

5. PROPOSALS – ST JOHN'S KIRK CARILLON

- 5.1 St John's Kirk of Perth have requested their full allocated annual grant of £2,000 from Perth Common Good Fund to assist them with the costs relating to their 2023/24 Carillon Programme. Throughout the current financial year, they have planned 16 recitals ranging from Medieval Dance Music to Christmas Carols. The programme ensures that the Bells of Perth are played regularly, whilst working around the ongoing spire works. It is estimated that 5,000 people from the Common Good Area will benefit this project, including those near and passing by during the bells, with a large increase expected in the next financial year once Perth Museum opens.
- 5.2 The total cost of the recitals is estimated to be at least £2,240 with full costs for publicity and lighting yet to be determined. The group are requesting a grant of £2,000 as annually allocated by the Committee.

Consideration

5.3 In line with prior agreement for this funding, it is considered that a grant of £2,000 is appropriate in these circumstances.

6. PROPOSALS - SMALL GRANTS

Perth Chinese Association

- 6.1 A grant of £2,236 has been requested from Perth Chinese Association. The grant is for part of their annual event to share their annual Chinese Cultural Celebration with residents in Perth and Kinross on Sunday 11th February 2024. The plans for this year's celebrations include a procession starting from 2 High Street, circling the Museum with a blessing for its upcoming opening. The procession will then return to 2 High Street for an afternoon of entertainment and craft stalls. This project is estimated to benefit 1750 people in the Common Good Area, with participants in the event also coming from other areas in Perth and Kinross and further afield.
- 6.2 The total cost for the event is estimated at £5,588. The group are requesting £2,236 to assist with the costs. The group have indicated that they can contribute £1,000 and have received £750 from the Council's Equalities budget. A full breakdown of the total costs is provided below.

Consideration

6.4 It is considered that a grant of £2,240 is consistent with Criteria 9.2a.

Perth Flower Club

- 6.5 A grant of £350 has been requested from Perth Flower Club. The grant will assist the group in hiring a coach to take their members to Tomnah'a Gardens at Comrie Croft. The trip will enhance the members existing knowledge and passion for flora and fauna, whilst learning new regenerative techniques and processes being applied to horticulture. It is estimated that 30 people from the Common Good Area will benefit from the trip as well as 5 people from elsewhere in Perth and Kinross.
- 6.6 The total cost of the trip is estimated at £350, covering the coach hire only. The group are requesting the full amount. Perth Flower Club have not received Common Good funding in the last three years.

Consideration

6.7 It is considered that a grant of £180 is consistent with Criteria 9.6.

Perth Festival of the Arts

6.8 A grant of £1,981 has been requested by Perth Festival of the Arts. The grant will support the staging of a new series of the Festival's Community Stages Project held on the Saturdays of 25 May and 1 June. The stages will feature pop-up concerts showcasing community arts organisations and groups that involve musicians, singers and other art forms from around Perth & Kinross. It is hoped that the stages will be spread across the city. The Community Stages aim to celebrate and promote the variety of home-grown artistic talent in Perth & Kinross, bringing vibrant concerts and pop-up arts experiences to local people in a way that is fully accessible and free to the audience member. It is estimated that around 6,000 people from the Common Good Area will benefit from the wider Festival, as well as 2,600 people from elsewhere in Perth and Kinross and around 4,500 people from further afield.

6.9 The total cost of the project is estimated at £4,954, with £1,981 being requested from Perth Common Good Fund. The Group will cover the remaining £2,973 as part of the Festival budget. A full breakdown of the total costs is provided below.

Consideration

6.11 It is considered that a grant of £1,990 is consistent with Criteria 9.2a.

ESOL Perth

- 6.12 A grant of £600 has been requested by ESOL Perth. The grant will assist them with the running of guitar lessons. They have had a guitar class running for the last six months, which has been well attended by 6-8 children every week. The class is supported by one tutor and 2 young people working for their Duke of Edinburgh Award from Strathallan School. The money requested would go towards continued pay for the sessional tutor, alongside funding towards room hire and the purchase of 5 ¾-sized guitars for the young people to use during lessons and practising. It is estimated that 12 young people from the Common Good area will benefit from this project.
- 6.13 The total cost of this project is estimated at £1,500. £600 has already been secured through Robertson Trust to cover the room hire, including heating. A funding request to the Local Action Partnership is also pending to cover the guitars at a value of £300 total. A full breakdown of the costs is provided below.

Consideration

6.14 In line with Criteria 9.8, the Committee is asked to consider the request and determine the level of any grant to be awarded.

7. PROPOSALS - COST OF LIVING GRANT

Letham4All

- 7.1 Letham4All have requested a grant of £15,000 to assist them in continuing to operate their PayPoint voucher distribution as well as the purchase and distribution of Perth Cards. This continues their cash first approach, supporting people through immediate financial crisis by being able to offer small amounts of cash, via the vouchers and cards. This offers a swift and dignified resolution for those struggling during the Cost-of-Living Crisis. The grant would also help the group to maintain stock levels for their community fridges and emergency food parcels. It is estimated that 1,000 people from the Common Good Area will benefit from the project, along with 100 people from elsewhere in Perth & Kinross.
- 7.2 The total costs of this project is estimated to be £24,966, of which £9,966 is funded by other funders. The group are requesting £15,000 to cover the purchasing of Paypoint Vouchers; Perth Cards and community fridge stock.



Appendix 1

PERTH COMMON GOOD FUND REVISED FINANCIAL ASSISTANCE CRITERIA

- 1. All grants are awarded at the discretion of the Perth Common Good Fund Committee.
- 2. Within the boundary of the Perth Common Good area and if funding is available, applications will be considered from individuals and groups for projects or activities which demonstrate benefit to the residents of the City of Perth.
- 3. The Perth Common Good area is restricted to Elected Member Ward 10 Perth City South, Ward 11 Perth City North, and Ward 12 Perth City Centre. Applications for financial assistance from individuals residing or groups operating outwith the boundary of the Perth Common Good area must clearly demonstrate that the project or activity to be undertaken will provide benefit to the residents of the City of Perth.



- 4. Applications for financial assistance from schools and school groups (e.g. Parent Councils) within the Perth Common Good area will be considered regardless of where participating pupils reside.
- 5. The Financial Year for the Perth Common Good Fund covers the period 1 April to 31 March. The Perth Common Good Fund Committee meets five times per year to consider applications for financial assistance and other business matters; Committee meeting and application deadline dates are

available on the Council's Community Grants webpage via the following link: http://www.pkc.gov.uk/pkgrantsdirect.

- 6. Applications for financial assistance must be submitted to the Perth Common Good Fund Committee in advance of the project or activity taking place. Retrospective applications where expenditure is incurred during the time between the application submission deadline date and the date of the Committee meeting will be considered however the applicant must be aware that funding may not be approved by Committee.
- 7. A separate Capital Grants fund will be maintained to support applications for financial assistance towards the funding of building improvement works, and the acquisition of equipment. Applications for Capital Grant funding assistance should be submitted to the first Perth Common Good Fund Committee meeting of the new financial year, which normally takes place during April or May. The Capital Grants fund will normally close until commencement of the next financial year, however the Committee may consider late applications if Capital Grant funding remains available.
- 8. The following conditions shall apply to all applications for financial assistance:
- 8.1 The application for financial assistance must demonstrate that the funding will provide benefit to the residents of the City of Perth. The Perth Common Good Fund Committee must be satisfied that all disbursements from the fund meet this requirement and the Committee decision in this regard is full and final.
- 8.2 The Perth Common Good Fund should not be viewed as a resource to supplement the funding of Council services; applications for financial assistance from Council services are therefore not encouraged. Any application submitted by a Council service will be considered by the Perth Common Good Fund Committee on its own merits.
- 8.3 Applicants who are seeking funds to purchase resources, or undertake capital projects are asked to demonstrate that they are sourcing these from local providers where these can reasonably meet their needs.
- 8.4 All awards of £400 or less will be paid in advance, but recipients must complete an end of grant monitoring form and provide evidence of spend based on their initial application Awards greater than £400 must be claimed on completion of the project and within three months of the activity taking place. The claim should include an end of grant monitoring form and evidence of spend, based on the initial application. Funding for awards not claimed will be returned to the Fund.
- 9. Small Grants:
- 9.1 Applications for financial assistance will be considered by the Perth Common Good Fund Committee in line with the criteria below: -

- 9.2 Organisation of events/games/festivals including prize awards:
 - a) No entry fee payable by the public: up to maximum of 40% of the total actual costs.
 - b) Entry fee payable by the public (commercial event): up to a maximum of 20% of the total actual costs subject to the submission of an evidenced Income & Expenditure account for the event.
 - c) In the event, that the Common Good funding of a commercial event results in a profit, the level of funding award will be reduced accordingly.
 - d) In the event, that the commercial event is loss making, the Common Good funding may be used to underwrite the loss, subject to the level of funding approved by Committee.
 - e) Grants will not be paid for any event/games/festival which are cancelled following the approval of funding by Committee.
- 9.3 Hire of hall and provision of prizes for school prize giving ceremonies up to a maximum of 40% of total costs.
- 9.4 Voluntary work overseas by individuals: -
 - 6 months or more: up to £400 per individual
 - Up to 6 months: up to £250 per individual
- 9.5 Attendance at summer schools/events by individuals or groups of up to 5:
 - More than 2 weeks: up to £150 per individual
 - One to two weeks: up to £100 per individual
- 9.6 Excursions/Parties (up to two applications per year per group): -
 - Contribution of up to 50% towards the actual costs. Each organisation is permitted a maximum of two applications during the course of a financial year. Overall grant to be capped at £10 per individual with an overall maximum grant of up to £1,000.
- 9.7 Visits or trips by and from School/Youth/Sport/Music groups: -
 - For groups of between 6 and 10 people, a flat contribution of £500.
 - For groups of 11 or more; a contribution of £50 per person to a maximum of £1,000 for youth groups, senior citizen or vulnerable groups for activities of one week or more.
- 9.8 Any other purpose where it can be demonstrated that there is a benefit to the residents of the City of Perth.
- 10. Capital Grants: -
- 10.1 The funding of applications for Capital Grant funding will be restricted to the available annual budget.

- 10.2 It is expected that the total funding available will be fully committed at the first meeting of the Perth Common Good Fund Committee at the start of the new financial year. In the event, that funding is not fully committed, the Common Good Fund Committee may choose to either roll forward the unallocated funding to the next financial year or consider further applications during the year.
- 10.3 Acquisition of equipment and uniforms consideration on merits up to a maximum of 25% of total cost, subject to the budget available.
- 10.4 Provision and improvement of buildings consideration on merits up to a maximum of 25% of total cost and up to £50,000, subject to the budget available. Note that the facilities must be available to the general public.
- 11. Expenditure which is not eligible for funding awards:
- 11.1 Assistance with further or higher education fees
- 11.2 Charity fundraising e.g. sponsored walk/cycle/bungee etc.

- 11.4 Organisations with religious or political associations where there are restrictions on usage or availability
- 11.5 Core funding of the voluntary sector
- 11.6 Assistance with day to day running costs e.g. the rental of premises, employee costs etc.

2024/25 BUDGET & 2023/24 FINANCIAL STATEMENT

Report by Head of Finance

(Report No. 24/28)

1. PURPOSE OF REPORT

1. This report seeks approval of the budget for financial year 2024/25 for the Perth Common Good Fund, and provides details of the Income and Expenditure to 30 November 2023 and the projected outturn for Financial Year 2023/24.

2. RECOMMENDATIONS

- 2.1 The Committee is requested to:
 - (i) Approve the Perth Common Good Fund Budget for financial year 2024/25, as set out in Appendix 1;
 - (ii) Note the draft Budgets for the Fund for financial years 2025/26 and 2026/27, as set out in Appendix 1;
 - (iii) Note the projected Income and Expenditure to 31 March 2024 for the Perth Common Good Fund for the 2023/24 Financial Year, as set out in Appendix 2 to the report.

3. BACKGROUND / MAIN ISSUES

- 3.1 The budget for Financial Year 2023/24 was approved by the Committee on 6 February 2023 (Report 23/37). The Committee received financial monitoring updates at the meetings on 22 May 2023 (Report 23/145), 18 September 2023 (Report 23/250), and 27 November 2023 (Report 23/322).
- 3.2 The proposed budget for 2024/25 has been prepared based on activity undertaken in the years following the covid pandemic and cost of living crisis, and specific budget lines have been adjusted for anticipated changes in the new financial year. Appendix 1 provides the proposed 2024/25 Budget for the Perth Common Good Fund and the draft budgets for 2025/26 and 2026/27.
- 3.3 This report also provides an update on the projected outturn for Financial Year 2023/24.

4. PROPOSALS

Budget 2024/25

- 4.1 The proposed budget for 2024/25 and the draft budgets for 2025/26 and 2026/27 are at current prices and have been prepared in line with activity following the covid pandemic and cost of living crisis, and in line with the anticipated costs which are likely to be incurred in future years.
- 4.2 Appendix 1 provides a summary of the actual outturn for the years 2020/21 to 2022/23, together with the projected outturn for 2023/24. Also included is the proposed budget for 2024/25, and draft budgets for the following two financial years.
- 4.3 The proposed budgets for 2025/26 to 2026/27 achieve a surplus to provide contingency for any in-year movement in the actual income received and/or expenditure incurred.
- 4.4 The review of titles for the former burgh is complete and following a period of public consultation the findings are now available on the Perth and Kinross Council Citizen Space website. Apart from professional fees to complete the review of moveable Common Good property, there is no other financial impact on the Fund. However, there remains the risk that a common good site used for service delivery by the Council is declared surplus in the future. In this scenario, the site would transfer to the Perth Common Good Fund and the Fund would be responsible for the upkeep of the site until disposal.
- 4.5 In line with previous years, the 2024/25 Perth Common Good Fund budget and medium-term plan is based upon a strategy of distributing the annual income of the Fund, whilst protecting the Fund balance. There is a budgeted deficit in 2024/25 which is due to the Moncreiffe Island Causeway works, however, the budgeted surplus in future years will recover the deficit. There does, however, remain the risk that the balance may be eroded in the event of a shortfall in income or if expenditure budgets are exceeded in future years.
- 4.6 The proposed budget for 2024/25 essentially replicates the budget for the current year, and adjustments to specific lines are noted as follows: -
 - Repairs and Maintenance Moncrieffe Island Causeway
 A budget line has been added for the replacement of the causeway
 blockwork, and the repair or replacement of gabion baskets at the edge
 of the causeway. The estimated cost for the project is £62,000, and this
 is based upon the previous cost of works with allowances for inflation
 and optimism bias. The cost will be refined when the outcome of the
 tender process is known, which is currently timetabled for early April
 2024.

- Financial Assistance Cost of Living
 There currently is no budget allocated to this activity, however, it is
 proposed that any 2023/24 Cost of Living underspend is allocated to
 the budget line in 2024/25.
- Christmas Events Switch on Ceremony
 The contribution from the Perth Common Good Fund towards the staging of the Switch on Ceremony has remained at £40,000 since 2017/18. The costs associated with the event have steadily increased over recent years and it is, therefore, proposed that the contribution from the Fund is increased to £50,000 for financial year 2024/25 onwards.
- 4.7 The anticipated budgeted deficit for 2024/25 is £13,300 which is mainly due to the increased Repairs and Maintenance costs in 2024/25.

Financial Statement 2023/24

- 4.8 Appendix 2 provides the 2023/24 Financial Statement which includes the Budget approved by Committee on 6 February 2023 (Report 23/37 refers).
- 4.9 The year end projections for Financial Assistance have been updated in line with the funding requests to be considered by Committee at this meeting. The anticipated underspend to 31 March 2024 across all Financial Assistance budget lines is £24,040. There are currently no other changes to year end estimates for income or expenditure.
- 4.10 The previously reported deficit of £7,800 is now projected to be a surplus for 2023/24 of £16,240 and the estimated Fund balance at 31 March 2024 is £1,961,588.
