There was submitted a report by the Executive Director (Housing and Community Care) (15/7): (1) advising of “Equally Safe”, a Scottish Government strategy for the prevention and eradication of violence against women and girls, and (2) detailing proposals for governance and implementation in Perth and Kinross.

**Resolved:**

- (i) It be noted that the local authority role in implementing the Equally Safe Strategy is entrusted to the Perth and Kinross Violence Against Women Partnership as it develops and takes forward a local Action Plan which reflects the priorities in the national strategy.
- (ii) The Executive Director (Housing and Community Care) be instructed to bring a further report to the Community Safety Committee on the key elements of the Action Plan as it emerges.

**17. COMMUNITY PAYBACK ORDERS ANNUAL REPORT**

There was submitted a report by the Executive Director (Housing and Community Care) (15/8) providing an update for the period 2013/14 on the operation of Community Payback Orders in Perth and Kinross which are managed and delivered by the Community Safety Service, specifically the Public Protection Team and the Unpaid Work Team in accordance with the requirements of the Criminal Justice and Licensing (Scotland) Act 2010.

**18. JOINT PUBLIC HEALTH PROTECTION PLAN**

There was submitted a report by the Depute Director (Environment) (15/9): (1) seeking approval of the final draft of the Tayside Joint Public Health Protection Plan for 2014/15. The Plan provided an overview of health protection priorities, provision and preparedness within Tayside and was prepared by NHS Tayside in consultation with Angus, Dundee City and Perth and Kinross Councils.

**(i) Scottish Fire and Rescue Service Local Service Delivery – Interim Activity Report**

In response to questions from the Committee on Report 15/11, Group Manager Middlemiss provided further information on: (1) the Safe Drive Stay Alive Community Engagement Event for young drivers aged between 17 and 25 years which had taken place at Bell's Sport Centre, Perth on 25 and 26 November 2014; and (2) the community engagement and partnership safety initiatives which had been implemented prior to Bonfire Night, 5 November 2014.

The interim activity of the Scottish Fire and Rescue Service in local service delivery in Perth and Kinross for the period 1 October to 31 December 2014 as detailed in Appendix 1 to Report 14/473, be noted.

**(ii) Police Scotland - Perth and Kinross Local Policing Area Interim Update – 1 October to 31 December 2014**

There was submitted a report by Chief Superintendent Smith, Police Scotland 'D' Division (Tayside) (15/12) providing an interim update on the performance results and work which had taken place within the Perth and Kinross policing area for the period 1 October to 31 December 2014 in the priority areas of: (1) serious and organised crime; (2) public protection and safety; (3) road safety; (antisocial behaviour; (4) major events and planning; (5) theft, housebreaking and scams, and (6) community engagement.

The Chief Superintendent provided the Committee with further details on proposals to restructure the territorial command area within Tayside Division and to introduce a new shift pattern for uniformed officers. The new arrangements will provide a greater number of available front line officers at times of peak demand and a larger proportion of frontline uniformed officers within Community Policing Teams.

- (i) The interim update on local policing area performance results for Perth and Kinross for the period 1 October to 31 December 2014, as detailed in the Appendix to Report 15/12, be noted.
- (ii) The proposal to introduce a new policing model in Tayside which will lead to an increase in Community Policing Officers be noted.
