. GRANT OF TAXI OPERATOR LICENCE NO. X30

There was submitted a report by the Head of Legal and Governance Services (20/143) regarding the Grant of Taxi Operator Licence No. X30.

The applicant was in attendance, he addressed the Committee and answered members' questions.

FOLLOWING A SHORT ADJOURNEMENT, THE COMMITTEE RECONVENED

Motion (Councillors C Ahern and D Illingworth):

Refuse the application for Taxi Operator Licence No. X30, as there was not sufficient evidence to support exceeding the current limit on taxi numbers in Blairgowrie.

Grant the application for Taxi Operator Licence No. X30 as it was considered that there was sufficient unmet demand to justify exceeding the current limit on taxi numbers in Blairgowrie, on the condition that the holder of the licence must have a wheelchair accessible vehicle.
