POLICE AND FIRE REFORM: LOCAL SCRUTINY AND ENGAGEMENT

PERTH & KINROSS LOCAL POLICING AREA PERFORMANCE RESULTS 1st APRIL 2013 TO 30th JUNE 2013

RECOMMENDATION

- 1.1 It is recommended that members:
 - (A) Note, scrutinise and question the content of this report.

2 RECORDED CRIME

2.1 Perth & Kinross LPA evidenced reductions in violent crime when compared to the average of the previous 5 years

A reduction in overall violent crime of 12% (5 fewer victims) A reduction in serious assaults of 20% (3 fewer victims) A reduction in robbery of 60% (6 fewer victims)

2.2 Reductions were also achieved in

Housebreaking (including attempts) – 36% (14 fewer victims) Shoplifting - 20% (29 fewer victims) Vandalism – 29% (88 fewer victims)

- 2.3 Overall, Group 1-4¹ recorded 999 crimes and evidenced a reduction of 7% compared with the 5 year average (76 fewer crimes).
- 2.4 37 crimes of indecency were recorded, a 42% increase on the 5 year average of 26. However, it should be noted that approximately a third of these crimes had been retrospectively reported and did not occur this year. Recent, well publicised cases involving historic abuse have, perhaps, given victims greater confidence to report matters to the police knowing they will be thoroughly investigated. Some of the crimes were linked and involved the same victims and/or perpetrator. There was also an increase in crimes linked to the use of internet, phones etc.

¹ Groups 1-4 refer to an amalgamation of four crime groups. They are Group 1, consisting of violent crime; Group 2 covering sexual offences; Group 3, the largest, covers a wide range of crimes of dishonesty; and Group 4 includes vandalism, fire-raising, and malicious mischief.)

2.5 Common assault mainly occurred in Perth City Centre and North Perth areas and approximately 50% of occurrences involved alcohol. Just over 27% of occurrences included a domestic aggravation. In terms of locus, just over 50% occurred in residential private spaces, approximately 33% in open spaces and a further 15% took place in or on public premises.

A Centre Safe plan has been created for Perth City and others are being developed for the outlying towns. These will ring fence dedicated resources to proactive and preventative patrols in the hot spot areas, at the identified times and days.

Campaign Against Violence resources will be deployed in Perth City to focus on hotspots identified by intelligence. The post of Crime Performance Officer has been created within Perth and Kinross and this officer reviews common assault on a daily basis to ensure that each incident is correctly recorded and managed. Several initiatives, involving Partners, especially in terms of educating and informing young people have also been developed as a deterrent to this type of behaviour.

Where this is a domestic crime it is dealt with by the dedicated Tayside Division Domestic Abuse Investigation Unit and victims of such abuse are referred to partner agencies.

3 DETECTION RATES

3.1 Improvements in detection rates, against the 5 year average were evidenced in the following:-

Serious assault 100% - 5 year average 99.7% Robbery 100% - 5 year average 97% Common assault 82.9% - 5 year average 80.9% Vandalism 39.7% - 5 year average 37.5%

3.2 Detection rates for the following were below the 5 year average

Housebreaking (including attempts) 28.0% - 5 year average 28.8% Shoplifting 86% - 5 year average 89%

- 3.3 The detection of the supply, production etc of drugs is reliant on intelligence and, thereafter, the targeting of drug dealers can take a lengthy period to develop. Once an operation comes to fruition, however, multiple crimes and seizures can occur. Indeed, the figures in this report cover only the first quarter of the fiscal year but by the first week in August the position had been reversed and the number of detections this year was slightly above the five year average.
- 3.4 All investigations of rape, irrespective of geographically location, are now dealt with centrally by the Tayside Division Rape Investigation Unit and supplemented by the National Rape Investigation Unit (North Hub).

Detection rates in this area can fluctuate for several reasons; often detections hinge on forensic evidence and the volume of cases being dealt with by the laboratories cause's back-logs which can delay investigations significantly. Cases of a

historical nature are not unusual and recent, well publicised cases involving sexual abuse have, perhaps, given victims greater confidence to report matters to the police knowing they will be thoroughly investigated. Cases of this nature often involve several crimes which will be detected all at the same time thus leading to a rise in the overall detection rate.

3.5 Significant detections for the following were above the five year average and this is due to emphasis on enforcement to influence driver behaviour to keep people safe and deny criminals use of the road networks:-

Speeding 713 – 5 year average 383 Seat belt offences 136 – 5 year average 34 Mobile phones 196 – 5 year average 38

Currently there is greater focus on criminal activity of road users in terms of keeping people safe and denying criminal's use of the road network. This has increased performance in areas such as dangerous driving, speed detection, seatbelt and mobile phone offences. However, we are currently working towards increasing performance in detecting disqualified drivers and those who are uninsured. To this end we are working with partners and also looking to develop IT solutions to increase opportunities to raise performance in this area. We are looking to adopt best practice being used currently elsewhere in Scotland.
