## **Housing Estates Based Initiative**

# Report by Executive Director (Housing and Community Care)

#### PURPOSE OF REPORT

This report informs Committee of a new estates-based initiative and seeks approval for the process for agreeing initiatives and allocating funds.

#### 1. BACKGROUND / MAIN ISSUES

- 1.1 In August 2014 Housing and Health Committee were informed (Report 14/355) of the proposal to introduce Estates Based Initiatives (EBIs) to identify and prioritise external environmental improvements by involving tenants, local elected members and staff.
- 1.2 It was recognised EBIs had the potential to deliver wider community benefits, including community capacity building and support local employability projects.
- 1.3 Every tenant was informed about EBI in an article in December 2014's 'On The House' magazine. There will also be a press release issued and promotion through the Council's social media. Tenants will be able to contact their Area Team with their suggestions.

#### 2. PROPOSALS

- 2.1 For 2015/16, £100,000 will be available to support this initiative. It is proposed that a method of allocating this is developed and based on the number of council houses in the locality area.
- 2.2 It is further proposed that projects to be included in the Estates Based Initiatives must meet the following criteria:
  - Be on communal ground/property owned by the Housing Revenue Account
  - Must contribute to community safety
  - Must improve the amenity of the area
  - Should demonstrate it is sustainable

It is worth noting that this initiative is not a replacement for routine maintenance.

- 2.3 It is further proposed that local EBI panels are established in each of the four housing localities. Membership should include, where possible, representatives from the local Registered Tenant Organisations (RTOs), elected members and locality housing staff. If there are no active local RTOs, volunteers will be recruited from the interested persons list and from the expression of interests taken from the 'On The House' article.
- 2.4 It is proposed that the responses and suggestions from tenants are collated and considered by local EBI panels, along with suggestions made at the local estate walkabouts and local meetings.
- 2.5 Each local EBI Panel will have the authority to approve a programme of work in each locality and have a role in monitoring the local EBI Action Plan. Tenants who propose projects which are not successful will receive a response explaining why it wasn't progressed. Details and progress of approved EBI projects will be published in the 'On The House' magazine, along with a paper-based survey to generate ideas for future improvements. It will also be reported and publicised in the local press.
- 2.6 It is proposed that, wherever possible, projects are delivered by the local employability based projects and the Unpaid Work Team, subject to procurement rules.

#### 3. CONCLUSION AND RECOMMENDATION

- 3.1 This report provides details of a new Estates Based Initiatives to support environmental improvements in local communities, involving local tenants, elected members and housing staff.
- 3.2 Housing and Health Committee is asked to approve the proposals outlined in Section 2 of the report.
