# 1. WELCOME AND APOLOGIES

The Provost welcomed everyone to the first virtual meeting of Perth and Kinross Council and apologies were noted as above.

The Provost confirmed that the meeting was taking place virtually due to the physical distancing regulations in place as part of the current COVID-19 pandemic.

# 2. TRIBUTE TO THE LATE COUNCILLOR BOB BAND

The Provost referred to the sad news of the passing of the late Councillor Bob Band who had died in March 2020 following a long battle with Cancer. The Provost paid tribute to his hard work and dedication since being elected as a member in 2007, and also in his various roles as a Convener, Vice-Convener and Depute Provost. The Provost confirmed that there would be a memorial service at the appropriate point in the future for all members to pay their tributes.

# 4. OPERATIONAL UPDATE ON COUNCIL RESPONSE TO CORONAVIRUS (COVID-19)

There was a verbal update by the Chief Executive, Gold Commander and senior officers providing an operational update on the Council's response to the Coronavirus (COVID-19) pandemic, including a summary of various workstreams and initiatives set up as part of the response. The Chief Executive praised all Council staff for their hard work and commitment since the outbreak of the virus, and referred to the Gold, Silver and Bronze command structure that had been set up, as well as the weekly elected member sounding board meetings that had been set up as part of emergency powers.

There followed a number of questions and comments from members, along with responses from officers.

- A review of emergency powers to take place, if possible, at the end of July 2020.
