Minute of Meeting of the Licensing Committee held virtually via Microsoft Teams on Thursday 19 November 2020 at 10.00am.

1. WELCOME AND APOLOGIES

The Convener welcomed all present to the meeting. Apologies for absence were noted as above.

2. DECLARATIONS OF INTEREST

3. MINUTES

The Minute of Meeting of the Licensing Committee of 8 October 2020 was submitted and approved as a correct record.

4. LICENSING OF SEXUAL ENTERTAINMENT VENUES – CIVIC GOVERNMENT (SCOTLAND) ACT 1982

There was submitted a report by the Head of Legal and Governance Services (20/221) providing the Licensing Committee with the results of the public consultation, and to try make proposals for further action.

Resolved:

- (i) The responses to the consultation exercise, be noted.
- (ii) It be agreed to license SEVs in Perth and Kinross.
- (iii) It be agreed that from and after 19 November 2021, Schedule 2 of the Civic Government (Scotland) Act 1982 (as modified by Section 76 of the Air Weapons and Licensing (Scotland) Act 2015) is to have an effect in the Perth and Kinross Council area in relation to Sexual Entertainment Venues.
- (iv) The Head of Legal and Governance Services be requested to prepare a SEV policy statement in terms of Section 45C of the 1982 Act, consult on this Policy Statement and bring a subsequent report to Committee for approval prior to November 2021.

5. VARIATION OF A LATE HOURS CATERING LICENCE NO. LH119

# Amendment to Taxi and Private Hire Drivers' Knowledge Test Licensing Condition

Report by Head of Legal & Governance Services (Report No. 21/19)

### **PURPOSE OF REPORT**

The purpose of this report is to seek approval for a further amendment of the licensing condition which requires applicants for Private Hire Car Drivers' and Taxi Car Drivers' licences to pass a knowledge test. This is required due to the ongoing barriers to carrying out the knowledge test during the coronavirus pandemic.

#### 1. BACKGROUND / MAIN ISSUES

- 1.1 The Council, as Licensing Authority, regulates civic licensing under the Civic Government (Scotland) Act 1982.
- 1.2 On 26 October 2017 the Committee approved the introduction of a knowledge test by amending the Standard Conditions for Taxi and Private Hire Drivers to include a requirement that the knowledge test be passed prior to grant of licence (report 17/349 refers).
- 1.3 Since March 2020, it has not been possible to deliver the knowledge test which requires personal attendance at the Council office. This is because of coronavirus and the public health restrictions in place. On 11 June 2020 (report 20/101 refers) Committee approved an amendment to the knowledge test condition by allowing a licence to be issued without completion of the knowledge test. Instead, completion of the test is required within 9 months of grant of the licence. This enabled new licences to be issued during the coronavirus pandemic.
- 1.4 Due to ongoing coronavirus restrictions, all knowledge tests continue to be suspended for safety reasons. Alternative options for carrying out the test have been explored; however none were suitable, either because of the demand it would place on resources, or because it was not possible to ensure the integrity of the test being done online.

#### 2. PROPOSALS

- 2.1 Coronavirus restrictions remain in force and are likely to be in force for some time to come. Rather than seek a further extension to the time limit within which a knowledge test must be passed, a more flexible solution is required, which will allow for the test to be resumed when safe to do so. It is unlikely to be safe until coronavirus restrictions are significantly relaxed. It is unclear when this may be the case, and therefore this more flexible solution is needed.
- 2.2 It is proposed that the Head of Legal and Governance Services be authorised to determine when it is appropriate to resume the test for both new applicants and existing licensees who have been granted their licence during the restrictions but have not yet sat the test. The condition relating to the knowledge test would require to be amended temporarily to permit this.
- 2.3 It is proposed that condition one of the Standard Conditions for Taxi and Private Hire Drivers Licence dated November 2017 be amended with the text in italics substituted so that it reads:
  - "The holder of a taxi or private hire driver's licence will be required to undertake a test on matters relating to the operation of a taxi or private hire vehicle as the Council considers desirable, at a time required by the Council either before or after grant of the licence".
- 2.4 It is also proposed that the Head of Legal and Governance Services reports back to Committee once plans are in place for the test to resume.

## 3 CONCLUSION AND RECOMMENDATION(S)

- 3.1 It is recommended that the committee agrees that:
  - (i) Condition one of the Standard Conditions for Taxi and Private Hire Drivers Licence dated November 2017 be amended so that it reads:
    - "The holder of a taxi or private hire driver's licence will be required to undertake a test on matters relating to the operation of a taxi or private hire vehicle as the Council considers desirable, at a time required by the Council either before or after grant of the licence"; and
  - (ii) the Head of Legal and Governance Services be asked to report back to Committee once plans are in place for the test to resume.
