# CONTRACTS AWARDED BY THE CHIEF EXECUTIVE'S SERVICE 1 JANUARY 2012 TO 30 JUNE 2012

## Report by the Head of Finance

### **ABSTRACT**

In accordance with the Council's Contract Rules, this report provides information to the Committee on contracts awarded by the Chief Executive's Service from 1 January 2012 to 30 June 2012 under delegated authority.

#### 1. RECOMMENDATION

#### 2. BACKGROUND

The Council approved the Contract Rules on 23 March 2005, report 05/199 refers. Those rules set out the requirement for each Executive Director to submit a report detailing all tenders over £5,000 in value accepted by the Service which have not previously been reported.

The delegated authority to contract for goods and services is contained within the Council's Scheme of Administration which permits the Chief Executive or any Executive Director to enter into contracts on behalf of the Council in accordance with the Council's Contract Rules.
