**732. POLICE SCOTLAND AND SCOTTISH FIRE AND RESCUE SERVICE: LOCAL SCRUTINY AND ENGAGEMENT**

**(i) Scottish Fire and Rescue Service Local Service Delivery - Quarterly Performance Report – 1 July to 30 September 2014**

There was submitted a report by Area Manager Stapley, Local Senior Officer, Scottish Fire and Rescue Service, (14/473) advising of the performance of the Scottish Fire and Rescue Service in local service delivery within the Local Fire and Rescue Service Plan for Perth and Kinross for the period 1 July to 30 September 2014 in support of Member scrutiny of local service delivery.

The Convener commended the actions of Volunteer and Retained Firefighters in tackling a large fire at the Spittal of Glenshee Hotel on 18 August 2014. On behalf of the Committee he thanked the crews and specialist services who had attended the incident and prevented this serious fire from spreading to other parts of the hotel complex.

In response to questions from the Committee on Report 14/473, Area Manager Stapley provided further information on: (1) the roll-out of risk critical core skills training for volunteer firefighters; (2) the community engagement and community education work relating to accidental fires and fires in communal closes; and (3) the Home Safety Visit 6 month trial partnership initiative.

**(iii) Police Scotland - Perth and Kinross Local Policing Area  
Performance Results – 1 July to 30 September 2014**

There was submitted a report by Chief Superintendent Smith, Police Scotland 'D' Division (Tayside) (14/474) providing an update on the performance results for the Perth and Kinross policing area for the period 1 July to 30 September 2014 in relation to Crime Groupings 1 to 4. The report included information on (1) local officers involvement in Project Jackal, a national initiative aimed at dismantling and disrupting criminal business structures and activity by capturing financial intelligence from serious and organised crime groups; (2) public protection and safety; (3) road safety and road traffic statistics; (4) antisocial behaviour; (5) major events and planning; (6) theft, housebreaking and scams; and (7) community engagement work.

In response to questions from the Committee on Report 14/474, Chief Superintendent Smith provided further information on: (1) the reduction in detection rates for drug supply, production and cultivation and road traffic offences and (2) the large decrease in the detection of the consumption of alcohol in designated places. The Chief Superintendent also responded to a number of concerns raised by Members' in relation to the role of community liaison officers.

**Resolved:**

The local policing area performance results for Perth and Kinross for the period 1 July to 30 September 2014, as detailed in the Appendix to Report 14/474, be noted.

**733. VALEDICTORY**

The Convener referred to the forthcoming retirement of Area Manager David Stapley, after over 30 years' service, formerly with Tayside Fire and Rescue and latterly with the Scottish Fire and Rescue Service. He recounted Mr Stapley's lengthy career, thanking him for his contribution to the work of the Committee and for his dedicated service to the Perth and Kinross community. On behalf of the Committee the Convener wished him well in his retirement.
