

# LICENSING COMMITTEE

Minute of Meeting of the Licensing Committee held virtually via Microsoft Teams on Thursday 7 April 2022 at 10.00am.

## 1. WELCOME AND APOLOGIES

The Convener welcomed all present to the meeting. Apologies for absence were noted as above.

## 2. DECLARATIONS OF INTEREST

There were no declarations of interest in terms of the Councillors' Code of Conduct.

## 3. MINUTES

The Minute of Meeting of the Licensing Committee of 24 February 2022 was submitted and approved as a correct record.

## 4. CIVIC GOVERNMENT (SCOTLAND) ACT 1982 – TAXI FARE REVIEW

There was submitted a Report (22/70) by the Head of Legal and Governance Services. The Council is required to review the scales of fares for Taxis in this area at intervals of not more than 18 months. The Report (22/70) outlines the findings of the most recent review and proposes that there be an increase in fares.

Mr S Smith, Radio Taxis, addressed the Committee via audio conference and answered members' questions.

### **Resolved:**

The Committee:

- (i) Agrees that the current scale of fares be increased by 15% as soon as relevant legislation and/or regulations permit.
- (ii) Agrees that the scale of fares be advertised in the local press and that interested parties are invited to respond within one month of the advertisement and any responses be considered at the next available Licensing Committee meeting.
- (iii) Agrees that if no representations are received after advertising, the new scale of fees commence from a date specified by the Head of

- Legal and Governance Services in the advertisement, that date to be approximately six weeks after the date of the advertisement.
- (iv) A further review of the Taxi Fares be carried out within the next 18 months.
