#### Taxi and Private Hire Drivers' Knowledge Test

#### Report by Head of Legal & Governance Services (Report No. 19/1)

#### PURPOSE OF REPORT

The purpose of this report is to seek approval for the introduction of a knowledge test for Private Hire Car Drivers' and Taxi Car Drivers'

#### 1. BACKGROUND / MAIN ISSUES

- 1.1 The Council, as Licensing Authority, regulates civic licensing under the Civic Government (Scotland) Act 1982.
- 1.2 Within the Civic Government (Scotland) Act 1982 provision is made for a Licensing Authority to require applicants for a Taxi/Private Hire Driver Licence to take a test of knowledge of the geographical area to which the licence relates. Such tests relate to the layout of roads within the area and other matters relating to the operation of a taxi/private hire as the authority may consider desirable.
- 1.3 A report was submitted and approved by the Licensing Committee on 26 October 2017 (Item 4, Report 17/349). This resulted in the standard conditions for taxi and private hire car drivers being updated. There is a condition relating to a knowledge test within the standard conditions. This states that the knowledge test will be required to be undertaken at renewal and application stages; however, it is anticipated that it will be introduced for new applications only at this time. This will allow the Licensing Manager to monitor staff time and resources required to undertake the knowledge test as the Licensing Team will administer the test.
- 1.4 It is proposed that the taxi/private hire driver's knowledge test would comprise of 60 questions in six parts:
  - Part 1 would consist of questions relating to Public Buildings and Local Landmarks,
  - Part 2 Street Names,
  - Part 3 Routes,
  - Part 4 Knowledge of the Highway Code,
  - Part 5 questions relating to the conditions to the licence,
  - Part 6 Arithmetical and general questions.

- 1.5 The test would take the form of multiple-choice questions/answers for 4 parts and written answers for 2 parts of the test.
- 1.6 The proposed pass rate for the test would be 85% (applicants must answer 51 questions correctly to pass).
- 1.7 It is proposed that the applicant be given three attempts to pass the test. If an applicant does not pass after three attempts, the application would be deemed as being voluntarily withdrawn and no refund will be given. This restriction is required to ensure continued compliance with the time limit within which applications must be determined (6 months).
- 1.8 If the applicant fails to take the test after three appointments have been sent out, the application will also be deemed as voluntarily withdrawn and no refund will be given.
- 1.9 Most authorities that have a knowledge test charge an additional fee to drivers to cover the administrative costs of the test. Generally fees range from £10.00 to £30.00.
- 1.10 Perth and Kinross Council's current fee for a new Taxi Driver's Licence and a Private Hire Car Driver's Licence is £110.00 for a 1 year licence and £165.00 for a 3 year licence. It is proposed that the Committee agree to increase the fees by £30.00 making a 1 year licence £140.00 and a 3 year licence £195.00 to cover the administration costs of the test for new applications.

#### 2. PROPOSALS

- 2.1 It is proposed that the Committee approve the commencement of the Taxi/Private Hire Car Drivers' Knowledge Test for all new applications received from 11 January 2019 onwards.
- 2.2 It is proposed that the Committee approve the increase in fee by £30.00 for new Taxi/Private Hire Drivers' applications received from 11 January 2019.

## 3. CONCLUSION AND RECOMMENDATION(S)

- 3.1 It is recommended that the committee agrees that the Taxi/Private Hire Car Driver knowledge test be introduced from 11 January 2019.
- 3.2 It is recommended that the fee for new applications received from 11 January 2019 for a Taxi/Private Hire Driver is increased by £30.00.

We are residents of Churchill court and in fact live opposite the yard and proposed burger van site. We strongly object to the application for the following reasons:

- This is a quiet community area with older residents and families. A burger van operating late into the night will have a profound noise effect and be highly disruptive
- The car park that is situated right next to the yard that the applicant wants to operate out of is a public car park but a lot of the residents use it and we do not feel that it would remain safe for the vehicles. Accidental scratching and rubbing up against vehicles is the least you can expect not the mention car alarms going off if lent on
- No toilet facilities which will result in customers urinating on the street or cars and while that may seem extreme its a fact if the van is going to be serving late at night
- No public bins for rubbish
- The general safety is also an issue with the close proximity to residental caravans, gas works and the Taxi business yard. Not forgetting that cars constantly come and go so increased pedestrian activity could be hazardous as there is no pavement.

I have recently moved to the area and have discovered that the neighbouring site, currently used as a bus depot, has applied for an application for street trading from the same site. I am not in favour and would like to express an objection on the following grounds

- 1 The area is primarily a residential area comprising both sheltered housing for elderly residents and a sizeable number of families
- 2 The area to be used is not a food area of the town and there are already numerous suitable food outlets a matter of a couple of minutes walk away in the local square and along the main route through Aberfeldy
- 3 There does not seem to be an indication of hours of operation, and the prospect of late night traffic in and out of the area would be disruptive
- 4 There are no public toilets close by and no walkways in the existing car park, which would imply a focus on vehicle traffic
- 5 Location next to the gas distribution depot behind locked gates and chain fence will inevitably result in rubbish accumulation as there are no public bins located in the area Attraction of guils to fast food outlets is already a problem in the centre of Aberfeldy and this proposal would increase the likelihood of extending the reach of an existing pest hygiene problem

Please consider the application for change of use of the garage area very carefully and consider the potential impact on those who live there

Please find my objection to the proposed plan; noted below with the most obvious concerns being the potential Fire hazard, Noise and anti social behaviour

Chapel Street Garage is a privately enclosed yard and compound it houses motor vehicles, occupied residential homes/caravans, a privately rented vehicle repair centre and worskhop A mobile 'Burger Van' is the most recent arrival on site

All these vehicles are served with fuel and gas (stored on site) and presumably the mobile burger van will "cook with gas" when in operation

Immediately to the side of said burger van is another yard which is used by the local taxi business to keep their vehicles

Residential properties are located within close proximity and flank the garage on either side Churchill court comprises of a 4 storeyed building housing 16 maisonette flats and 6 x 2 storeyed private dwellings. On the opposite side Chapel street comprises of 6 x 2 storeyed dwellings (24 flats) formerly kept as sheltered housing. Although now of de-sheltered status there are still lots of OAP's and occupants receiving care packages housed there Completing the sandwich within 20 yards of said yard is a public car park

We hope you take the time to investigate this application as most of the residents have a firm objection to the proposal
