### 175. MINUTE OF PREVIOUS MEETING

The Minute of the Meeting of the Enterprise and Infrastructure Committee of 30 January 2013 (Arts. 50-65) was submitted, approved as a correct record and authorised for signature.

### 176. BLAIRGOWRIE TOWN CENTRE REGENERATION

There was submitted a report by the Depute Director (Environment) (13/123) (1) providing an update on the Blairgowrie Town Centre Regeneration Funding and the projects it is supporting; (2) seeking approval to support the development of a bus stance and associated traffic improvements as part of a combined proposal to regenerate Blairgowrie Town Centre; and (3) recommending that a variation be made to the Blairgowrie Traffic Management Order to accommodate these changes.

### Resolved:

- (i) The proposed programme of works in the Riverside and Wellmeadow area of Blairgowrie be approved.
- (ii) The development of a bus stance and associated traffic improvements in the Wellmeadow, Blairgowrie, be approved.
- (iii) The promotion of a variation to the relevant Traffic Regulation Order to alter the waiting restrictions in the Wellmeadow and Commercial Street areas and to introduce a designated bus lane and a short section of one-way in Wellmeadow, Blairgowrie, be approved.

# 178. PROPOSED NO WAITING AT ANY TIME WAITING RESTRICTIONS – AULD BOND ROAD, PERTH

There was submitted a report by the Depute Director (Environment) (13/125) (1) outlining the problems experienced by the residents of Cooper Drive and users of Auld Bond Road in Perth caused by inconsiderate parking; and (2) recommending a variation to the Perth Traffic Management Order to introduce 'no waiting at any time' restrictions on sections of Auld Bond Road, Perth.

# 179. PROPOSED 40 MPH SPEED LIMITS AT CAMPMUIR (C405), GRANGE (U150), AND OLD SCONE (U87), AND THE EXTENSION OF THE 30MPH SPEED LIMIT ON THE A823 AT GLENEAGLES

There was submitted a report by the Depute Director (Environment) (13/126) detailing a proposal to (1) introduce 40mph speed limits on roads in Campmuir (C405), Grange (U150) and Old Scone (U87), (2) extend the existing 30mph speed limit at Gleneagles A823; and (3) recommending the start of the process to vary the Traffic Regulation Orders for the 30mph and 40mph Speed Limits.
