PERTH AND KINROSS RECONVICTION RATES – 2011/12

Report by Excecutive Director (Housing and Community Care)

PURPOSE OF REPORT

This paper advises Committee on the reconviction rates for Perth and Kinross for 2011-12, the most recent year for which figures are available.

1. BACKGROUND / MAIN ISSUES

- 1.1 Each year the Scottish Government publish reconviction rates in relation to Community Justice Authorities and to the individual authorities within CJA areas. The two key reconviction rates are the '1 year reconviction rate' and '1 year average number of reconvictions per defender' or 'Frequency of reconviction rate'. It is the latter of these two rates which now attracts most attention from Government not least because prolific offenders have a disproportionate impact upon the overall safety of communities.
- 1.2 Last year, we reported to Committee a very slight rise of 0.1% in our overall 'Reconviction rate', but a drop in our 'Frequency of reconviction rate' of some 0.6%. The Scottish Government have now decided, retrospectively, to include several new categories of offence, namely 'threatening or abusive behaviour', 'offences of stalking',' threatening communications' – all previously excluded from Government calculations.

The net effect has been to retrospectively increase our '1 year reconviction rate' by 0.5% from 29.1% in 2009-10 to 29.6% in 2010-11. Similarly, our '1 year Frequency of reconviction rate' has now increased by 0.1% from 0.50% in 2009/10 to 0.51% in 2010/11.

As two of the offences in question only came into being in 2010 and the other two were introduced by statute in 2012, figures before 2010 are not affected. The introduction of these offences, however, has had a negative effect on the 2010 performance figure for this local authority and many others.

1.3 The most recent reconviction rates for Perth and Kinross, for 2011/12 were published in June of this year. They provide further evidence of the steady progress which has been made locally, since 2004, in reducing both our reconviction rate and the average number of reconvictions per offender. As figure 1 beneath indicates, there has been a slight reduction of some 0.2%, in the 1 year reconviction rate for Perth and Kinross, when compared to the figure for 2010-11. The overall Reconviction rate, however, has seen a drop of 2.1%.

- 1.4 Figure 2 also clearly indicates that our 1 year Reconviction rate is now 1.7% below the Scottish average while our Frequency of reconviction rate sits at 0.4% below the Scottish average.
- 1.5 Our performance in relation to both our neighbouring local authorities and the Scottish average remains strong, but there is no room for complacency. As the Scottish Government's consultation on the future of the Community Justice System now moves into its formal redesign stage, so we will wish to build upon the lessons learned locally and within other local authority areas regarding those approaches towards Prevention and 'Breaking the cycle of reoffending' which appear to yield the most significant results.

2. PROPOSALS

- 2.1 In the light of the continuing progress made within Perth and Kinross towards reducing the impact of reoffending in our communities, the following proposals are now offered to Committee:-
 - The Criminal Justice section continue to work closely with its partners in Police Scotland, The Scottish Prison Service, the Voluntary Sector, Health Board, Housing Service, Drug & Alcohol Services and, increasingly, communities in developing approaches which break the cycle of reoffending.

• Staff from this local authority develop relationships with other local authorities where steady progress has been achieved in reducing the frequency of reconviction rates in order to enhance our learning of 'What Works'.

3. CONCLUSION AND RECOMMENDATION(S)

- 3.1 The reducing reoffending figures for Perth and Kinross for 2011-12 provide encouragement for the emphasis placed, in recent years, upon bringing key agencies together in order to provide co-ordinated support and upon taking a broad approach towards the needs of those within our Criminal Justice system. Over the last 2 years, we have seen the introduction of the One Stop Women's Learning Service, and the introduction of Complex Case Integration Groups in five locations across the Council – building upon the success of the 'Right Track' project and the 'Short Term Prisoner Protocol'.
- 3.2 In the years ahead, we will endeavour to strengthen links between agencies and those communities which experience higher levels of crime as we seek to further reduce the numbers of those who become trapped in a cycle of worklessness, substance misuse, poor health and the Criminal Justice system.

In light of the foregoing, the following recommendations are offered to Committee:-

- That Community Justice partners extend the partnership work which has yielded continuous improvement and seek to learn from other areas approaches which may offer further gains
- That the Executive Director (Housing & Community Care) bring forward a further report to Committee in 12 months time on the reconviction rates for 2012-13.



1. 1 year conviction rate


Reconviction rate –the percentage of offenders with index convictions from a court in the cohort who were reconvicted one or more times by a court within a follow up period of one year.

2. Average number of Reconvictions per offender

Average number of reconvictions per offender – in a cohort it is the total number of reconvictions from a court recorded within a follow up period of one year from the date of index convictions, divided by the total number of offenders in the cohort with index convictions from a court.

Note

The calculations of index offences and reconvictions now include new offences, which weren't included in calculations when last year's reconviction data was made available. Therefore, the revised figures from 2010 onwards, when the acts relating to the offences came into effect, are slightly higher than the figures previously reported. The new offences that have been included are "Threating or abusive behaviour" and "Offence of stalking", which are part of the Criminal Justice and Licensing (Scotland) Act 2010; and "Offensive behaviour at football (under the Offensive behaviour at football and threatening communication Scotland Act 2012)", and "Threatening communications (under the Offensive behaviour at football and threatening communication Scotland Act 2012)".
