There was submitted a report by the Executive Director (Housing and Community Care) (15/326) providing an update on the work of the Perth and Kinross One-stop Women's Learning Service (OWLS) and outlining some preliminary indications of success for the project and future developments.

**511. POLICE SCOTLAND AND SCOTTISH FIRE AND RESCUE SERVICE:  
LOCAL SCRUTINY AND ENGAGEMENT**

**(i) Scottish Fire and Rescue Service Local Service Delivery – First  
Quarter Performance Report**

There was submitted a report by Area Manager Colin Grieve, Local Senior Officer, Scottish Fire and Rescue Service (SFRS), (15/328) providing an update on the activity of the Scottish Fire and Rescue Service (SFRS) in local service delivery within the Local Fire and Rescue Service Plan for Perth and Kinross for the period 1 April to 30 June 2015.

On behalf of the Committee Councillor Pover thanked the SFRS for its efforts during the initial emergency response to the extensive flooding incidents in Alyth and Bankfoot on 17 July 2015. Thanks were also conveyed to the SFRS and to Council staff for the support given to those affected in the aftermath of the flooding as communities continued to rebuild and recover from its impact.

Councillor Pover requested further information on: (1) the extent of all the flooding incidents which had occurred in Perth and Kinross on 17 July 2015, (2) how the emergency response command and control had been coordinated and, (3) if this had been influenced in a negative or positive way, as a result of the transition to a single national service.

Local Senior Officer C Grieve reported that the Service had responded to around 20 flooding incidents across Tayside on 17 July 2015, the majority of which had been in Perth and Kinross. 17 fire appliances and a number of specialist resources had been committed to tackling the flooding incidents. Resources from other parts of the country including Fife, Central, Falkirk and Stirling had also been called to provide support. Personnel had also been placed on stand-by from further north. The deployment of resources from across the country with no reduction in the service provided to communities had demonstrated the benefits of a single national fire service.

In responding to a question from Councillor MacLellan on the national review of specialist appliances and fire crews, the Local Senior Officer reported that the Service is working to a national delivery plan. Perth is a transport hub and as a result its resources might be utilised more.

In response to questions from Councillor Wilson and Councillor H Stewart on joint Home Safety Visits (HSV), the Local Senior Officer reported that the HSVs are targeted at people identified as potentially being at increased risk of unintentional injury at home.

Councillor Anderson requested an explanation for the 6% decrease reported in the overall percentage of operational personnel who currently demonstrated competence in all risk critical core skills. In responding the Local Senior Officer reported that an action plan was being prepared to address this and gave an assurance that crew members on fire appliances were competent.

**Resolved:**

The performance of the Scottish Fire and Rescue Service against the priorities contained in the Local Fire and Rescue Plan for Perth and Kinross for the period 1 April to 30 June 2015, as detailed in Appendix 1 to report 15/328, be noted.

**(ii) Police Scotland - Perth and Kinross Local Policing Area  
Performance Results – 1 April to 30 June 2015**

There was submitted a report by Chief Superintendent E Smith, Police Scotland 'D' Division (Tayside) (15/329) providing an update on the performance results for the Perth and Kinross policing area for the period 1 April to 30 June 2015 in relation to Crime Groupings 1 to 4.

In responding to questions from Councillor Pover and Councillor Giacomazzi on road safety, road casualties and drink/drug detections, Chief Inspector Scott reported that some of the increase in drink/drug detections could be attributed to recent changes in drink drive legislation. Superintendent Mentès added that Operation Zenith had contributed to the reduction in casualties on Perth and Kinross roads. The initiative had run throughout the summer to raise the awareness of all road users to motorcycle safety. The introduction of average speed cameras on the A9 had also had a positive effect.

In responding to a question from Councillor A Stewart for an update on T in the Park, Chief Inspector Scott advised that crimes were still under investigation and it was not possible to provide the Committee with accurate figures at this time. Statistical information would be provided in the next quarterly report to Committee. Councillor A Stewart expressed his disappointment that details of the policing of the event were not yet available for public discussion by Committee at the meeting.

Councillor H Stewart and Councillor H Anderson requested further details on the increase in violent crime in Perth city centre and serious assaults in Perth Prison. In responding the Chief Inspector expressed his disappointment at the increase in violent crime and gave an assurance that Police Scotland will continue to adopt a robust approach to tackling offenders and violence of any kind. Additional dedicated patrols had been conducted throughout the year through initiatives such as Centre Safe and the national Campaign Against Violence days. Police Scotland had met with staff from

Perth Prison to discuss the increase in the number of serious assaults, however, there appeared to be no particular pattern to these. A best practice approach and more regular meetings with Prison staff had now been introduced.
