2013/14 BUDGET & FINANCIAL STATEMENT

Head of Finance & Executive Director (Environment)

PURPOSE OF REPORT

This report seeks approval of the budget for Financial Year 2013/14 and details the Income and Expenditure to 4 April 2013 and the projected outturn to 31 March 2014.

1. BACKGROUND / MAIN ISSUES

1.1 The report has been prepared using the Perth and Kinross Council General Ledger for 2012/13 and 2013/14. The proposed budget detailed in Appendix 1 is based on activity undertaken in 2012/13.

2. PROPOSALS

2.1 Budget

It is proposed that there is no change to the 2012/13 budget for the financial year 2013/14.

2.2 Financial Statement 2013/14

On the basis of appendix 1, it is anticipated that a surplus of £300 will be generated in 2013/14 and the Fund's estimated Revenue Account Balance will be £85,303 at 31 March 2014.

2.3 Delegated Authority

To assist in the management of the budget it is proposed that the Executive Director (Environment) is delegated with authority to authorise expenditure on behalf of the Aberfeldy Common Good Fund where a budget has been approved. It is proposed that this delegated authority would not include applications for Financial Assistance payments which will be considered individually by the Common Good Fund Committee.

3. CONCLUSION AND RECOMMENDATIONS

- 3.1 The Committee is requested to:
 - 1. Approve the Aberfeldy Common Good Fund budget for financial year 2013/14.
 - 2. Note the Aberfeldy Common Good Fund Income and Expenditure to 4 April 2013 and the projected outturn to 31 March 2014.

3. Delegate authority to authorise expenditure on behalf of the Aberfeldy Common Good Fund in respect of all approved budget expenditure with the exception of Financial Assistance payments to the Executive Director (Environment).
