#### ARMED FORCES COMMUNITY COVENANT

#### **Report by Head of Democratic Services**

#### ABSTRACT

The purpose of this report is to advise the Council of a proposed Community Covenant with the Armed Forces.

#### 1. **RECOMMENDATION**

- 1.1 It is recommended that -
  - (a) Perth and Kinross Council adopt the Armed Forces Community Covenant as set out in **Appendix 1** to this report; and
  - (b) authorise the Chief Executive to conclude the Covenant on behalf of the Council.

#### 2. BACKGROUND

2.1 The Armed Forces Community Covenant is a voluntary statement of mutual support between a civil community and its local Armed Forces community. It is intended to complement the Armed Forces Covenant, which outlines the moral obligation between the Nation, the Government and the Armed Forces, at local level. The aim of the Community Covenant is to encourage local communities to support the service community in their area and nurture understanding and awareness amongst the public of issues affecting the Armed Forces Community.

#### 3. CURRENT POSITION

- 3.1 Over 80 Community Covenants have been signed, including 18 in Scotland. The local authorities in these areas have established, or are establishing, effective relationships with the military community in their area. Almost every community has members of the Armed Forces Community living within it, be it Serving members, family members or veterans. The Community Covenant encourages local communities to develop a relationship with the service community in their area, this enables support to be tailored according to need. In return there is much the Armed Forces community can do to support the local communities in this area. The Covenant Scheme encourages the Armed Forces community to do their bit to nurture this two way relationship.
- 3.2 Many people have become involved in supporting the Service community, through Service charities or more recently in participating in Armed Forces Day. As members will be aware a main feature of the Council's Queen's Diamond Jubilee Celebrations on 2 June 2012 was the Kilt Run, where the nominated charities were ABF The Soldiers' Charity and PKAVS. The Council has actively supported the annual Armed Forces Day for a number of years.

#### 4. PROPOSALS

- 4.1 Public service providers, businesses and communities can offer support in a number of ways to the Armed Forces and by entering into a partnership this will further enhance that Perth and Kinross is a place where a first class quality of life can be enjoyed by all. It is therefore recommended that the Council enter into discussions aimed at preparing a Covenant fit for Perth and Kinross. The scheme is aimed to encourage all parties within a community to offer support to the local Armed Forces Community and make it easier for service personnel, families and veterans to access the help and support available from the Ministry of Defence (MOD), from statutory providers and from the charitable and voluntary sectors. A draft Community Covenant document is attached at **Appendix 1** to this report.
- 4.2 The Covenant is based on the five themes set out in the Government's Covenant guidelines:-
  - Encourage local communities to support the Armed Forces communities in their area and vice versa;
  - Nurture public understanding and public awareness amongst the public of issues affecting the Armed Forces community;
  - Recognise and remember the sacrifices faced by the Armed Forces community;
  - Encourage activities which help to integrate the Armed Forces community into local life; and
  - Encourage the Armed Forces community to help and support the wider community.

#### 5. COMMUNITY COVENANT GRANT SCHEME

5.1 The MOD has also launched the Community Covenant Grant Scheme where £30 million is to be made available over the next four years to fund relevant community based schemes. Bids may only be submitted from areas which have established a Community Covenant in their area and applications are invited for sums from £100 to £250,000.

#### 6. CONSULTATION

6.1 There has been no consultation in the preparation of this report.

#### 7. **RESOURCE IMPLICATIONS**

7.1 There are no resource implications arising directly from the proposals contained in this report.

#### 10. CONCLUSION



#### SECTION 2: PRINCIPLES OF THE ARMED FORCES COMMUNITY COVENANT

2.1 The Armed Forces Community Covenant is a voluntary statement of mutual support between a civilian community and its local Armed Forces Community. It is intended to complement the Armed Forces Covenant, which outlines the moral obligation between the Nation, the Government and the Armed Forces, at the local level.

2.2 The purpose of this Community Covenant is to encourage support for the Armed Forces Community working and residing in xxxx and to recognise and remember the sacrifices made by members of this Armed Forces Community, particularly those who have given the most. This includes in-Service and ex-Service personnel their families and widow(er)s in ABCD.

2.3 For ABCD County Council and partner organisations, the Community Covenant presents an opportunity to bring their knowledge, experience and expertise to bear on the provision of help and advice to members of the Armed Forces Community. It also presents an opportunity to build upon existing good work on other initiatives such as the Welfare Pathway.

2.4 For the Armed Forces community, the Community Covenant encourages the integration of Service life into civilian life and encourages members of the Armed Forces community to help their local community.

#### SECTION 3: OBJECTIVES AND GENERAL INTENTIONS

#### Aims of the Community Covenant

3.1 The Armed Forces Community Covenant complements the principles of the Armed Forces Covenant which defines the enduring, general principles that should govern the relationship between the Nation, the Government and the Armed Forces community

3.2 It aims to encourage all parties within a community to offer support to the local Armed Forces community and make it easier for Service personnel, families and veterans to access the help and support available from the MOD, from statutory providers and from the Charitable and Voluntary Sector. These organisations already work together in partnership at local level.

3.3 The scheme is intended to be a two-way arrangement and the Armed Forces community are encouraged to do as much as they can to support their community and promote activity which integrates the Service community into civilian life.

### THE ARMED FORCES COVENANT

An Enduring Covenant Between

The People of the United Kingdom Her Majesty's Government

– and –

All those who serve or have served in the Armed Forces of the Crown

And their Families

The first duty of Government is the defence of the realm. Our Armed Forces fulfil that responsibility on behalf of the Government, sacrificing some civilian freedoms, facing danger and, sometimes, suffering serious injury or death as a result of their duty. Families also play a vital role in supporting the operational effectiveness of our Armed Forces. In return, the whole nation has a moral obligation to the members of the Naval Service, the Army and the Royal Air Force, together with their families. They deserve our respect and support, and fair treatment.

Those who serve in the Armed Forces, whether Regular or Reserve, those who have served in the past, and their families, should face no disadvantage compared to other citizens in the provision of public and commercial services. Special consideration is appropriate in some cases, especially for those who have given most such as the injured and the bereaved.

This obligation involves the whole of society: it includes voluntary and charitable bodies, private organisations, and the actions of individuals in supporting the Armed Forces. Recognising those who have performed military duty unites the country and demonstrates the value of their contribution. This has no greater expression than in upholding this Covenant.
