Brief Feedback Report from Community Safety/Environment Outcome Delivery Group

PURPOSE OF REPORT

This report informs Committee of the recent Reports presented to the Community Safety and Environment ODG

1. BACKGROUND / MAIN ISSUES

- 1.1 A Briefing Report was presented to the last meeting of Housing & Health Committee on the domains within the proposed Community Safety Action Plan to be taken forward under the auspices of the Community Safety Outcome Delivery Group.
- 1.2 At a subsequent meeting of the Outcome Delivery Group on 15 August, the following reports were presented taking forward key areas within this Action Plan:-

1.2.1 Drugs & Alcohol Related Crime Report

This report (presented by Mr Eric Knox, Perth and Kinross Alcohol & Drug Partnership) began by noting some national and local figures relating to the cost of illicit drug use and alcohol related crime, before commenting on two important, local initiatives in these areas. The first concerned the Mentoring Project, focussing initially upon women within the Criminal Justice system, but subsequently extending this service to certain men under Criminal Justice Supervision. The service is run by Tayside Council on Alcohol, of which Mr Knox is the Chief Executive, and has made significant contributions both to the OWLS Project for women at risk of offending and towards supporting male persistent offenders under Court Supervision/Bail between the ages of 16-25 years into more positive lifestyles.

- 1.2.2 The report then noted the focus of the local Alcohol Forum, on the issue of over provision in Perth and Kinross. Licensing Boards have a duty to assess over-provision and to include a statement in their Licensing Policy. The aim of the forum is to contribute towards wider work in this area in order to ensure that decisions with regard to the granting of licences take into account both public health and community safety considerations with a direct bearing on the wider public.
- 1.3 A report was then presented on the Scams Hub Project by Willie Young, Acting Head of Service, TES. Ms Janet Reay, Trading Standards Officer currently chairs an Inter-Agency Group focussed on this particular problem, in the wake of the discovery of a national Scams Hub in England containing the names of 180 residents of Perth and Kinross. Following further intelligence, a

further list of 68 names from Perth and Kinross has been received. This group endeavours to identify the individuals concerned, determine the extent to which they remain at risk of scamming and suggest actions which may be taken to address these risks. This is not a short-term task, given the difficulty in tracing certain people and the potential challenges in convincing others of the risk to which they may be subject. Royal Mail have become directly involved in this exercise and Scam Awareness sessions are now being carried out with postal workers. Royal Mail will also instigate an internal referral procedure so that their staff can report any possible victims, with this information being forwarded to Trading Standards.

1.3.1 A report was then presented by Mr Rab Middlemiss, (Group Manager, Scottish Fire & Rescue Service) on actions being taken to develop a multifaceted Home Safety Screening process. Some years ago, an initial scheme was developed involving Community Care staff checking with older people whether their homes contained smoke or fire detectors – as part of the standard Community Care initial assessment. This assessment process has gradually expanded to include a wider number of staff and a broader range of agencies.

In April 2014, a pilot scheme was implemented between Scottish Fire & Rescue Services and the Safer Communities Wardens to extend the training available on home safety assessments. 3 volunteers are now attached to PKAVS, the umbrella organisation which provides support for agencies in their recruitment and use of volunteers.

A joint home safety visit has now been developed which can extend to the following areas:-

- Falls Assessment
- Home Security
- Energy Efficiency
- Electric and Gas Safety
- Fire Safety
- Community Alarms
- Basic Adult Protection
- Care & Repair
- · Basic assessment of need for additional support
- Fitting of mail guards
- Home Security

This truly person-centred approach contributes much towards building safer communities by offering a wider set of security checks to people who, through age, frailty or other circumstances, may be more vulnerable within their community.

Finally, further minor adjustments continue to be made to the Community Safety Action Plan in order to ensure that actions are addressed under the appropriate themes and the potential for inter-agency co-operation is maximised.

2. CONCLUSION AND RECOMMENDATION(S)

2.1 At the last meeting of the Housing & Health Committee a brief report was presented describing the outline of an Inter-Agency Community Safety Action Plan. An Environment Action Plan has also been tabled before the ODG. These Action Plans are now underway and the agencies responsible for their delivery are reporting on progress to the Outcome Delivery Group.

It is recommended that Committee note the content of this report.
