## APPLICATIONS FOR FINANCIAL ASSISTANCE

#### Report by Head of Cultural and Community Services (Report No. 23/148)

#### 1. PURPOSE

1.1 The report asks the Auchterarder Common Good Fund Committee to consider one capital grant application for financial assistance.

#### 2. **RECOMMENDATION**

- 2.1 It is recommended that Committee:
  - consider the grant applications and agree any financial assistance to be awarded.

#### 4. BACKGROUND / MAIN ISSUES

- 4.1 Perth and Kinross Council owns land and property which forms part of the Common Good of the former burghs in Perth and Kinross and has a statutory duty in terms of Section 15 of the Local Government etc. (Scotland) Act 1994 to administer this land and property "having regard to the interests of the inhabitants" of those former burghs. This duty also applies to the administration of the associated Common Good Funds.
- 4.2 The Common Good Funds have traditionally demonstrated their support to local residents and organisations by distributing grants. These grant awards allow individuals and local organisations to carry out a wide range of community-based activities.
- 4.3 Applications to Common Good Funds vary across the different former burghs of Perth and Kinross. The report is for the Auchterarder Common Good Fund.
- 4.4 The proposed 2023/24 Budget for the Auchterarder Common Good Fund is included in a separate report at this meeting. A summary of the draft

Financial Assistance budget, and the value of funding under consideration, is provided below:

## 5. **PROPOSALS – CAPITAL GRANTS**

## The Rotary Club of Auchterarder & District

- 5.1 An application of £12,000 has been received by The Rotary Club of Auchterarder & District to contribute to the development of a memorial garden in an unused green space adjacent to Collearn Drive. The garden will be a memorial to a young Spitfire pilot, FI Lt. Sandy Gunn, who was born and brought up fifty yards from where the garden is planned. The garden will contain a bench in the shape of a Spitfire wing and information on the story of the pilot. The project will provide a space for people to meet, relax and reflect. The project has widespread approval from various meetings and forums involving the local community, the Community Council and local Councillors. The Community Action Plan Management Group and School History Department are both supportive as well. The project also has a direct link to one of the outcomes of the recently published 'Auchterarder and Aberuthven Community Action Plan 2022-2027', specifically 'Theme 3: Heritage, Arts and Culture'.
- 5.2 It is estimated that the project will benefit several hundred people within the Common Good Area as well as a small number from elsewhere and outside of Perth and Kinross through the improvement of greenspace provision in the town. The project is estimated to begin in the summer of 2023, with construction during autumn 2023 and a celebration event in April 2024.
- 5.3 The total costs of the project are estimated to be £21,323. Friends of St Margaret's have agreed to provide £2,000 and there is a pending application of £6,000 to Auchterarder Community Facilities Fund. The Rotary Club will also endeavour to raise £4,000 from individuals and fund-raising activities. A full breakdown is included overleaf. The group estimates that voluntary services in project management and garden maintenance will cover a total of £2,500 per annum as a further contribution to the project.
- 5.4 Committee should note that once approved and pending applications are considered, the funding gap totals £9,322.80. The Rotary Club have been asked to set out what they would use the additional £2,677.20 for, but no further explanation was provided by the time of the report being written. It is likely that any funding over and above the £9,322.80 would subsequently reduce the fundraising that the Rotary Club will need to undertake (currently

aiming for £4,000). Committee should further note that any Common Good funding awarded would be paid out in arrears, following evidence of spend. Any grant awarded would be directly related to the overall project costs and the results of any other fundraising activities.

## 1. PURPOSE OF REPORT

This report provides the projected outturn for Financial Year 2022/23, and the budget options and projected outturn for Financial Year 2023/24.

#### 2. **RECOMMENDATIONS**

The Committee is requested to:

- (i) Note the projected Income and Expenditure to the 31 March 2023 for the Auchterarder Common Good Fund for the 2022/23 Financial Year, as set out in Appendix 1 to the report.
- (ii) Approve the Budget for the Auchterarder Common Good Fund for the 2023/24 Financial Year considering the options set out in section 4 and in Appendix 2 to the report.

#### 3. BACKGROUND / MAIN ISSUES

3.1 This report provides an update on the projected outturn for Financial Year 2022/23, and the budget options for Financial Year 2023/24.

#### 4. PROPOSALS

#### Financial Statement 2022/23

4.1 As detailed in Appendix 1, there is a projected surplus of £12,124 for the Fund for Financial Year 2022/23, and the estimated Fund balance at 31 March 2023 is £305,668.

#### Budget Options 2023/24

4.2 Auchterarder is due a full replacement of its Christmas Lights and depending on the decision taken by the Committee, this can be a phased replacement over two years or a full replacement in the current year. Additional expenditure on repairs and maintenance is also required to provide an extra animal water trough for the Common Good land that will be divided by the new path to the cemetery extension. Appendix 2 provides two possible budget options for the 2023/24 budget. Both options result in a deficit for 2023/24, however phasing the Christmas Lights over two years would reduce the deficit in the first year. There is one application for Financial Assistance which will be considered at this meeting, and the estimated Fund balance may require to be updated following the decisions taken by the Committee.
