The bar for the premises or parts of premises utilised for a function shall be closed such that no alcohol is sold 30 minutes prior to the commencement of the function.

A minimum of 2 stewards will be in place on Friday and Saturday commencing at 9 pm until 30 minutes after terminal hour or otherwise as required.

Alcohol is also served to residents of the hotel on a 24 hour basis.

THEATRE may comprise plays, comedians, magicians, poetry and literature readings and other arts functions.

FILM may be shown for training and other purposes and may be watched by residents in their rooms.

INDOOR SPORT will comprise use of function/bar/restaurant for eg yoga, keep fit, dance etc - there are no facilities for outdoor sport.

RESTAURANT hours all as per board policy -

alcohol will be served only with a meal during restaurant hours and after social demand hours when the premises are being used as a restaurant and food is being served and consumed.

Premises Operators may permit takeaway food and drink or either and may deliver food and drink or either product including alcohol all as per the terms of the delivery policy contained within Perth and Kinross policy statement.

Alcohol for takeaway or off sales will be in sealed containers and served from the chip shop, the hotel reception or other service sales points within the premises. For example, a guest could order e.g a bottle of wine for off sales during off sales hours while dining.

Off sales will commence at 1000 a.m. from the reception to permit residents to purchase eg specialist spirits, whiskies, gins, rums etc, wines, beers to take home when they are checking out of the premises otherwise off sales will be permitted from 1100 a.m. in the chip shop - there will be no display area for these off sales which will be kept in cellar or spirit stores - guests will be able to advise management of their requirements and/or chose from an off sales list.

Ice creams, sweets, soft drinks, teas and coffees will be able to be served to residents, guests and non residents from the ice cream hatch shown on the layout plan'

- an adult at all times they are in function room/bar/restaurant public parts of the premises
- 2. Resident young persons may be unaccompanied in function room/bar/restaurant public parts of the premises until 2000 hours for the purposes of having a meal or snack or soft drink and must be accompanied by an adult in function room/bar/restaurant public parts of the premises thereafter
- 3. Non resident children and young persons must be accompanied in function room/bar/restaurant public parts of the premises until 2200 hours for the purposes of having a meal or snack or soft drink or until the end of a meal or private function.
- 4. Neither children nor young persons need be accompanied by an adult in the bedroom areas
- 5. Unaccompanied children aged 13 15 and unaccompanied young persons may access the Orangery Chip shop for the purpose of purchasing a takeaway or having a meal, snack, ice cream or soft drink until 2200 and must be accompanied by an adult thereafter'
- 6(c) Delete existing and insert instead, 'Birth 17'
