# PROPOSED LIMITED WAITING - DUNDEE ROAD, MEIGLE

## **Report by the Depute Director (Environment)**

This report summarises an objection received to introduce a 30 minute limited waiting restriction in a new lay-by in Dundee Road, Meigle, and recommends that the objection be set aside and the Order is made as advertised.

#### 1. **RECOMMENDATION**

- 1.1 The Committee is asked to agree:
  - to set aside the objection received to the proposal to introduce a 30 minute limited waiting restriction in a new lay-by in Dundee Road, Meigle, and to proceed to make the Traffic Regulation Order as advertised.

#### 2. BACKGROUND

- 2.1 At its meeting on 21 March 2012 (Report Reference 12/132) this Committee agreed to promote a Traffic Regulation Order (TRO) to introduce a 30 minute limited waiting restriction in a new lay-by in Ardler Road, Meigle. Following this meeting it was pointed out by one of the local Elected Members that the correct road name is Dundee Road in terms of where the lay-by is located. As such this report refers to Dundee Road and the relevant Traffic Regulation Order will be promoted as such.
- 2.2 A resident who is a local shop owner has objected to the proposed 30 minute limit and has indicated a desire to replace this with a 90 minute limited waiting time. He considers that 30 minutes is only advantageous to one local business. It is highlighted that a 30 minute restriction is in line with restriction in other towns, and is sufficient to allow for a continued turnover of vehicles.

#### 3. PROPOSALS

3.1 The Committee is asked to set aside the objection received and to proceed to make the TRO effect to introduce a 30 minute limited waiting restriction in Dundee Road in Meigle as advertised.

#### 4. CONSULTATION

4.1 The Head of Legal Services, the Head of Democratic Service, the Head of Finance and the Chief Constable have been consulted in the preparation of this report. The local Elected Members have also been consulted and support the proposal.

#### 9. CONCLUSION

9.1 This report summarises the objection received during the advertising of the proposal to introduce a 30 minute limited waiting restriction in Dundee Road, previously referred to in error as Ardler Road, Meigle, and recommends that the objection be set aside and the TRO be made as advertised.


