Minute of Meeting of the Community Safety Committee held in the Council Chambers, Fourth Floor, Council Building, 2 High Street, Perth on Wednesday 28 August 2013 at 9:30 am.

### 485. DECLARATIONS OF INTEREST

There were no Declarations of Interest made in terms of the Councillors' Code of Conduct.

### 486. MINUTE OF PREVIOUS MEETING

The minute of meeting of the Community Safety Committee of 5 June 2013 (Arts. 333-339) was submitted, approved as a correct record and authorised for signature.

### 487. AUDIT SCOTLAND AND IMPROVEMENT SERVICE REPORTS ON FUTURE DELIVERY OF TRADING STANDARDS SERVICES

There was submitted a report by the Depute Director (Environment) (13/421) detailing the findings and impact on the future delivery of trading standards in Perth and Kinross of two reports on Trading Standards services in Scotland: (1) "Protecting Consumers", a report by Audit Scotland, and (2) the National Trading Standards Team: Critical Friend Report by the Improvement Service.

#### **Resolved:**

- (i) The outcomes of the reports by Audit Scotland "Protecting Consumers" and the Improvement Service Critical Friend in relation to the overall review of Trading Standards services in Scotland be noted.

- (ii) A commitment be given to work with CoSLA, other Local Authorities, Trading Standards Scotland and the Tasking Group Board to improve consumer protection measures currently provided locally and nationally.
- (iii) The request for £7,000 of revenue funding as part of shared developments of programme projects and communications be noted and once further information is available from the Improvement Service the decision on whether to commit that funding be remitted to the Executive Director (Environment).

#### **488. ANIMAL HEALTH AND WELFARE FRAMEWORK**

There was submitted a report by the Depute Director (Environment) (13/422) providing an update on the Animal Health and Welfare Framework in which Perth and Kinross Council's Animal Health and Welfare Section are participating and seeking approval of the Animal Health and Welfare Service Plan.

- (i) The work of the animal health and welfare service and its status against the Animal Health and Welfare Framework standard, as detailed in Report 13/422, be noted.
- (ii) The Service Delivery Plan 2013/14, as detailed at Appendix 2 of Report 13/422, be approved.

#### **489. RAISING CONSUMER AWARENESS OF SCAMS**

There was submitted a report by the Depute Director (Environment) (13/423) (1) advising of work which had been carried out by the Council's Trading Standards team in relation to Scam Awareness, and (2) detailing priorities for future work.

#### **490. REGULATORY SERVICES IN THE ENVIRONMENT SERVICE**

There was submitted a report by the Depute Director (Environment) (13/424) (1) advising of community safety work which had been undertaken by Environment Services' Regulatory Services, and (2) detailing future priorities for the team.

#### **491. SUPPORT SERVICES FOR WOMEN AT RISK OF OFFENDING IN PERTH CITY**

There was submitted a report by the Executive Director (Housing and Community Care) (13/425) advising of the work undertaken to date to implement the

Offending Women's Learning Service (OWLS) and mentoring service for female offenders in the criminal justice system in Perth and Kinross.

- (ii) The Executive Director (Housing and Community Care) be instructed to submit a progress report to the Community Safety Committee in six months time.
