### 265. WELCOME AND APOLOGIES

Councillor Coburn welcomed all present to the meeting and apologies were noted as above.

#### 266. DECLARATIONS OF INTEREST

There were no Declarations of Interest in terms of the Councillors' Code of Conduct.

#### 267. MINUTE OF PREVIOUS MEETING

The Minute of Meeting of the Perth Common Good Fund Committee of 26 February 2014 (Arts. 105-116) was submitted, approved as a correct record and authorised for signature, subject to the following amendment:

#### 268. MATTERS ARISING

# (i) St John's Kirk of Perth (Carillon) (Art 108(ii) refers)

The Convener advised members that a meeting between Council officers and members of the Perth Common Good Fund Committee was due to take place during week commencing Monday 12 May 2014, on this subject.

#### (ii) South Inch Pavilion Franchise Agreement (Art 114 refers)

Following a query from Councillor Wilson, members were advised that it was hoped to advertise very soon for a franchise for the South Inch Pavilion, with a view to a contract being let prior to the summer season.

#### 269. PERTH AND KINROSS DISABILITY SPORT

Members of the Committee were advised that, at its meeting on 2 October 2013, Perth Common Good Fund Committee awarded a grant of £2,400 towards the purchase of two Race Running Cycles, to be used by Perth school children with additional support needs.

The organisation purchased one bike and the Council awarded 50% of the cost of one bike, i.e. £1,200, as per the criteria. However, as there was a possibility of a donation of a bike, and there are very limited funds, it is unlikely that Perth and Kinross Disability Sport will be purchasing a second bike. They have therefore requested that the Perth Common Good Fund pay the remaining £1,200, thereby funding the full purchase price of one Race Running Cycle. Although this is not in line with criteria, the Committee can go beyond the recommended amount, if they so wish.

#### **Resolved:**

Perth and Kinross Disability Sport be awarded a further £1,200 (i.e. the full cost of one Race Running Cycle), to be used by Perth school children with additional support needs.

#### 270. PERTH SHOW RELOCATION TO MAIN SOUTH INCH

There was submitted a report by the Depute Director (Environment) (14/175) seeking approval to relocate the Perth Show onto the main South Inch following an interim arrangement which was successful in 2013.

#### **Resolved:**

- (i) The Perth Show be allowed to relocate onto the main South Inch from, and including, the 2014 season.
- (ii) Final operational decisions on an annual basis be delegated to the Executive Director (Environment).

Perth Highland Games be awarded a grant of £1,600 towards the costs of promotion and prizes for the Pipe Band Competition on 10 August 2014, subject to the award from Perth Common Good Fund Committee being reflected in the programme.

#### (4) Wednesday Tea Dance

Wednesday Tea Dance be awarded a grant of £196 towards the costs of 28 members attending their summer weekend outing to Dumfries from 17-19 August 2014.

#### (5) Perth Academy

Perth Academy be awarded £460 towards the costs of sending 2 pupils on a visit to various sites in Belgium and France relating to the First World War including war graves, museums and monuments from 2-8 September 2014.
