## PROPOSAL TO GRANT FREEDOM OF THE CITY OF PERTH TO ST JOHNSTONE FOOTBALL CLUB

Report by Interim Chief Executive (Report No. 21/104)

### PURPOSE OF REPORT

This report proposes to grant the Freedom of the City of Perth to St Johnstone Football Club (the Club) to officially mark their double success in winning the Scottish League Cup and the Scottish Cup in the season 2020/2021.

### 1. BACKGROUND

- 1.1 St Johnstone Football Club, Perth was first established in 1884 and played its first game on 7 March 1885 at the South Inch.
- 1.2 The Club have occupied several sites in Perth, starting off at the South Inch then moving to St Johnstone Recreation Ground between 1885 to 1924. A further move took them to Muirton Park, Dunkeld Road on the northern edge of the city from 1924 to 1989.
- 1.3 The Club's stay at Muirton Park brought some great success with promotion being achieved on various occasions including three championship seasons. The best spell was, arguably, when the Club reached the Scottish League Cup Final for the first time in its history in 1969, followed by a third place in the Scottish Football League, thereby securing a place in European competition for the first time.
- 1.4 Following a number of financial issues and poor performance, the Board of Directors approached local businessman, Geoff Brown, which resulted in his appointment as Chairman of the Company.
- 1.5 In December 1986, an approach was made to the new Chairman to buy Muirton Park to turn it, and the adjoining Ice Rink, into a retail superstore, with the Club relocating to a brand new stadium on the western edge of the city. The first match played at McDiarmid Park was on 19 August 1989 – St Johnstone beat Clydebank 2-1.
- 1.6 McDiarmid Park was the UK's first all-seated purpose-built football stadium, which provided first class facilities for spectators with an all seated stadium for over 10,000, parking for 1,000 cars and 100 coaches; a synthetic playing surface adjacent to the stadium and conference facilities within the main stand.
- 1.7 In 2014, the Club won their first Scottish Cup – the first national trophy in its 130 year history.

- 1.8 On 28 February 2021, St Johnstone won the Scottish League Cup, beating Livingston 1-0 in the final. Less than three months later, on 22 May 2021, St Johnstone won the Scottish Cup, defeating Hibernian 1-0. This result is significant, as only three sides in the history of Scottish football have ever won a double - Aberdeen FC, Celtic FC and Rangers FC. The success of season 2020/21 means St Johnstone join this small, exclusive club.
- 1.9 Perth has many things to be proud of, and its football team has always been one of them. The Club's success this season sees them returning to European football this summer as they will enter the third qualifying round of the Europa League. This will in turn, highlight the City of Perth to a wider audience with the potential for increased tourists and visitors to the area and associated economic benefits as a result.
- 1.10 Aside from the football, St Johnstone Football Club is at the heart of the City of Perth and the local community through the Club's charitable Community Trust - Saints in the Community – which provides a link between the Club and the wider community.

The Council has a Service Level Agreement in place for four specific community projects - Football Memories; Show Racism the Red Card; SAINTS (Inclusion Through Sport) and Street Sports - all of which were affected by pandemic restrictions. However, the Trust has responded positively during the pandemic by continuing to maintain connections and vital support to community members. In addition, a number of additional community support initiatives were introduced due to coronavirus.

- 1.11 St Johnstone have completed their greatest season and secured a place in the history books. It was a significant achievement to win the Scottish League Cup, and even more remarkable to win the Scottish Cup months later in the same season. To achieve a historic cup double, in a year that has been particularly challenging in terms of the ongoing covid pandemic, is an incredible success.
- 1.12 St Johnstone Football Club have given their fans, and the people of Perth and Kinross, something great to celebrate, during what has been the most challenging times many of us have ever faced. This season, as a result of the cup double, St Johnstone Football Club has added to the positive reputation of Perth, with the exciting prospect of European football in season 2021/22.

## **2 PROPOSALS**

- 2.1 Section 206 of the Local Government Scotland Act 1973, as amended provides as follows:

206 (1) states:

*A local authority may by resolution passed by not less than two thirds of the members voting therein at a meeting of the authority, the notice of which specifies the proposed admission as an item of business admit to be Honorary Freemen of their area persons of distinction and any persons who have rendered eminent service to their area*

*(2) An officer designated for the purpose by the local authority shall keep a roll containing the names of persons admitted to be Freemen under this section.*

- 2.2 It is proposed that the Council exercises its power under Section 206 of the Local Government (S) Act 1973 to grant St Johnstone Football Club the Freedom of the City of Perth to celebrate their double success in attaining the Scottish League Cup and the Scottish Cup in season 2020/2021.
- 2.3 It is envisaged that the Freedom of the City of Perth ceremony would take place at a time and place to be mutually agreed between the Council and St Johnstone Football Club, when Coronavirus restrictions have been relaxed.
- 2.4 Members of The Society of High Constables of the City of Perth will accompany the Provost and play a ceremonial role in this event.
- 2.5 Given the Club's success and their ongoing contribution and unwavering support to the local Perth community, it is considered appropriate to acknowledge their greatest season in an official way.

### **3. HISTORY OF FREEDOM CEREMONIES IN PERTH**

- 3.1 The last Freedom ceremony took place in August 2019 to mark the retirement of the previous Lord-Lieutenant of Perth and Kinross, Brigadier Sir Melville Jameson.
- 3.2 The following table details the list of Burgesses and Freemen of the City of Perth since 1933.

- 3.3 The above illustrates that there is a precedent for such honour of the Freedom of the City of Perth being conferred to a collective body, i.e. the Black Watch in 1947, the Royal British Legion Scotland in 2004, and 51st Highland, 7th Battalion, the Royal Regiment of Scotland in 2010.

#### **4. CONCLUSION AND RECOMMENDATIONS**

- 4.1 Given the outstanding achievement of St Johnstone Football Club in season 20/21, which took place during the global Covid pandemic and the particular challenges that has brought, it is considered appropriate to grant the Club the Freedom of the City of Perth in recognition of their success.
- 4.2 It is recommended that the Council agrees:
- (i) to exercise its power under Section 206 of the Local Government (S) Act 1973 to grant St Johnstone Football Club the Freedom of the City of Perth to celebrate their double success in attaining the Scottish League Cup and the Scottish Cup in the season 2020/2021.
  - (ii) that the Freedom of the City of Perth ceremony takes place at a date and venue to be mutually agreed with St Johnstone Football Club when Coronavirus restrictions have been relaxed.



- (iii) that the Interim Chief Executive be requested to report to the Provost Sub-Committee once full details of the Freedom ceremony are known.
