

Environment Committee**5 June 2013****WASTE MANAGEMENT PLAN 2010 TO 2015 – PROGRESS REPORT****Report by the Depute Director (Environment)**

This report provides an update on progress with the Action Plan of the Perth and Kinross Council Waste Management Plan, approved by the Environment Committee in November 2010. The report recommends approval of new Actions 52-60 (shown in Part 2 of Appendix 1) to bring the plan in line with the Waste (Scotland) Regulations 2012.

1. BACKGROUND / MAIN ISSUES

- 1.1 In November 2010, the Environment Committee (Report No 10/597) approved the new Perth and Kinross Waste Management Plan 2010-2025. This plan was developed to work towards delivering Scotland's Zero Waste Plan targets at a local level. The Scottish Government targets for household waste recycling are:
 - 2013 – 50%
 - 2020 – 60%
 - 2025 – 70%
- 1.2 The aim of the Council's Waste Management Plan is to map out a way forward for the Council in terms of:
 - Achieving the national recycling and composting rates at local level.
 - Initiatives to control waste arisings and waste growth.
 - Looking into potential partnership agreements for managing waste.
 - Determining the way forward for the procurement of residual waste treatment.
 - Determining the future financial implications for waste management in Perth and Kinross.
- 1.3 This report provides a full update on progress with the Action Plan of the Perth and Kinross Council Waste Management Plan, shown in part 1 of Appendix 1. Of the 51 actions, 43 have been achieved, with 4 partially achieved.
- 1.4 Key Waste Management Plan Actions which have been achieved include:
 - An increase in the amount of waste segregated at source through separate kerbside collections of dry mixed recyclates and mixed food

and garden waste. This has led to an overall household recycling rate of 52.3% in 2011/12, placing the Council in the top 5 performing Councils in Scotland, (see graph at Appendix 2). Provisional unaudited figures for 2012/13 indicate the recycling rate has risen to 56.6%.

- The redevelopment of recycling centres and points and the construction of the new Inveralmond Recycling Centre. The recycling rate at recycling centres for 2011/12 was 67%. (See graph at Appendix 3.)
- The procurement of a contract for residual waste disposal commencing 2010/11, to 2015, with options up to 2017. Based on the previous contract charges, this new contract delivers a saving of £440,000 per annum.
- Investigation of options for joint procurement are being explored with other local authorities, for long term residual waste treatment. Initial work carried out for the four East of Scotland councils (Perth and Kinross, Fife, Dundee and Angus) during 2011 (Phase I) explored the costs, performance and location for a range of 7 technical options, plus potential joint working scenarios between the four authorities. The current Phase II study examines in more detail a limited number of the specific proposed technology and partnering options discussed during Phase I, focussing primarily on the options for Fife and Perth & Kinross Councils. In terms of developing long term residual waste treatment and disposal services, the composition of collected waste (Appendix 5) and waste growth (Appendix 4) have to be considered carefully.
- Implementation of waste awareness campaigns and initiatives which aim to encourage waste prevention and increase participation in recycling and composting schemes. This has involved, on an annual basis, producing 60 media releases, carrying out 70 school and community presentations, welcoming 1,000 visitors to the WEBwalk and receiving 80,000 hits on the Waste Services WebPages.
- Implementation of Zero Waste Scotland 'Construction Commitment: Halving Waste to Landfill'. By signing this, the Council is highlighting its intention to halving the amount of construction, demolition and excavation waste going to landfill, thereby minimising expensive landfill charges.
- The implementation of community sector based waste projects to promote sustainable resource management. The Community Waste Fund has supported 25 innovative projects such as The Bike Station, the Salvation Army Furniture Reuse Project and Starter Packs Perth. The projects have diverted 1,166 tonnes of waste from landfill, (equivalent to a cost avoidance of £91,000), employed 9 people, created 55 volunteering placements and 30 training placements.
- The introduction of a new kerbside collection of dry mixed recyclates to the commercial sector, from April 2012. The service is now used by over 500 businesses.
- The Furniture Reuse Project has saved the Council over £250,000 in 2011/12 by putting in place a procedure for reusing surplus furniture, rather than purchasing new items.

- 1.5 In terms of the actions not achieved to date:
- Proposals have been submitted to Zero Waste Scotland to develop supplementary planning guidance as a national project, rather than the original intention in the Council's Plan, to develop our own local guidance.
 - The existing contract for dry mixed recyclates (DMR) cannot currently provide a processing service for plastic sacks. However, this will be incorporated as part of the next procurement exercise for DMR in 2014.
 - The review of enforcement policies on the presentation of waste and recycling bins will start following the implementation of the project to replace bagged waste in Perth City Centre with containers, reducing litter and other environmental problems.
 - The most appropriate procurement route for residual waste treatment will be considered, following the identification of preferred technical and joint working options with neighbouring local authorities.

2. PROPOSALS

- 2.1 Part 2 of Appendix 1 to the report incorporates new actions 52-60, to bring the plan up to date with the Waste (Scotland) Regulations 2012, which came into effect on 9 May 2012.
- 2.2 The key requirements in the new Waste (Scotland) Regulations are as follows:
- A ban on municipal biodegradable waste going to landfill from 1 January 2021
 - A ban on material collected for recycling going to landfill or incineration from 1 January 2014.
 - A new requirement to remove key recyclables from residual waste prior to incineration.
 - A requirement for local authorities and businesses to present recyclable material for collection.
 - A requirement for local authorities and waste companies to separately collect food waste for collection from most households and waste companies.
- 2.3 The Report seeks approval of the new actions 52 - 60 of the Waste Management Action Plan set out at Part 2 of Appendix 1.

3. CONCLUSION AND RECOMMENDATIONS

- 3.1 This Report provides an update on progress with the action plan of the Perth and Kinross Council Waste Management Plan. These elements provide a firm foundation from which the Council, its residents, and businesses, can achieve the targets relating to recycling, composting and diversion of waste from landfill.

- 3.2 The new actions will support the Council to achieve future national targets within an evolving regulatory framework. They will also enable the provision of high quality services within the current challenging financial situation.
- 3.3 The Committee is asked to:
- i) Approve the full update on progress on the Waste Management Action Plan at Part 1 of Appendix 1.
 - ii) Approve the new actions 52 - 60 to the Waste Management Action Plan set out at Part 2 of Appendix 1.
 - iii) Agree that a further report on progress be submitted to the Environment Committee in 12 months.

1. Strategic Implications

Community Plan / Single Outcome Agreement

- 1.1 The proposals relate to the delivery of the Perth and Kinross Community Plan/Single Outcome Agreement by reducing the local and global environmental impact of our consumption and production by managing municipal waste and increasing recycling and composting rates.

Corporate Plan

- 1.2 The Council's Corporate Plan 2013 – 2018 lays out five outcome focussed strategic objectives which provide clear strategic direction, inform decisions at a corporate and service level and shape resources allocation. They are as follows:
- i. Giving every child the best start in life;
 - ii. Developing educated, responsible and informed citizens;
 - iii. Promoting a prosperous, inclusive and sustainable economy;
 - iv. Supporting people to lead independent, healthy and active lives; and
 - v. Creating a safe and sustainable place for future generations.

This report contributes to Objective (v).

2. Resource Implications

Financial

- 2.1 The cost of implementing the actions detailed in the Waste Management Action Plan have been aligned with the current approved Waste Services Revenue and Capital Budget, with the exception of residual waste treatment costs, which can currently only be estimated.

Workforce

- 2.2 The proposals in this report have no workforce implications.

Asset Management (land, property, IT)

- 2.3 The proposals in this report have no Asset Management implications.

3. Assessments

Equality Impact Assessment

- 3.1 Under the Equality Act 2010, the Council is required to eliminate discrimination, advance equality of opportunity, and foster good relations between equality groups. Carrying out Equality Impact Assessments for plans and policies allows the Council to demonstrate that it is meeting these duties.

- 3.2 The function, policy, procedure or strategy presented in the Perth and Kinross Waste Management Plan 2010-2025 report was considered under the Corporate Equalities Impact Assessment process (EqIA) with the following outcome:

- 3.3 Assessed as relevant and the following positive outcomes have been investigated / implemented with updates provided in Appendix 1:
- Investigate feasibility of collecting reusable materials at Recycling Centres for resale and redistribution in the local area in conjunction with local charity and reuse organisations. This potentially could benefit people on low incomes including people with long-term health conditions, homeless families, migrant workers setting up home etc.
 - Investigate the use of clear plastic sacks for the collection of dry mixed recyclates for assisted lift customers and those in city centre locations.

Strategic Environmental Assessment

- 3.4 The Environmental Assessment (Scotland) Act 2005 places a duty on the Council to identify and assess the environmental consequences of its proposals.

- 3.5 The Perth and Kinross Council Waste Management Plan was modified by the SEA process with the following main themes incorporated into the plan:
- Promoting the SEA objectives by utilising the objectives when developing assessment criteria for the residual waste treatment procurement exercise.
 - Assumed mitigation through meeting modern regulatory standards and ensuring operator competency.
 - Provide education and awareness to reassure residents about impacts of any waste management facilities that may be used in the future by PKC. By providing up-to-date, relevant and researched information to residents would allow them to make informed opinions.
- 3.6 A post adoption statement, outlining how the plan incorporated the results of the Environmental Report, the responses received from the Consultation Authorities and other consultation responses, was prepared and submitted to the SEA Gateway once the Plan had been approved by the Council.
- 3.7 The post adoption statement contained information on how we would monitor the environmental effects of the Plan and the mitigation and enhancements proposed. The environmental effects to be monitored included biodiversity, air and material assets. The associated indicators are either monitored through the Waste Management Plan update report or through other reporting mechanisms such as the Local Biodiversity Action Plan etc. Full details can be found at: <http://www.scotland.gov.uk/Topics/Environment/environmental-assessment/sea/SEAG>

Sustainability








Appendix 3: Recycling Centre Recycling Rate
