### 163. MINUTES OF PREVIOUS MEETINGS

### 164. SCOTTISH GOVERNMENT'S CONSULTATION – "REDESIGNING THE COMMUNITY JUSTICE SYSTEM"

There was submitted a report by the Executive Director (Housing and Community Care) (13/128) outlining details of the Scottish Government's consultation on the Community Justice system in Scotland – "Redesigning the Community Justice System" and providing a suggested response to the consultation.

- (ii) The suggested response to the consultation as detailed at Appendix II of Report 13/128 with its emphasis upon local coordinated support and supervision, be approved.

#### **165. FIRE SAFETY REPORT**

There was submitted a report by the Executive Director (Housing and Community Care) (13/129) outlining the proposal to work more closely with the Tayside Fire and Rescue Service in the prevention of fire deaths and management of fire risk for older people, particularly those at risk due to frailty and confusion and other vulnerable people in the community.

##### **Resolved:**

- (i) The proposal to extend the Community Care assessment to include referral to Tayside Fire and Rescue Service for fire safety assessment with the individuals consent, be approved.
- (ii) The proposal to refer for fire safety assessment at times of critical intervention due to deterioration in functioning with or without consent in line with duty of care, be approved.

#### **166. MANAGEMENT STRUCTURES FOR THE SCOTTISH FIRE AND RESCUE SERVICE AND THE POLICE SERVICE OF SCOTLAND IN PERTH AND KINROSS**
