SCRUTINY COMMITTEE AND AUDIT SUB-COMMITTEE FORWARD PLANNER 2012/13

Report by the Depute Director (The Environment Service)

Abstract

This paper presents a forward planner for scrutiny at Perth and Kinross Council during 2012/13.

1 RECOMMENDATIONS

- 1.1 It is recommended that the Scrutiny Committee:
 - i) agrees the Scrutiny Committee and Audit Sub-Committee Forward Planner attached at Appendix 1.

2 BACKGROUND

- 2.1 The Scrutiny Committee supports the Council and its standing committees in examining activities and performance across all service areas. The wide range of responsibilities of the Committee include reviewing the performance of Services and the Council, considering the effectiveness of Council policy and its implementation, conducting a programme of scrutiny reviews, reviewing the Council's arrangements for assessing and managing risk, overseeing the Council's complaints procedure and considering reports by the Scottish Public Services Ombudsman.
- 2.2 Since the Scrutiny Committee was established in 2007, work continues to develop further the role of the Committee. This includes ongoing training and guidance to elected members of the Scrutiny Committee to ensure clarity of their role and remit and to enable them to effectively examine policy setting and service performance.
- 2.3 A key development of the Scrutiny Committee has been the introduction of Scrutiny Reviews. To date the Committee has undertaken three scrutiny reviews: Implementation of grounds maintenance policy in 2009 (findings reported to the Scrutiny Committee on 16 September 2009); Integration of policy in respect of the More Choices, More Chances policy area in 2010 (findings reported to the Scrutiny Committee on 23 February 2011); and Learning from complaints and customer feedback in 2011 (findings reported to the Scrutiny Committee on 28 March 2012). The experience gained during the first review enabled the Scrutiny Committee to develop a Guide to Scrutiny at Perth and Kinross Council. The guide is a live document which will continue to be developed further to reflect the Committee's learning experiences.

2.4 The Scrutiny Committee continues to strengthen and improve its approach to the scrutiny of Council policy and performance. The Forward Planner 2012/13 at Appendix 1 aims to provide the Committee with clear information on the reports that it will receive to ensure Perth and Kinross Council maintains a strong governance role in respect of performance and resource management over the forthcoming year. It will also enable the Scrutiny Committee to recognise and acknowledge the successes of Council services noted in reports where no further scrutiny has been required.

3 SCRUTINY AND GOVERNANCE FORWARD PLANNER 2012/14

- 3.1 The Council and its Committees routinely consider a number of key scrutiny and governance reports. A review of the Committee agendas for meetings held since 2009 identified a range of reports that are considered by Committees either quarterly, 6-monthly or annually.
- 3.2 The scrutiny and governance reports proposed for consideration routinely by the Scrutiny Committee and Audit Sub-Committee are identified in the Forward Planner at Appendix 1.
- 3.3 The planner is arranged in date order and contains the title of the scrutiny or governance report, the lead Service responsible for the report, the frequency of the report being presented and the Committee(s) which will consider the report. The dates provided are accurate at this time but may be subject to change, i.e. a report may be presented at a later Committee.

4 CONSULTATION

4.1 All Council services have contributed to this report through their representatives on the Performance, Planning and Risk Group. The Head of Legal Services, Head of Finance, Head of Democratic Services and the Executive Officer Team have also been consulted in the preparation of this report.
