BACKGROUND TO THIS REPORT

As from April 2013, the Police and Fire Reform (Scotland) Act 2012 has required Police Scotland to produce and publish a Local Policing Plan (LPP) for each local authority area. The LPP clearly sets out the policing priorities for Perth and Kinross.

Performance in relation to the identified policing priorities is monitored and reviewed internally on a weekly basis. Quarterly reports are produced to allow scrutiny by Perth and Kinross Council Community Safety Committee.

This report covers the period from 1st July 2015 to 30th September 2015 but no figures are provided as the submission date for this report is prior to the release of Police Scotland figures. A supplementary report containing figures will be submitted prior to the Committee meeting being held on 28th October 2015.

Serious and Organised Crime

Serious and Organised Crime remains a key priority and focus in Perth and Kinross.

The disruption of these individuals contributes to the safety and wellbeing of the local community, ensuring illegal substances are recovered and offenders are brought to justice.

The Community Investigation unit (CIU) has many roles and functions however they are instrumental in targeting Serious Organised Crime.

As reported in the last quarter the CIU continue to tackle the anti social impact that New Psychoactive Substances (NPS) have within the communities of Perth and Kinross. The CIU continue to work with key partners and various options to deter and disrupt are being pursued.

Since the beginning of July 2015, the CIU have executed numerous warrants, throughout the local authority with several positive recoveries. Operation Slate continues to run which see local and divisional resources deployed to tackle illegal drug use.

At the start of July 2015, officers stopped a vehicle in the Broxden area which had links to serious and organised criminality. The driver was a 46 year old male from the Liverpool area. A subsequent search of him and the vehicle resulted in a package containing in excess of £75,000 of heroin being recovered. This male was arrested and is now awaiting trial at the High Court. This intervention prevented the introduction of up to 7,500 wraps of heroin being circulated onto the streets of Perth and Kinross and the wider Tayside area.

During the middle of July 2015, the CIU undertook an enquiry relating to the theft of various items of plant machinery throughout rural Perthshire. The property stolen included mini diggers, mini excavators, power tools and trailers and exceeded \pounds 12000 in value. A complex investigation was commenced and following some weeks of enquiry encompassing the execution of search warrants in neighbouring divisions, specialist investigatory techniques, interviewing of witnesses and the seizure of property, a male was positively identified as being responsible for the crime series. A 34 year old male is now awaiting trial in connection to the crime series.

Towards the end of July 2015, the CIU executed a drugs search warrant at an address of a male who had only recently been arrested in connection to the discovery of 250 grams of the class A controlled drug cocaine. This second search of the property in less than 8 weeks led to the discovery of 297 grams of the class B controlled drug Amphetamine, valued at approximately £3000. A 35 year old male was arrested, pled guilty and was sentenced to a 9 month term of imprisonment.

At the beginning of September 2015, Perth CIU launched an intelligence led operation following a cannabis cultivation in the Muthil area of Perthshire. A search warrant was craved and executed and a small cultivation of 9 mature plants were recovered from within the property.

The plants had a potential yield value of £4500 and the crop was just 3 weeks from being cultivated. A 47 year old male was arrested and charged and is now awaiting trial.

Public Protection and Safety

Keeping people safe is a key priority for Police Scotland.

As has been mentioned in previous reports, Police Scotland are committed to deploying the right people, in the right place at the right time.

In order to tackle violence within Perth and Kinross, Operation Quest has been launched, which sees officers from specialised units being deployed into hotspot areas in order to tackle and prevent violence.

In addition to this high visibility patrols by way of "Centre Safe" as well as the deployment of officers on Campaign Against Violence (CAV) duties remain.

The next quarter will see these officers being deployed at key times and in keeping with the festive period.

At the end of September 2015, a meeting was help with key partners, regarding the deployment of a community bus within Perth and Kinross.

This is being supplied and run by the National Christian Outreach Centre with a proposal to have the community bus in South Street between 2200 - 0300 hours on Friday and Saturday nights. This will be staffed by approximately 8 staff from local churches, who will complete outreach work and will work with the street pastors currently deployed in the town centre.

The discussions are at an early stage in relation to the community bus and further updates will be provided in future reports.

The Community safety team have continued delivering workshops for raising awareness of Prevent (WRAP3) training as mentioned in the previous quarter. There have been a further 8 of these sessions completed. In addition to these, the

Community Safety partners and St Martins House employees received a Counter Terrorism Safety Advice (CTSA) briefing in September 2015.



Road Safety

The strategic priority for road safety is keeping people safe on the roads of Perth and Kinross.

As discussed in previous reports, Operation Zenith has been running from the 2nd of April and concluded on the 28th of September 2015. This was a national operation aimed at educating and enforcing road traffic legislation with all motorists but, in particular, concentrating on motorcyclists.

In August there were focused days of action on the A9, A85 and A93. Which resulted in the following: *

Saturday 15/08

37 vehicles (of which 7 were motorcycles) stopped - 1 Conditional Offer Fixed Penalty Notice (COFPN) issued and 9 warned for speeding; 5 warnings for careless driving; 1 report to Driving and Vehicle Licensing Agency (DVLA) re vehicle and licence inaccuracies; and 1 non injury Road Traffic Collision (RTC) involving a motorcycle.

Sunday 16/08

44 vehicles (of which 12 were motorcycles) stopped - 6 COFPN issued and 11 warned for speeding; 4 warnings for careless driving; 1 COFPN and 1 warning for use of mobile telephone; and 1 warning for driving licence irregularities.

<u>Total</u>

81 vehicles (of which 19 were motorcycles) stopped - 7 COFPN issued and 20 warned for speeding; 9 warnings for careless driving; 1 report to DVLA re vehicle and licence inaccuracies; 1 non injury RTC involving a motorcycle; 1 COFPN and 1 warning for use of mobile telephone; and 1 warning for driving licence irregularities.

As a result of the good weather in early September 2015, priority was again given to these routes. During this time a motorcycle rider was reported for travelling at 130mph in a 60mph limit.

The summer weather conditions have played a large part in the lower number of motorcycle journeys that have been on the roads within Perth and Kinross. However it should be recognised that between April and the end of August 2014 there had been 4 motorcyclist fatalities, where as the same period in 2015 there was 1.

In addition, since April 2015, the number of people that have been fatally injured within Perth and Kinross has been reduced from 9 to 3 which is an encouraging downward trend.

This is still a number that we must try to reduce further and as always efforts continue to tackle those road users that offend. The number of drivers that have been dealt with for motoring offences shows an increase of about 50% and this highlights the need for proactive patrolling to influence driver and rider behaviour.

In order to address driver/rider behaviour local officers are deployed to hotspot areas when they are identified in order to educate and enforce legislation appropriately.

In July 2015, following a report of speeding in Stanley, officers conducted a survey of 100 vehicles and found 4 to be over 30 but were below 35 and subsequently warned, the community council were updated with the result. Local Officers believed due to the type of vehicles involved, larger agricultural vehicles, it may be more of the perception of speeding as opposed to the actual speed.

In September 2015 speed checks were carried out in the Pitlochry area, in response to community concerns which was commented upon favourably by the residents.


As we enter the next quarter Police Scotland will be continuing to work in a joint partnership with key partners, regarding speed calming and parking in and around the area of Rattray Primary School.


This is in the early stages but Police Scotland are working with the school, the parent council, Local Councillors, Roads Department and the Local Authority Parking Attendants.

There have been many new and exciting ideas as to how to address this situation which the partners are confident will result in the local residents and parents seeing a vast improvement in relation to road safety at the school.

The Festive period will see the start of the Drink Drive campaign which is anticipated will run from the beginning of December.

Antisocial Behaviour

This report sees the period covering the Summer holidays and key event time within Perth and Kinross.

As stated in the last report Police Scotland have continued to work in partnership with Safer Communities team, utilising the skills and knowledge of the Community Wardens as well as ensuring officers are deployed into areas of concern to deal with or prevent anti-social behaviour escalating.

A meeting recently took place with representatives of Police Scotland, Crieff Community Council and with Housing, Safer Communities and Perth and Kinross Council working together to address issues of anti-social behaviour in the area of Crieff.


Some reports of anti-social behaviour in Bridge of Earn have been received and in order to tackle these extra high visibility patrols from both Police and Community Wardens have been put in place.

In order to prevent the escalation of such reported anti-social behaviour, long term diversionary tactics are being looked at which include the deployment of Street Sports for all, working with Youth Services as well as liaising with The Royal Highland Education Trust who provide inputs to all Primary 7's as part of Safe Taysiders, to establish if they can assist on a more local basis.

Operation Ironworks came to an end in September 2015. Over the summer months this has been a very successful operation which was jointly serviced by multiple officers from neighbouring divisions.

In September 2015 there was another series of vandalisms to vehicles in the Craigie area. The Community Investigation Unit were involved in this enquiry and after a relatively short but thorough investigation, 3 juvenile males were reported to the Youth Justice assessor for 18 vandalisms.

Major Events and Planning

This report covers the period of T in the Park which took place at Strathallen Castle, Auchterarder. This music festival commenced on Thursday 9th July 2015 and finished on Monday 13th July 2015.

A break down of the statistics is being prepared however initial indications are that they are broadly similar to previous years.

As we move forward into the next quarter, local officers will be involved in patrols for Halloween, bonfire night, the Christmas light switch on as well as festive patrols focused on the night time economy.

Winter contingency planning is also underway which sees a partnership approach to policing the A93. Once the ski season is upon us local officers will have a weekly phone in meeting with partners to ensure everyone is working together to promote road safety for those travelling to the ski centre.

Theft, Housebreaking and Scams

In the last quarter it was mentioned that a Rural Crime governance group was being set up within D division. This is now operational and the group has, so far, met twice. There is representation from all areas of the division and work is ongoing to review our engagement with rural communities, how we identify and investigate rural crime as well as looking at preventing these crimes from occurring.

In early August 2015, the CIU took on an investigation into a theft by housebreaking at commercial premises in Kinross where a variety of power tools were stolen. Several witnesses were identified which resulted in the identification of a suspect vehicle and distinct description of the offender. The vehicle was traced being driven in the Kinross area the next day, 2 males aged 52 and 23 were arrested and appeared at Perth Sheriff court.

At the end of August 2015, there was a series of break-ins to a number of business premises in Crieff, Perthshire. Local Police officers supported by trunks road policing department immediately deployed to the area where they traced the vehicle and 3 offenders. The offenders attempted to run off but were successfully caught and arrested. Three men aged 47, 37 and 17 appeared at Perth Sheriff Court and are awaiting trial.

In September 2015, a series of 15 insecure motor vehicles were entered and property was stolen. An extensive investigation was carried out, several witnesses traced and spoken to. A known and prolific thief was identified and arrested for all of these offences and he is now awaiting trial on indictment.

Police Scotland is to undertake a campaign specifically focusing on Doorstep Crime, known as Operation Monarda, within local communities. The initiative will commence on Monday 28th September and terminate on Sunday 4th October 2015. Areas of prevention, intelligence, engagement, enforcement and reassurance will be covered during this period.

Local Community officers will also undertake a joint initiative with Trading Standards, focusing activity at Errol Car Boot sale, to identify counterfeit goods and educate buyers and sellers.


The Adult Protection Committee will be holding three financial harm seminars, targeting financial businesses, to raise awareness of these types of scams. The seminars will allow information to be shared and the identification of any patterns or trends that may assist the Police.

The seminars will run up until the end of March 2016 and will cover Financial Institutions Solicitors and members of the care professions.

Police Scotland is also currently working in conjunction with Trading Standards to set up a no cold calling zone within the Craigie area of Perth. The street has been identified and public consultation will be undertaken to link in with Operation Monarda.

Community Engagement

A community/partnership engagement event took place on 1st September 2015, at Perth Police Station consulting on the Annual Policing Plan for 2016/17 with much discussion on the subjects of Violence/Anti-social behaviour, Road Safety, Serious and Organised Crime, Counter Terrorism and People at Risk.

A presentation on Community Watch was given at a recent Stanley Community Council meeting.

The Community Co-ordinator for South Perthshire, local Community Constable and National Gypsy/Traveller Portfolio holder for Police Scotland will be attending the forthcoming Annual Gypsy Traveller Event in Kinross on 16th October 2015, offering

an opportunity to engage with the local gypsy traveller community residing in this area. Advice will be offered on hate crime and third party reporting.

A launch event is due to take place on 28th October 2015, at Dewars Centre for the roll out of Community Watch to Perth City. Invitations will be sent out shortly to members of the community and partners including Community Councils, Councillors and media.

Drop-in opportunities for Councillors, Community Councils and members of the public have been arranged as follows:-

Strathearn - 9th October 2015 - Crieff Police Station Almond and Earn - 5th November 2015 – Bridge of Earn Police Station Strathallan - 6th November 2015 - Auchterarder Police Station Kinross-shire - 4th December 2015 - Kinross Police Station

The local Community Co-ordinator and Community Sergeant will be in attendance at these events and the following councillors have been invited to attend;

Councillor Cowan, Younger, Brock for Strathearn ward.

Councillors Anderson, Livingstone and Jack for Almond and Earn ward.

Councillors Lyle, Gaunt and Gray for Strathallan ward.

The invitation for Kinross-shire has not been circulated at this time however Councillors Barnacle, Cuthbert, Giacopazzi and Robertson will be invited to attend.

In addition community council members and members of the public are encouraged to pop in between the hours of 2pm and 7pm to discuss any policing issues.



The event held on 9th October was successful with approximately 15 members of the public and members of the community council in attendance.

There are plans underway to hold similar engagement events throughout the other multi member ward areas within Perth and Kinross.

A FUTURE PROSPECTS career event was held at Perth Grammar on Saturday 3rd October 2015. This was a joint event highlighting the work of Special Constables and Full Time Officers and the opportunities available for joining the Police Service.

In addition to this all secondary Schools in Perth and Kinross are being offered the opportunity to have a local officer attend and provided a presentation regarding recruitment into the organisation, whilst also highlighting the 100 years of Woman in Policing.

Rape and Sexual Abuse Centre (RASAC) (Perth & Kinross)

The Scottish Government's recent announcement of a further £1.85million investment for Rape Crisis services across Scotland will result in a dedicated Support & Advocacy Post at RASAC P&K. This post will dedicate itself to supporting women and young people who have either reported, or are considering reporting, a sexual offence to the Police. RASAC P&K look forward to working closer with local officers in establishing this project.

Across recent years Police Scotland have transformed the way in which sexual offence reports are investigated, including the introduction of Rape Investigation Teams and the training of Sexual Offence Liaison Officers (SOLO). These changes

have resulted in improvements which are recognised by our local centre, RASAC P&K. The Centre has noted a significant increase in the number of women who have provided positive feedback of the reporting process. The approach taken by SOLO officers has resulted in an improved experience in which higher numbers of women have felt supported, believed and respected. Reporting is often an extremely difficult decision for victims, making the response given at initial point of contact crucial in determining whether or not they proceed with the reporting process. Additionally, there are many officers who have met with women at RASAC P&K, either to take statements or to inform them of the process. The option to meet with an officer in an environment they feel is comfortable and safe has given many women increased confidence to proceed.

In working together to end sexual violence and bring perpetrators to justice we seek to strengthen the work of both Police Scotland and RASAC P&K by providing services which protect individuals and build safer communities.
