#### Local Development Plan Action Programme 2012-2024

#### **Report by Executive Director (Environment)**

This report highlights the changes and updates in the Action Programme since the previous version which was published in May 2013. The Local Development Plan Examination resulted in changes being made to the Action Programme, as well as recent consultation with Key Stakeholders which provided progress updates on development sites. The Action Programme is for information and will be updated on a regular basis.

Approval is sought for the final Action Programme to be adopted, published and submitted to Scottish Ministers in support of the Adopted Local Development Plan.

#### 1. BACKGROUND / MAIN ISSUES

- 1.1 The Perth and Kinross Local Development Plan was adopted by Scottish Ministers on 3 February 2014. The Local Development Plan sets out a vision to promote Perth and Kinross as a dynamic and attractive region for sustainable and economic development looking to 2024. A copy of the Local Development Plan is available online: <u>http://www.pkc.gov.uk/Local-Development-Plan</u>
- 1.2 The new Planning Act sought not only to speed up the production of the Local Development Plan but also to ensure that there was a greater focus on delivery. Accordingly, the legislation requires local authorities to produce an Action Programme to accompany the LDP, which assists the delivery and notes the progress of sites. Planning Circular 6/2013 states that Scottish Ministers anticipate that Action Programmes are key tools in instigating action and co-ordinating the activity of a range of agencies and organisations.
- 1.3 Planning Circular 6/2013 confirms that Action Programmes must be published within three months of adoption of the LDP. The legislation states that Action Programmes should then be regularly reviewed and an updated version should be re-published at least every two years. Each time the Action Programme is re-published, two copies should be sent to Scottish Ministers as well as being placed in each public library within the local authority area and made available online.
- 1.4 The legislation states that Action Programmes should demonstrate:

- A list of actions required to deliver each of the plan's policies and proposals;
- The name of the person who is to carry out the action; and
- The timescale for carrying out each action.

#### 2. PROPOSALS

- 2.1 Following the LDP Examination, a number of changes were made to the Local Development Plan most of which have been reflected within the Action Programme. There have been new sites added (e.g. Almond Valley Village), sites deleted (e.g. West Kinross H46) and sites altered in size (e.g. Perth West). The updated Action Programme can be seen in Appendix 1.
- 2.2 Key Stakeholders have recently been consulted on the Action Programme and have provided updates on a number of sites. Their input is vital in ensuring that the Action Programme remains up-to-date and all progress on development sites is recorded.
- 2.3 Following adoption of the Local Development Plan by Scottish Ministers on 3 February 2014, the Action Programme should be published no later than 3 May 2014. The previous version of the Action Programme was published in May 2013 which accompanied the Proposed Local Development Plan.
- 2.4 It is proposed that the Action Programme is updated on a regular basis and published every 6 months in order for it to remain a robust and effective working document that will aid the delivery of development within the life time of the Local Development Plan. The intention is to build on the content of the Action Programme updating it regularly with information from site owners and developers in relation to their programme for development. This will give confidence to the providers and funders of the required infrastructure and services to commence early planning and implementation.
- 2.5 Updates to the Programme will be of a factual nature and as such it is not intended to report to the E&I Committee each time it is updated. A bi-annual report will be prepared detailing progress on the delivery and implementation of the actions set out in the Programme.

#### 3. CONCLUSION AND RECOMMENDATION(S)

- 3.1 Publication of the Action Programme is a significant step towards the implementation of the recently adopted Local Development Plan. It sets out the actions required to ensure the successful implementation of policies and proposals contained within the Local Development Plan. It also indicates who will be responsible for delivering the actions and the anticipated timescale to commence them.
- 3.2 The Action Programme will help ensure that the Local Development Plan delivers sustainable economic growth through shaping better quality places and responding to climate change.

- 3.3 It is recommended that the Council:
  - (i) Adopts the Action Programme as set out in Appendix 1
  - (ii) Instructs the Executive Director (Environment) to publish and submit the Action Programme to the Scottish Ministers
  - (iii) Instructs the Executive Director (Environment) to regularly update and publish the Action Programme and to prepare a bi-annual report to the E&I Committee on delivery and implementation of the Action Programme.

#### Introduction

The Action Programme has been prepared to support the delivery of the Perth and Kinross Local Development Plan. It sets out the actions and partnerships required to implement the strategy of the Local Development Plan to 2024 and will serve as a tool to achieve this purpose.

Section 21 of the Planning etc. (Scotland) Act 2006 requires a Local Planning Authority to publish an Action Programme to accompany the Local Development Plan which sets out the aspirations and policies behind the programme.

To ensure the efficient and effective delivery of the Local Development Plan, it is important that any action or infrastructure development required are identified as soon as possible to provide confidence to key stakeholders, developers and funders.

The Action Programme has been prepared in consultation with input from other departments within Perth & Kinross Council, key stakeholders, the Scottish Government and other organisations/ delivery bodies specified in the document. Perth & Kinross Council have an aspiration to build on this version of the Action Programme with more regular reviews and increased communication with key stakeholders.

Funding of a number of the schemes contained within the Action Programme will be dependent on future Scottish Government spending reviews and the availability of public and private sector finance.

#### Approach

The delivery of proposals and policies is a complex process which requires a pragmatic approach to delivery. In considering the delivery of sites, the expectations of all parties should remain realistic, and the requirements remain as flexible as possible to ensure the delivery is viable. While all the Strategic and National Development Actions from NPF2, the emerging NPF3 and STPR are important only some will have a direct impact on the delivery of the Local Development Plan.

#### **Delivery and Monitoring**

Strong leadership and stakeholder commitment is key to the successful delivery of the Proposed Action Programme. Circular 6/2013 requires Planning Authorities to consult and consider the views of the key agencies, the Scottish Ministers and anyone specified by name in the Action Programme.

Regular monitoring and updating of the Action Programme will take account of any policy alterations or developments and will be republished more frequently than the statutory regulations require to ensure the document remains up-to-date and effective.
