Joint Report by Head of Finance & Executive Director (Environment)

PURPOSE OF REPORT

This report details the Income and Expenditure to 6 November 2013 and the projected outturn to 31 March 2014.

1. BACKGROUND / MAIN ISSUES

1.1 The Committee approved the budget at the meeting of 1 May 2013. This report provides the monitoring position and projected outturn for the Financial Year 2013/2014.

2. PROPOSALS

2.1 Financial Statement 2013/14

On the basis of Appendix 1, it is anticipated that a deficit of £1,685 will accrue in 2013/14 and the Fund's estimated Revenue Account Balance will be £82,492 at 31 March 2014. The main movement is the additional costs associated with the sale of Aberfeldy Town Hall as reported to this Committee at the meeting on 2 October 2013, (Report No 13/433 refers). As there is still uncertainty whether the sale of Aberfeldy Town Hall will be concluded within this financial year no income from the sale has been projected.

3. CONCLUSION AND RECOMMENDATION

3.1 The Committee is requested to note the Aberfeldy Common Good Fund Income and Expenditure to 6 November 2013 and the projected outturn to 31 March 2014.
