## LICENSING COMMITTEE

Minute of Meeting of the Licensing Committee held in the Council Chambers, Ground Floor, Council Building, 2 High Street, Perth on Thursday 21 February 2019 at 10.00am.

### 83. WELCOME AND APOLOGIES

The Convener welcomed all present to the meeting. Apologies for absence were noted as above.

### 84. DECLARATIONS OF INTEREST

There were no declarations of interest in terms of the Councillors' Code of Conduct.

### 85. MINUTES

The Minute of Meeting of the Licensing Committee of 10 January 2018 was submitted and approved as a correct record.

### 86. REVIEW OF CIVIC LICENCE FEES

There was submitted a report by the Head of Legal and Governance Services (19/49) seeking approval for an increase in fees for licences issued under the Civic Government (Scotland) Act 1982 and the Housing (Scotland) Act 2006.

D Merchant, Licensing Manager, advised the Committee of an omission from Appendix 1 to Report 19/49 relating to new applications for taxi/private hire car drivers licences, and explained that no increase to this fee would be applied in light of the decision taken under Art. 8 of the minute of the Licensing Committee of 10 January 2019 which approved the introduction of a £30.00 fee to cover the cost of the new taxi and private hire drivers' knowledge test.

#### **Resolved:**

The increase in fees charged as set out in Appendix 1 of Report 19/49 be approved.

**87. SUSPENSION OF SKIN PIERCING & TATTOOING LICENCE NO. SP70**

There was submitted a report by the Head of Legal and Governance Services (19/51) together with a letter of objection from Police Scotland dated 22 January 2019 in terms of Schedule 1, Paragraph 11 of the Civic Government (Scotland) Act 1982 regarding suspension Skin Piercing and Tattooing Licence (SP70).

The representative from Police Scotland advised the Committee that they had now withdrawn their request for suspension. Thereafter, Art. 87 was withdrawn from the agenda.

**88. SUSPENSION OF A TAXI/PRIVATE HIRE CAR DRIVER LICENCE NO. TD709**

There was submitted a report by the Head of Legal and Governance Services (19/52) together with a letter of representation dated 6 February 2019 from Police Scotland regarding Suspension of Taxi/Private Hire Car Driver's Licence No. TD709.

Taxi/Private Hire Car Driver's Licence No. TD709 be not suspended.
