### Aberfeldy Putting Green – Extension to Existing Concession

### Report by Executive Director (Housing and Environment) (Report No. 18/410)

This report seeks approval from Aberfeldy Common Good Fund Committee to extend the existing concession to operate Aberfeldy Putting Green for a further three years.

### 1. BACKGROUND / MAIN ISSUES

- 1.1 At the Aberfeldy Common Good Fund Committee meeting on 11 December 2013 (Report No.13/577 refers), it was agreed that:
  - the Aberfeldy putting green site be advertised for a concession to run it as a going concern including the comfort scheme and grounds maintenance, and
  - if there was no interest, the Council will revert to standard amenity maintenance.
- 1.2 At the Aberfeldy Common Good Fund Committee meeting on 8 October 2014, it was agreed to appoint Fourways as operator for the Aberfeldy putting green new concession.
- 1.3 Fourways were given the concession until 31 March 2016.
- 1.4 At the Aberfeldy Common Good Fund Committee meeting on 16 December 2015 (Report 15/583), it was agreed to:
  - extend the current Concession from 1 April 2016 to 31 March 2019 on the same terms and conditions as reported to the meeting of 8 October 2014, and
  - note that the operation of the putting green be passed over from Fourways to Aberfeldy Community Putting Green (ACPG).
- 1.5 ACPG have approached Perth & Kinross Council asking if the concession could be extended for a further three years.
- 1.6 The three local members, were consulted on the following issues:
  - their awareness of any local interest expressed in operating this concession,
  - their awareness of any complaints/comments about the operation of the concession by ACPG, and
  - were they happy for ACPG to continue to operate the Concession

- 1.7 All three elected members stated that they were in favour of ACPG continuing to operate the concession for a further three years.
- 1.8 ACPG were asked for, and have provided, a statement on the benefits that operating the concession has given to the staff, together with an indication of visitor numbers (see Appendix 1). The group have also supplied a copy of their Annual Report for year-end 31 December 2017 (see Appendix 2).

### 2. PROPOSALS

- 2.1 Neither Perth & Kinross Council nor the local elected members have received or are aware of any other expression of interest in operating this Concession and have received no complaints about the present operator. It is, therefore, proposed to extend the current concession from 1 April 2019 to 31 March 2022 on the same terms and conditions.
- 2.2 The current terms and conditions, as reported to the meeting of 08 October 2014, are:-
  - Rent £1 per annum, if asked;

Aberfeldy Community Putting Green (ACPG) will be responsible for:-

- maintaining the putting green including cutting of holes, installing cups and flags and thereafter regularly reposition holes;
- cleaning the public toilet to a high standard of cleanliness and replenishment of disposable items e.g. toilet paper, soaps, hand towels;
- maintaining public picnic tables;
- maintaining shrubs beds around the kiosk and toilets;
- maintaining equipment for use on the putting green;
- security of the kiosk and toilets.

The Council will be responsible for:-

- keeping the kiosk and toilets wind and watertight;
- regulatory and compliance testing of kiosk and toilet services;
- insuring the kiosk and toilets except contents;
- maintaining shrub and bedding plants (except for the beds for which ACPG are responsible) including paths and other hard landscaping;
- replacing damaged or worn picnic tables, subject to available resources.

### 3. BEST VALUE

- 3.1 The Local Government in Scotland Act 2003 requires the Council to make the best use of public resources, including land and property, and to be open and transparent in transactions.
- 3.2 The Council is required to demonstrate responsiveness to the needs of communities, citizens, customers and the other stakeholders where relevant

in its assessment of best value. The aspects of this duty which are relevant to the proposals in this report are as follows:

- making the best use of land and property
- being open and transparent in transactions
- insuring sound financial controls are in place to minimise the risk of fraud and error
- assessing the full financial consequences of decisions at an appropriate level before major financial decisions are taken or commitments entered into
- demonstrating responsiveness to the needs of communities, citizens, customers and other stakeholders, where relevant
- 3.3 The implementation of the recommendations in this report is considered to comply with the Council's requirement to fulfil its statutory duties in respect of Best Value and meet the Council's Corporate Plan 2018-22 strategic objectives of supporting people to lead independent, healthy and active lives by employing people with mental health issues.
- 3.4 Given the current success of ACPG, the extension of the current concession on the same terms and conditions will save the Council costs in advertising the concession (previous advertisements only produced one tender), along with a saving in staff costs for advertising and re-negotiating new terms and conditions.

### 4 CONCLUSION AND RECOMMENDATION

4.1 It is recommended that the Committee approves ACPG's request for an extension of their current concession to run the Aberfeldy Putting Green for a further three years until 31 March 2022.

### Statement from Aberfeldy Community Putting Green

For use and discussion at the next Common Good Committee Meeting, I am attaching our Annual report for 2017 which gives a detailed account of visitors, events and work with volunteers etc. This year our visitors' numbers have increased again. From end March to end October we have received approx. 3800 visitors to the Putting Green. This is 14% up on our final figure for last year (3282) and an almost 25% increase since 2015 (3000).

All our volunteers are a wonderful asset and without them we could not run the facility. Those who need extra support are given assistance, training and encouragement to play as big a part as they feel they can. We are a social group and meet weekly out of season for coffee and a chat and to continue to plan events, fundraising, and essential maintenance work for the putting green. All our volunteers have contact with each other and support each other as and when needed. Having a central focus such as the putting green has greatly benefited our volunteers, especially those with long term and enduring mental health issues.

Year on year we have received many wonderful comments from locals and visitors about our facility. How it enhances the town offering a very cheap, fun activity for all the family. We have a number of visitors who return year on year, and we have made many friends. We have also received donations from visitors.

I hope this is of help, and that the Common Good Committee will see fit to grant us a further concession to run the Putting Green. If there is any further information yourself, or the Councilors need, please do not hesitate to contact me.

Our season commenced on 1st April 2017 at the start of the Spring Holidays. Over a magnificent 3 week holiday period, we received approximately 641 visitors providing us with income from putting and snacks of £1203!

On Sunday 16th April for the second year, we held an Easter Egg Hunt. Over 30 local and visiting children took part in the hunt for approximately 120 Easter Eggs. We raised £100 in donations.

On Friday 28th July, for the first time since we took over running the Putting Green, we held a Family Fun Day. Again we were fortunate to be well supported with in the region of 95 visitors. We made a wonderful £320. We were

### Season Opening & Egg Hunt

Prior to opening at the end of March/beginning of April we tidy the putting green and gardens, spruce up the kiosk, order a new stock of snacks and drinks, put up the signs and hope for another successful season with lots of happy visitors.

This year was no exception and we had a tremendous start with favorable good weather and around 641 visitors, in a 3 week period, from all over the country and abroad. Our Easter Egg Hunt once again proved successful and a wonderful time was had by all.

### Summer Family Fun Day









For the first time since we took over running the Putting Green our group decided to try and run a slightly larger event than normal to attract more visitors and locals, and to raise our profile. Aberfeldy is lucky to receive a large number of tourists through out the year, but especially in the summer.

We planned a BBQ, Bouncy Castle, Raffle & Tombola, Bake Sale, Tattoos and Fun Putting. All our volunteers worked extremely hard to make everything possible and we were fortunate to have a beautiful day weather wise.

Flyers, banners and posters were put up and distributed, an advert in the Quair magazine at the start of July, and word of mouth ensured we received a good turn out.

The event was held on Saturday 28th July and we had approx. 95 visitors. Many enjoyed putting however the Bouncy Castle and stalls were also very popular. John and Willie ensured the burgers were popular!

Overall the event was a great success. We raised  $\pm 320$  and felt we provided a fun and entertaining day for lots of people., at a reasonable price, with many people staying and picnicking for the afternoon.

We will certainly aim to hold a similar event in 2018.

### Season Finale



Our 3rd and final event of the season was an Open Day on Saturday 14th October when we invited visitors, locals, and all our supporters to putt FREE and had a Tombola and Home Baking Stall. Cllr Ian Campbell attended and presented us with our Volunteer Friendly Award, given by the Perth & Kinross Volunteer Hub in recognition of the good practice, support and mentoring given to our volunteers.

We were also delighted to receive the Move2Improve "Best Kept Commercial Property" award for our Putting Green and gardens.

By the close of season at the end of October we had received 3285 visitors, an increase of approximately 285 (9.5%) on the previous 2016 season. Well done everyone! To celebrate and thank our volunteers, we held an end of season dinner at The Waterfront Restaurant in Kenmore.





### OUR VOLUNTEERS

In 2017 our volunteer numbers rose by 3 bringing our total to 12. With our help and support some of our volunteers have gone onto participate in further volunteering opportunities, completing additional training courses and starting college courses. As well as continuing to attend and benefit from existing weekly well-being support sessions.

Volunteer William Swinton has joined the Northwest Community Mental Health Team which offers a weekly Dementia Group at Pitlochry. William helps with art & craft, giving encouragement and assistance to clients and aiding staff. William finds this challenging, enjoyable and he feels he is contributing to the community by giving something back. William is also a Volunteer Coach with Community Cook It an initiative to help vulnerable groups and people with mental health issues; learn more about nutrition and preparing reasonably priced and health food, He has completed The Royal Environmental Health Institute of Scotland 'Food Health & Nutrition' and Food Hygiene' courses.

Another volunteer, Jackie Shanley, commenced a course at Perth College— PDA Mental Health Peer Support. This will enable Jackie to further support people with mental health problems in groups and one-to-one sessions.

We encourage all our volunteers to take up new and interesting challenges and will continue in 2018 to further our training programme and refresh ourselves with regard to Health & Safety and First Aid where appropriate.

### Fundraising and Donations

Our three events at the Putting Green plus a the Pub Quiz in December raised a total of £732. In addition, we received two individual donations; the first being £100 from Mr Cunningham (Cunningham Carpets) toward repairing the putting green after some vandalism. And a very generous donation of £25 from two visitors from Kirkcaldy. In total we have been fortunate to receive £857 in donations in 2017.

### Report by Head of Finance (Report No. 18/411)

### PURPOSE OF REPORT

This report provides an update of the Income and Expenditure to 31 October 2018 and the projected outturn to 31 March 2019 for the Aberfeldy Common Good Fund.

### 1. BACKGROUND / MAIN ISSUES

1.1 The Committee approved the Aberfeldy Common Good Fund budget for 2018/19 at the meeting of 25 April 2018 (Report 18/143 refers). This report provides an update on the monitoring position and projected outturn for Financial Year 2018/19.

### 2. PROPOSALS
