APPLICATION FOR FINANCIAL ASSISTANCE

Report by Strategic Lead – Housing and Communities (Report No. 24/139)

1. PURPOSE

1.1 The report asks the Auchterarder Common Good Fund Committee to consider one capital grant application for financial assistance.

2. **RECOMMENDATION**

- 2.1 It is recommended that Committee:
 - Consider the grant application and agree any financial assistance to be awarded.

4. BACKGROUND / MAIN ISSUES

- 4.1 Perth and Kinross Council owns land and property which forms part of the Common Good of the former burghs in Perth and Kinross and has a statutory duty in terms of section 15 of the Local Government etc. (Scotland) Act 1994 to administer this land and property "having regard to the interests of the inhabitants" of those former burghs. This duty also applies to the administration of the associated Common Good Funds.
- 4.2 The Common Good Funds have traditionally demonstrated their support to local residents and organisations by distributing grants. These grant awards allow individuals and local organisations to carry out a wide range of community-based activities.
- 4.3 Applications to Common Good Funds vary across the different former burghs of Perth and Kinross. The report is for the Auchterarder Common Good Fund.
- 4.4 The proposed 2024/25 Budget for the Auchterarder Common Good Fund is included in a separate report at this meeting. A summary of the draft Financial Assistance budget, and the value of funding under consideration, is provided below:

5. **PROPOSALS – CAPITAL GRANTS**

Auchterarder Parish Church

- 5.1 An application of £7,560 has been received by Auchterarder Parish Church to help with the costs of maintaining their Community Centre Car Park to prevent flooding, ensuring access for all. During recent heavy rain and snow, access to the car park has been restricted, limiting access to community activities within the Centre and visits from the Mobile Bank. Local neighbours have also voiced concern over flood water from the car park getting into their gardens and are very supportive of the planned works. A local Contractor has been found to construct a soakaway for the car park, adding gravel to ease drainage. The works are set to commence as soon as possible, with completion due a week after.
- 5.2 It is estimated that the project will benefit 205 people from within the Common Good area, along with 205 people from elsewhere in Perth & Kinross.
- 5.3 The total costs of the project are estimated to be £7,560 with the Group requesting the full amount. A full breakdown is included below.

2023/24 FINANCIAL STATEMENT & 2024/25 BUDGET

Report by Strategic Lead – Finance and Business Support (Report No. 24/140)

1. PURPOSE OF REPORT

This report provides the projected outturn for Financial Year 2023/24, and the proposed budget and projected outturn for Financial Year 2024/25.

2. **RECOMMENDATIONS**

The Committee is requested to:

- (i) Note the projected Income and Expenditure to the 29 February 2024 for the Auchterarder Common Good Fund for the 2023/24 Financial Year, as set out in Appendix 1 to the report.
- (ii) Approve the Budget for the Auchterarder Common Good Fund for the 2024/25 Financial Year, and draft Budget for the 2025/25 Financial Year, as set out Appendix 2 to the report.

3. BACKGROUND / MAIN ISSUES

3.1 This report provides an update on the projected outturn for Financial Year 2023/24, and the budget for Financial Year 2024/25.

4. **PROPOSALS**

Financial Statement 2023/24

4.1 As detailed in Appendix 1, there is a projected deficit of £10,890 for Financial Year 2023/24, and the estimated Fund balance at 31 March 2024 is £298,212.

Budget 2024/25

- 4.2 The proposed 2024/25 Budget for the Fund provides a surplus to mitigate the potential impact of unknown costs or a reduction in income, and to ensure the Fund remains sustainable over the longer term.
- 4.2.1 Repairs & Maintenance

It is proposed to maintain a £5,000 budget to accommodate the costs for repairs or improvement works to the grazing fields during 2024/25.

4.2.2 Financial Assistance

The 2023/24 Financial Assistance budget was reduced to £15,000 to accommodate the additional expenditure for the full replacement of the Christmas Lights. It is proposed that the 2024/25 Financial Assistance budget is reinstated at the level for the years prior to 2023/24 at £20,000.

4.2.3 Christmas Lights

The Auchterarder Christmas Lights were fully replaced in 2023/24. The proposed £3,000 budget allows for the costs incurred during the installation and removal of the lights, and for any required repairs to the festive decorations.

4.2.4 Income

Rental income is assumed to remain in line with previous years at £21,000. The estimate for interest received has increased to £13,300 in line with the higher interest rate available when fixing the deposit for another 12 months.

4.3 There is one application for financial assistance to be considered at this meeting, and it is assumed that the level of funding approved by the Committee will be contained within the Financial Assistance budget.
