P1. PRE-MARKETING REMEDIATION

There was submitted a report, together with revised Appendix 1, by the Depute Director (Environment) (14/1) (1) informing elected members of the vacant and life-expired properties which would benefit from works being undertaken by utilising the £200K allocated for pre-marketing remediation in the 2013/14 financial year. The report noted that funding would allow redevelopment opportunities to be progressed to support regeneration and Service objectives, and ensure Best Value was achieved.
