4. GRANT OF TAXI OPERATOR LICENCE - X32

There was submitted a report by the Head of Legal and Governance Services (21/46) regarding the Grant of Taxi Operator Licence No. X32.

Resolved:

- (i) Grant of Taxi Operator Licence X32 be refused, on the grounds that it would contravene the policy currently in place regarding the limit on taxi numbers in Perth.
- (ii) Following the release of the Unmet Demand Survey, the Licensing Manager be instructed to look at the current policy with a view to bringing this to a future meeting for discussion on possible changes that could be made to the policy.

(iii) If there are any material changes made to the current policy in the near future, the usual one-year ban for the applicant on re-applying for a licence be lifted.
