# **Extreme Weather Events Review Overview of Activity**

# Background

In October 2023, Perth and Kinross experienced a series of severe weather events that had a significant impact on people and properties. As a result, the Council conducted a review which has been regularly reported to the Scrutiny and Performance Committee. The review focused on the Council's preparedness, response, and recovery efforts during these events. It identified areas for improvement to enhance the Council's effectiveness in handling similar future events.

For residents and businesses affected as a result of these and other weather events, this has been a very difficult time, with disruption lasting far beyond the periods of weather. The Council continues to acknowledge that we have an important role to play in reassuring residents, building resilience and confidence in our ability to respond effectively to future events. The feedback from residents, internal reviews of activity and scrutiny by Committee members has been a valuable part of identifying areas for improvement.

While the closure timing of flood gates at the North Inch received significant attention, the review and improvement plan extend beyond this factor. In developing the improvement plan we have acknowledged that existing plans and processes need updating to account for the rising frequency and intensity of severe weather events throughout the year. Additionally, it considers the potential impact of losing the expertise of individuals involved in past responses.

This interim report provides a summary of the activity to date.

#### Weather events

The three weather events reviewed to develop the improvement plan took place on:

- 6-8 October 2023
- 18-21 October 2023
- 27-29 October 2023

## **Acting on feedback**

The October 2023 weather events affected communities across Perth and Kinross, many simultaneously. While we heard lots of positive examples from residents who were positive about the approach taken in their area, there were also instances during the response and recovery phase where the Council did not meet the standards of support that residents expect. Our Chief Executive has placed on record his apology for those who experienced this, doing so at a community meeting with impacted residents around the North Inch area, in a public statement issued to the media, and again at the first meeting of Scrutiny and Performance to consider the improvement plan.

Our thanks go to all of the residents who shared their feedback directly and via representatives during one-to-one conversations with our teams, at the resident's meeting and by sharing their experiences with the Scrutiny and Performance Committee. This feedback has informed the improvement plan and subsequent activity.

In addition, various contact and reassurance visits were carried out to affected households. Visits and ongoing contact were carried out with 37 households in Perth City and 10 households in Invergowrie. During these contacts, advice and support, including signposting to relevant services and a single point of contact, was provided. The Housing Service is continuing to provide support to some households regarding ongoing accommodation needs.

## Scrutiny and review

Scrutiny of the circumstances surrounding the initial weather events and progress updates on the improvement plan have taken place across several meetings of the Scrutiny and Performance Committee.

- 22 November 2023 the committee heard from residents impacted and considered a detailed report and improvement plan. Due to time pressures only activity related to the 6-8 October weather event were considered. The <u>report</u> presented and a <u>recording of the meeting</u> are available to review.
- 31 January 2024 the committee considered the report as it related to the 18-21
   October and 27-29 October weather events alongside an updated improvement plan. The report presented and a recording of the meeting are available to review.
- 24 April 2024 the committee considered an update on improvement activities undertaken. The <u>report</u> presented and a <u>recording of the meeting</u> are available to review.

Key findings from the severe weather events were included in Section 9 of the 22<sup>nd</sup> November 2023 report, categorised under Preparedness, Response and Impact & Recovery. The following table provides a further update on the Improvement Plan actions arising from the findings.

## **Liability Claims**

Investigations into the causes of the flooding remain ongoing through the Council's Insurers. Claims for the impact of flooding on affected properties between 6-8 October are being managed through the Council's Insurance team with residents being signposted on how to submit a claim. This will follow due process and is in the hands of the respective Insurance companies and advisors.
