Notes:

1. Unless stated differently Convenerships continued throughout the year.
2. Costs include VAT where applicable
3. Remuneration and relevant allowances were subject to Income Tax and National Insurance.
4. Travel and subsistence expenses, where claimed, relate only to the reimbursement of actual expenditure incurred by the Councillor. All claims were receipted during 2019/20.
5. Reimbursement of expenses for overseas trips is included in the travel and subsistence columns. There were two overseas trips paid in 2019/20.
6. Telephone and ICT Expenses - Support costs are met by the Council. There is no refund of any costs to elected members. The variation of support costs to each elected member reflects the cost of supporting homeworking and annual rental costs for mobile telephones. The balance relates to costs incurred from telephone calls made as part of Council activities.
7. Civic Allowance - The Provost of the Council can incur expenditure up to a maximum of £3,000 to support his/her activities. £717.00 of this allowance was claimed in 2019/20. This is recorded as Other Allowances and Expenses.
8. A mileage rate of £0.92 has been identified relating to costs associated with the provision of a vehicle for the use by the Provost and other nominated Councillors fulfilling civic/ceremonial duties. Staff costs associated with driving the civic vehicle have been estimated at an average of £14.72 per hour in addition to mileage costs. These costs are provided under Car & Van Mileage paid directly.
9. The format of this report follows that prescribed in the Scottish Government's publication titled 'Councillors' Remuneration: Remuneration, Allowances and Expenses - Guidance (Revised April 2010)' to ensure consistency of interpretation between all Scottish Local Authorities.
