8. MINUTE OF PREVIOUS MEETING

11. COMMUNITY GREENSPACE CAPITAL PROJECTS FOR 2014/15 AND 2015/16

There was submitted a report by the Depute Director (Environment) (14/10) outlining the main Capital Projects being undertaken by Community Greenspace in 2014/15 and 2015/16 and recommending the approval of this programme of investment in the Council's parks and open spaces to ensure they remain well used, fit for purpose and a source of community pride.

Resolved

12. LOCAL AIR QUALITY MANAGEMENT – DECLARATION OF AIR QUALITY MANAGEMENT AREA – CRIEFF (Art. 347/13)

There was submitted a report by the Depute Director (Environment) (14/11) asking the Committee to agree the extent of the Air Quality Management Area in Crieff and to implement it by designation, to come into force on 19 February 2014.

Resolved

- (i) The implementation of the statutory requirement of Section 83 (1) of the Environment Act 1995 through designation, by Order, of an Air Quality Management Area for nitrogen dioxide and fine particles, to come into force on 19 February 2014 and remain in force until it is varied or revoked by a subsequent Order, be approved.
- (ii) The area of Crieff, as shown on the map attached at Appendix 1 to report 14/11 and defined in the report, be designated as an Air Quality Management Area, be approved.
- (iii) The Depute Director (Environment) be remitted to make the necessary arrangements to complete and report back to this Committee regarding the further assessment of Air Quality and Air Quality Action Plan within the statutory timescales.
- (iv) The Executive Director (Environment) be remitted to prepare the necessary documentation for the designation Order and to publicise the said Order.

13. ABERFELDY CARAVAN PARK COMMON GOOD FUND PAYMENT (Art. 37/13)

There was submitted a report by the Depute Director (Environment) (14/12) noting that Aberfeldy Caravan Park was not regarded as part of the Common Good of Aberfeldy and recommending that the Council should not continue to make an annual payment of £4,500 to the Aberfeldy Common Good Fund.
