# 204. ACTIONS TO PROMOTE THE RED SQUIRREL POPULATION ON COUNCIL LAND

There was submitted a report by the Executive Director (Environment) (15/149) outlining the outcome of the surveys undertaken to assess the populations of red and grey squirrels on Council managed land and recommending actions to promote and increase the red squirrel population in specific locations.
