#### Resolved:

- (iii) Additional works to enhance the area around the former bowling green to create a more welcoming entrance to the park, and make best use of the available space for recreational purposes be approved.
- (iv) Instruct the Depute Director (Environment) to submit a report to the Perth Common Good Fund Committee requesting formal approval for the proposals outlined in Report 13/32.
