MOUNTAINS OF OUR FUTURE EARTH CONFERENCE 2015

PURPOSE OF REPORT

This report relates to a request for civic hospitality from the Centre of Mountain Studies, Perth College UHI, in respect of a conference entitled "Mountains of our Future Earth", coming to Perth in September or October 2015.

1. BACKGROUND / MAIN ISSUES

- 1.1 In October 2005, the Centre for Mountain Studies at Perth College UHI, in collaboration with international project partners held a conference in Perth entitled the "Open Science Conference". The conference was attended by 210 people from 41 countries.
- 1.2 In September 2010, the Centre for Mountain Studies, in collaboration with the Mountain Research Initiative, hosted a second international conference in Perth, entitled "Global Change and the World's Mountains". The conference was attended by 450 people from 60 countries. The Council provided civic hospitality in the form of a wine reception for 450 guests at a cost of £1,245.
- 1.3 A third conference is planned to take place in Perth in September or October 2015. It will be entitled "Mountains of our Future Earth" and will be directly linked into the global Future Earth research programme. It is anticipated that the conference will again be attended by approximately 450 delegates from across the world.
- 1.4 It is envisaged that the conference will start on a Sunday with fieldtrips to various parts of Highland Perthshire and other mountain locations easily accessible from Perth, followed by lunchtime sessions at Perth Concert Hall from Monday to Thursday.
- 1.5 The Environment Service has agreed to make a £10,000 financial contribution towards the conference.
- 1.6 In order to attract such a prestigious international conference, VisitScotland has agreed to match the total financial contribution by Perth & Kinross Council to the conference from the VisitScotland National Bid Fund.
- 1.7 The Centre of Mountain Studies, Perth College UHI has requested civic hospitality in the form of a wine reception for 450 delegates at Perth Concert Hall.

2. PROPOSALS

2.1 It is proposed that the Council agree to a request for civic hospitality in the form of a wine reception to welcome 450 international delegates to the 2015 conference, "Mountains of our Future Earth" at Perth Concert Hall in September or October 2015.

3. CONCLUSION AND RECOMMENDATIONS

- 3.1 It is envisaged that the anticipated 450 delegates from across the globe attending the 2015 conference, "Mountains of our Future Earth", will make a substantial contribution to the economy of the area over the week.
- 3.2 It is recommended that the Provost's Sub-Committee agrees to the request for civic hospitality in the form of a wine reception at Perth Concert Hall for approximately 450 delegates attending the conference "Mountains of our Future Earth" in September/October 2015.

2. Resource Implications - Financial
