# P1. GRANT OF TAXI / PRIVATE HIRE CAR DRIVERS' LICENCE – TD1892

# P2. GRANT OF A TAXI/PRIVATE HIRE CAR DRIVER'S LICENCE NO. TD2030

There was submitted a report by the Head of Legal and Governance Services (21/183) together with a letter of objection dated 27 July 2021 from Police Scotland regarding Grant of Taxi/Private Hire Car Driver's Licence No. TD2030.

The applicant failed to attend. The representative of Police Scotland addressed the Committee and answered Members' questions.

FOLLOWING A SHORT ADJOURNMENT, THE COMMITTEE RECONVENED.

#### **Resolved:**

Grant of Taxi/Private Hire Car Driver's Licence TD2030 be refused, on the grounds that due to the pattern of criminal behaviour detailed in the letter from Police Scotland and the potential threat to public safety, together with the lack of an explanation from the applicant as to the circumstances of the alleged offences, the applicant is not a fit and proper person to be the holder of a Taxi/Private Hire Car Driver's Licence. However, following the outcome of the pending court case the applicant could re-apply to a future meeting of the Licensing Committee.

# P3. GRANT OF WINDOW CLEANER LICENCE NO. WC359

There was submitted a report by the Head of Legal and Governance Services (21/184) together with a letter of objection dated 3 August 2021 from Police Scotland regarding Grant of Window Cleaner Licence No. WC359.
