#### Resolved:

Following consideration, and having noted that Report 12/499 had been considered by the Community Safety Committee at its meeting held earlier today, and would be considered by the Enterprise and Infrastructure Committee on 7 November 2012, the Scrutiny Committee on 21 November, approved the contents of The Environment Service Six Monthly BMIP Exception Report as detailed in Appendix 1 to Report 12/499, and as pertaining to this Committee's area of responsibility.

#### 554. BIODIVERSITY IMPROVEMENTS TO PARKS AND OPEN SPACES

There was submitted a report by the Depute Director (Environment) (12/515) (1) outlining the result of trial changes to the maintenance of grass in selected parks and open spaces with the objective of improving biodiversity; (2) reviewing the outcome of the 2010 and 2011 meadow trials; (3) recommending that the long grass areas should be returned to amenity grass, except where wildflower meadows have been created by sowing wildflower meadow seed mixes; and (4) that further alternative methods of improving biodiversity in parks be introduced where there is no additional resource requirement.

#### Resolved:

- (i) The improvements to biodiversity as a result of changes to grass management, the methods used and cost involved in undertaking the trials, be noted.
- (ii) The return of all long grass areas to a two weekly amenity grass cutting regime within parks and open spaces, except where wildflower meadows have been created by sowing wildflower meadow seed mixes or those managed by the community, be agreed.
- (iii) The assessment of alternative methods of improving biodiversity in parks and open spaces and, where practicable, the implementation of these within available resources, be agreed.
- (iv) The submission of a further report to the Committee, detailing the outcome of the 3 yearly trials, be agreed.

#### 555. REVIEW OF ABERFELDY CARAVAN PARK

Mr V Clements, representing Aberfeldy Community Council and Councillor I Campbell, representing Ward 4, addressed the Committee, and, following their respective representations, withdrew to the public benches.

There was submitted a report by the Depute Director (Environment) (12/516) (1) outlining the potential options open to the Council with regard to Aberfeldy Caravan Park; (2) recommending that the site for lease be advertised; and (3) that the Council put in place arrangements for the Park's disposal, through a lease, by referring the matter to the Head of Planning and Regeneration.
