### 1. WELCOME AND APOLOGIES

The Provost welcomed all those present to the meeting and apologies were noted as above.

## 2. DECLARATIONS OF INTEREST

In terms of the Councillors' Code of Conduct, Councillors J Rebbeck, B Brawn and T McEwan all declared a non-financial interest in Item 5.

### A1. REQUEST FOR DEPUTATION

In terms of Standing Orders, Council agreed to the deputation requests in relation to Item 5.

# 3. NOTICE OF MOTION IN TERMS OF STANDING ORDER 8.4(C)

In terms of Standing Order 8.4(c) the Provost confirmed that he had agreed to consider this motion as an urgent item of business at this meeting in order to avoid the need to call a further special meeting.

# **Motion (Councillors X McDade and G Laing)**

That this Council agrees the following:

Given the decision by the Russian Federation to launch an unprovoked attack on its neighbour Ukraine, our government and governments around the world have rightly denounced these actions and called for severe economic and political sanctions against Russia and for military and humanitarian aid to the government and people of Ukraine. In addition, there has been moves to suspend Russia from sporting and cultural competitions around the world.

Perth City has been twinned with the Russian city of Pskov since 1991. Twinning offers an opportunity to build positive civic relations between two local governments in different countries with an aspiration of creating cultural links between their respective communities.

It is important to demonstrate to the Ukrainian citizens living in Perth & Kinross that we do not support the invasion of their homeland or Russia's attack on a free and democratic European nation. For sanctions to be effective they must isolate the aggressor economically and culturally to have the maximum impact and cause the Russian Government to change course. It would therefore be inappropriate to maintain civic ties with Russia whilst they are occupying a sovereign country and threatening European security.

The Council appreciates that many Russian citizens including many living in Perth & Kinross do not support the invasion and some brave Russians have risked their personal safety to protest the Russian Government's actions. We stand in solidarity with them. However, to support them in applying pressure to the Russian government we must apply all the economic and cultural sanctions available to encourage a change of direction.

Perth & Kinross Council has limited opportunities to support the Ukrainian people, but we are determined to do all within our power to assist them and as such the Council agrees the following:

- Council to suspend the twinning of Perth City with Pskov Russia until such time as Russia ends its unwarranted attack and withdraws from the Ukraine. The Provost is instructed to write to the Pskov administration and express the Councils position.
- No formal invites to be issued to the Russian Ambassador or Consul General until such time as Russia ends its unwarranted attack and withdraws from the Ukraine. Instructs the Leader of the Council to write to the Ambassador and Consul General to inform them of the Councils decision and express our condemnation of the Russian Federations illegal actions.
- To "adopt" a Ukrainian city to direct our local support efforts towards with a long-term aspiration to twin with them after the conflict is over.
- Express that Perth & Kinross will welcome Ukrainian refugees and will work with the Scottish & UK Governments to make arrangements to support their arrival.

- Following an end of hostilities to seek to deepen relations and cultural links with all our twin towns and cities, promoting the values of free speech, democracy, peace and cooperation.
- To fly the Ukrainian flag from the Council Chambers as a visible demonstration of our solidarity.

### Addendum to Motion

### **Council Notes**

- 1) the Council is not authorised to provide direct relief to charities abroad,
- the basis of S83(3) of the Local Government (Sc) Act 1973 which states "A local authority may, . . . incur expenditure on contributions to any of the following funds, that is to say—(a) the funds of any charitable body in furtherance of its work in the United Kingdom;..."

Council further agrees that a donation of £10,000 is made to the Disasters Emergencies Committee (DEC) to fund its member charities' UK-based activities in recognition of the considerable strain the crisis in Ukraine has placed on the resources of these charities.

The mover and seconder of the Motion agreed to incorporate the Amendment into the Motion.

The mover and seconder of the Revised Motion also agreed to incorporate the following suggestion from Councillor J Duff into the Revised Motion:

The end of paragraph 4 of the motion to be amended as follows: "...... a free and democratic European nation. The Council also recognises the courage and determination of the Ukrainian people in fighting this deplorable and unjustified attack on their country and wishes to express its strong support for Ukraine, its sovereignty, and its territorial integrity.

### 5. NOTICE OF MOTION IN TERMS OF STANDING ORDER 10.1

Motion (Councillors E Drysdale and R Watters)

This Council fully recognises the autonomy of the Trustees of Live Active Leisure (LAL) to operationally manage the provision of sports and leisure services to the communities of Perth & Kinross, crucially that this is in accordance with its Service Level Agreement with this local authority and in accordance with LAL's own business imperatives. Further, this Council is well aware of the challenges associated with so doing, which have been exacerbated both by the effects of the Covid pandemic and the limitations of financial support which the Council, Scottish Government and UK Government have been able to provide. The Council places significant emphasis on the importance of the services currently offered by LAL, especially right now as we begin to emerge from 2 years of a pandemic that has taken its toll on the physical and mental health of many of us.

However from information provided by officers as part of the recent budget process, it has come to my attention that the proposed termination of gym facilities at Rodney Centre, Perth, within my ward, in a few weeks' time – with the consequential removal of the highly regarded sprung floor in the coaching hall at Bell's Sports Centre (also within my ward) to accommodate transfer of these facilities – appears to directly contravene the terms of the Service Level Agreement between LAL and the Council, at Clause 2.3 which states:-

The Service Provider shall be under an obligation to supply the PSO Services from the Service Provider Properties, the Properties and the Outdoor Centres and the Service Provider shall not be entitled to terminate the supply of PSO Services from any such venues without the prior written consent of the Authority (such consent not to be unreasonably withheld or delayed).

Council is therefore asked to agree to instruct officers to remind LAL Trustees of this legal requirement. Council is further asked to instruct officers to obtain assurance from LAL that PSO services will continue to be provided at the Rodney Centre in accordance with the Service Level Agreement, unless and until agreed otherwise by this Council at a future meeting.

Mr Brown and Mr Munro, followed by Mr Cromwell and Mr Maclehose, on behalf of Live Active Leisure, addressed Council via audio conference and answered a number of questions from elected members.

# 6. SCOTTISH GOVERNMENT CONSULTATION: DRAFT NATIONAL PLANNING FRAMEWORK 4

There was submitted a report by the Head of Planning & Development and Chief Planning Officer (22/46) (1) outlining the key elements of the Draft National Planning Framework 4 (NPF4) which sets out the Scottish Government's long-term plan for Scotland, identifying where development and infrastructure is needed and the policies required to deliver it; and (2) seeking approval for the proposed response to the consultation and for it to be submitted to Scottish Ministers thereafter.

# **Motion (Councillors M Lyle and J Duff)**

- (i) The detailed respons to the consultation questions, as set out in Appendix 1 to Report 22/46, be approved.
- (ii) Any formatting and presentational changes to the document be delegated to the Head of Planning & Development prior to its submission to Scottish Ministers.

Amendment (Councillors C Stewart and M Barnacle)

To include in appropriate sections:

- 1. PKC suggests that the NPF is backed up by a delivery strategy which incorporates a clear commitment from key public sector and statutory stakeholders (including but not limited to Transport Scotland, Scottish Water, NHS territorial boards and electricity network operators) to fully engage at all stages of the planning process, including the development plan stage.
- 2. PKC recognises that there is a need to improve public and developer confidence in the planning process. The Council recommends that the NPF should task LDPs to set out in greater detail what both the public and developers can expect to be delivered on any identified LDP site. Furthermore any exceptions from the design principles for a site (for example on flood risk, environmental or flooding matters, or density/capacity) need to be fully justified to the satisfaction of the planning authority during the application process, and where a development does not comply with the LDP then it must be treated as significantly contrary to the local development plan. Further clarity on this issue should be provided within the Draft Guidance on Local Development Planning, specifying the obligation on developers and landowners to work with the planning authority to provide sufficient site analysis to enable informed decisions to be made on the design guidance to be provided within the LDP.

Taking these two points together, PKC believes that these additions to the NPF would provide greater certainty for developers, planners, communities and elected members through the whole planning process from the preparation of an LDP right through to the delivery stage of individual developments. The mover and seconder of the Motion agreed to incorporate the Amendment into the Motion.

#### **UPDATE ON TAY CITIES REGION DEAL AND FIRST ANNUAL REPORT**

# **Report by Head of Planning and Development**

(Report No. 22/104)

#### 1. PURPOSE

This report provides an update on progress with the Tay Cities Region Deal, with a specific focus on projects benefitting the Perth and Kinross area. It highlights the key updates from the Deal's first Annual Report published in February 2022

#### 2. RECOMMENDATIONS

- 2.1 It is recommended that the Council:
  - (i) note the substantial progress that has been made in the first year of the Deal, and the receipt of c.£11M of grant funding to date.
  - (ii) requests a further report be brought to Council following the publication of the second Tay Cities Region Deal Annual Report.

#### 3. BACKGROUND

- 3.1 A private report was approved by the Executive Sub-Committee of the Strategic Policy and Resources Committee on 23 October 2020 which outlined the background to the Tay Cities Deal and sought agreement to sign the Deal (Report No. 20/203 refers). The Tay Cities Region Deal was signed on 17 December 2020 by the Tay Cities Partnership and both Governments. The Deal is a combined investment of £300m from the Scottish and UK Governments over the coming 10 years to deliver benefits over the next 15 years. The Tay Cities Deal will support business growth, develop innovative technologies, enhance productivity, develop skills, and create jobs. The investment is expected to leverage a further £400m and secure more than 6,000 jobs.
- 3.2 A Joint Committee was established to oversee the development and implementation of the Tay Cities Region Deal and other matters relating to regional economic development. Three Perth and Kinross elected members currently serve on the Joint Committee (Councillors Lyle, Laing and Stewart). In addition, Councillor Parrott is a non-voting co-opted member representing Tactran.
- 3.3 The Tay Cities Deal Programme Management Office has just published its first Annual Report covering the period from 17 December 2020 to 30 September 2021. A full copy of the report can be viewed at

<u>Tay Cities Region Deal Annual Performance Report-approved JC 110322.pdf</u> (taycities.co.uk) (and is included as Appendix 2 to the report).

- 3.4 The Deal aligns with the Regional Economic Strategy themes of:
  - Inclusive Tay Empower and promote inclusion by ensuring that local people have the skills they need to succeed in the modern workplace and that growth is inclusive, with government investment of up to £30m.
  - Innovative Tay Innovate and internationalise by developing globally recognised clusters of academic and business excellence, with government investment of up to £237.9m.
  - Connected Tay Connect by improving physical and digital infrastructure, with government investment of up to £32m.
- 3.5 The Tay Cities Region Deal is comprised of several local, regional, and national partners. These include:
  - Local Authorities Angus Council, Dundee City Council, Fife Council and Perth & Kinross Council
  - Higher Education and Further Education sector
  - The business sector
  - Regional third sector interface bodies
  - Scottish Enterprise
  - Skills Development Scotland
  - Tactran
  - VisitScotland
  - Scottish and UK Governments
- 3.6 Four Perth and Kinross Council led projects are included within the Deal. These are:
  - Perth Cultural Transformation/Perth City Hall (£10M)
  - Low Carbon Transport & Active Travel Hub (£3.5M)
  - Perth Bus & Rail Interchange (£15M)
  - Perth & Kinross & Angus Rural Digital Projects (£2M)
- 3.7 A further nine projects are based in Perth and Kinross or have elements based with Perth and Kinross: -
  - Aviation Academy (£8.1M) led by Perth College UHI & partners
  - Integrated Regional Barley Hub (£35M) led by James Hutton Institute
  - Advanced Plant Growth Centre (£27M) led by James Hutton Institute
  - Project Beacon (£5.2M) led by EcoideaM Ltd
  - Perth Innovation Highway (£5M) led by John Dewar Lamberkin Trust
  - Pitlochry Festival Theatre (£10M) led by Pitlochry Festival Theatre
  - Innerpeffray Library (100K) led by Innerpeffray Library
  - Crieff International Highland Centre (£1M) led by the Crieff Highland Gathering
  - Aero Space Kinross (£1.6M) led by ASSET (Aero Space Scientific Educational Trust)

There are also two thematic programmes within the Deal - a Regional Skills and Investment Programme and a Regional Cultural and Tourism Investment Programme, which are summarised below.

- 3.8 The Regional Skills and Employability Development Programme (£20M) has its own Outline Business Case for the programme including four Phase 1 projects and will be overseen by a Programme Manager (to be employed by Perth & Kinross Council on behalf of the partnership). It was approved in March 2022. The detailed Business Cases for the four projects in Phase 1 will come forward for approval during the remainder of 2022. The projects will deliver regionally, with the opportunity for businesses and residents from Perth and Kinross to participate in, and benefit from, all of them.
- 3.9 The Outline Business Case for the Regional Culture & Tourism Investment Programme (£27M) has been approved by the Governments and the Tay Cities Region Joint Committee. One of its projects is the Tay Adventures, a linked series of ten projects including proposals for pontoons along the river Tay, and for developments at Willowgate near Perth. The Business Case for this project will be developed during 2022/23 for delivery later in the Deal. The programme is oversubscribed, so all projects are required to provide match funding to secure Cities Region Deal investment.

# 4. UPDATE ON PROGRESS - PERTH AND KINROSS APPROVED PROJECTS

# 4.1 INTERNATIONAL BARLEY HUB AND ADVANCED PLANT GROWTH CENTRE

- 4.1.1 The International Barley Hub (IBH) has been developed in parallel with the proposal for the Advanced Plant Growth Centre and, at the request of the Approval Authorities, these have been maintained as separate business case documents, although they ultimately result in the same physical infrastructure investment.
- 4.1.2 The IBH will establish a world-leading research facility for barley science, bringing together industry, dedicated facilities, and world class scientists. It will:
  - expand the scale and excellence of barley research and innovation, operating across a broad spectrum of disciplines.
  - provide state of the art research equipment on site and at industry partners premises.
  - have the capability to support work from the molecular, to the field level.
  - increase the translation and application of this research around the globe.
  - support a "Barley Cluster" of related processing, innovation, and product interests; and
  - develop a supporting skills and knowledge programme.
- 4.1.3 The Advanced Plant Growth Centre (APGC) will be at the heart of plant and crop research and innovation in the Tay Cities region. It will develop the underpinning science and translate that science into industry, which will in turn increase the commercial, economic, and environmental benefits of agriculture and the food and drink sector. The APGC will integrate:

- a plant characterisation facility, which uses imaging to quickly understand how crops respond and perform in different environments.
- post-harvest storage facilities.
- vertical growth facilities; and
- next-generation controlled environments which can simulate any current or future environment anywhere in the world to test the effect on crops.
- 4.1.4 To date, the Project has achieved the following:
  - secured the land transfer required to progress the development
  - full planning permission has been granted for the first phase of the development – poly tunnel relocation, new entrance road, Farm Hub and Barley Field Research Centre.
  - the construction has been completed for the poly tunnels and new entrance road, with groundworks now underway for the other aspects.
  - Secured an accelerated drawdown of £10.048M in addition to that

#### 4.2 PERTH CULTURAL TRANSFORMATION

already planned for years 1 & 2,

- 4.2.1 The investment will bring Perth City Hall, a Grade B listed building in the original medieval heart of the city, back to life. It will repurpose a deteriorating heritage asset, currently on the Buildings at Risk Register, into a new museum attraction of international significance. Perth City Hall will showcase Perth's ancient roots through museum collections which have National Recognition Status. City Hall will become a major cultural venue, a significant addition to the world class offer of the Tay Cities region, and a source of civic and community pride, as it was when first built over a hundred years ago. City Hall will also tell the story of the Stone of Scone, also known as the Stone of Destiny, quarried in Perthshire, and used to crown every Scottish monarch at Moot Hill in Scone.
- 4.2.2 The Project received Full Business Case approval from the Joint Committee on 19 March 2021. To date, the project has achieved the following:
  - archaeology completed in the main hall
  - Considerable progress with internal and external works including public realm enhancements
  - offered and accepted accelerated funding of £3.673M in years 1 and 2 and has now fully claimed its grant award of £10M.

#### 4.3 RURAL ANGUS & PERTH & KINROSS HIGHSPEED BROADBAND

4.3.1 The UK Government committed up to £2 million to developing the Rural Angus and Rural Perth and Kinross High Speed Broadband projects. These projects will enhance digital connectivity in rural areas across the region and will be enhanced by match funding from the UK Government's Local Full Fibre Network programme. Up to £1 million is committed to the Rural Angus project, which will focus on creating a solution to provide remote and rural properties

with full fibre and high-quality wireless connectivity. Up to £1 million is committed to the Rural Perth and Kinross project, which will re-use and extend existing fibre broadband between Perth city centre and edge of city development. The remaining funding will connect over one hundred rural sites, including rural schools, libraries, and museums to gigabit capable connectivity.

- 4.3.2 The Project received Full Business Case approval from the Joint Committee on 18 June 2021. To date, the projects has achieved the following:
  - 34 premises in Perth connected to full fibre by Neos Networks by the end of July 2021, two months ahead of schedule
  - 155 premises in rural Angus (52) and rural Perth & Kinross (103) connected to full fibre by BT by mid-November 2021
  - The Perth & Kinross element of the project has drawn down 99.8% of the funding due, and only has <£2K left to claim in 2022/23

#### 5. CURRENT PROGRESS WITH OTHER PERTH AND KINROSS PROJECTS

5.1 Several other named projects in the Deal are under development and are at various stages in project scoping and Business Case development. Some are not scheduled for financial draw down until the later years of the Deal. The table below outlines the projects and provides a brief update on progress.

#### 6. SIDE DEAL AGREEMENT – FUNDING FOR CROSS TAY LINK ROAD

6.1 An additional £50M "side deal" investment was announced on 7 January 2019 by the Scottish Government. £40M will be invested in the new Cross Tay Link Road, which will link the A9 over the River Tay to the A93 and A94 north of Scone, reducing congestion in Perth and opening up sites for housing and economic development. The remaining £10 million will fund an industrial investment programme to support manufacturing in Perth and Kinross, Angus and Dundee. The grant agreement for the Cross Tay Road Link project has been finalised with Transport Scotland, and the first £5M tranche of grant is currently being drawn down.

# 7. CONCLUSIONS

7.1 The Tay Cities Region Deal provides a significant investment in projects across the Tay Cities Region, including projects within the Perth and Kinross area. The implementation of the Deal and the rolling out of the investment over the ten-year timeframe will make a significant contribution to our future economic growth. The Deal is now operational, and projects are starting to draw down the funding. Good progress has been made, however many projects still require to develop and gain approval for their Business Cases.

  - (iii) Promoting a prosperous, inclusive and sustainable economy.
  - (v) Creating a safe and sustainable place for future generations.

# 2. Resource Implications

#### Financial

2.1 The Tay Cities Deal has secured significant funding for Perth and Kinross capital projects and for other projects to be developed within the area.

#### Workforce

2.2 The recommendations in this report do not have any direct implications for the Council's workforce. However, a number of Council staff are members of the

various TCD governance groups and are working to take forward both the Council led projects and to support other local organisations to develop their Business Cases to gain full approval and to draw down funding.

#### **ECONOMIC WELLBEING PLAN - PROGRESS REPORT**

# Report by Head of Planning and Development

(Report No. 22/105)

#### 1. PROGRESS

1.1 This report provides an update on the delivery of actions within the Economic Wellbeing Plan. The plan was co-produced in the spring of 2021 by a Taskforce set up to help economic recovery as a result of the impact of Covid-19. It also outlines the Scottish Government's new National Strategy for Economic Transformation, which provides a new context for economic development delivery that the Council and partners will have to consider.

#### 2. RECOMMENDATIONS

#### 2.1 It is recommended that Council:

- (a) notes the good progress made to date in implementing the Economic Wellbeing Plan with 34% of the existing actions, excluding the new actions added for 22/23, on target and delivering positive outcomes.
- (b) notes that £1.14M of non-recurring expenditure to support further economic recovery has been provided by the Council in 2022/23
- (c) requests that the Economic Wellbeing Taskforce reviews the plan to provide reassurance that it is delivering against the current and future economic needs, and that it reflects the new National strategy for Economic Transformation, and refresh, as necessary.
- (d) requests that the Economic Wellbeing Taskforce continues to seek to secure external funding wherever possible, or re-direct existing resources to help to fund any new actions required.

#### 3. BACKGROUND

- 3.1 The Council approved an Economic Wellbeing Plan at its meeting on 31 March 2021 (Report No. 21/37 refers). The Plan was co-created with the members of the Economic Wellbeing Taskforce set up at the onset of the Covid-19 pandemic. The Economic Taskforce continues to monitor progress and to review the economic impact of the pandemic.
- 3.2 The approved plan named 73 actions under three broad headings of People (17 actions), Business (27 actions) and Place (29 actions). Good progress has been made in progressing the majority of these, although some remain unfunded and subject to review. In terms of a RAG rating, it is estimated 32% of projects are currently assessed as Green (underway and progressing to schedule); 47% rated Amber (started but some issues/delays); and 21% as Red (not started due to specific issues or no funding to progress).

- 3.3 In addition to delivering actions contained in the plan, over the past year, the Council has continued to support businesses and individuals in a wide range of other ways, including:
  - chairing and coordinating the Economic Wellbeing Taskforce which, in addition to the Council, comprises the Perthshire Chamber of Commerce, Business Gateway, Growbiz, Federation of Small Businesses, Department for Work and Pensions, Skills Development Scotland, Perth College UHI, PKAVS, Perthshire Tourism Partnership, Perth City Leadership Forum and the Perth Traders' Association. Three sub-groups were set up to monitor and co-ordinate delivery of actions.
  - continuing to administer and pay out multiple Scottish Government business grants totalling £85.5 million to more than 7000 businesses.
  - continuing to publish a regular Business Bulletin which is circulated to over 1000 businesses.
  - monitoring the local economy to assess the current economic situation and impact of Covid.
  - re-establishing the Local Employability Partnership to oversee local employability and skills delivery, including the monitoring of the significant support provided by Scottish Government through both the No one Left Behind and Young Persons Guarantee grants.
- 3.4 An update on all actions within the approved Economic Wellbeing Plan is detailed at Appendix 1. As agreed by Council, these represent a wide range of interventions that economic development practitioners across the partnership believe are needed to help the local economy recover. They include short-term response measures supporting business survival and keeping people in employment (now mainly complete); medium-term measures extending support to key sectors with catalytic investment projects to generate employment and confidence; and longer-term measures geared towards the decarbonisation and digitisation of the economy.
- 3.5 The overall cost of delivering the Economic Wellbeing Plan between now and 2024 was estimated to be in the order of £490m (with some capital expenditure beyond 2024). This is broadly allocated as follows:
  - People actions (£15m)
  - Business actions (£250m)
  - Place actions (£225m)
- 3.6 The capital expenditure identified in the plan is already largely secured through the Council's current budget, the Tay Cities Deal and other sources. Additional funding was secured through this year's revenue budget for:
  - Get Into Care Recruitment & Training Programme (£200K)
  - Eco Innovation Park revenue to support borrowing costs (£90K)
  - Additional funding for Support for Businesses/Micro Grants (£150K)
  - Additional funding for Business Accelerator Programme (£100K)
  - Additional funding for the Adapt Your Property Grants Scheme (£300K)
  - Additional funding for the Open for Business Fund (£200K)
  - Additional funding for Growbiz (£100K)

- 3.7 The Task Force partners will continue to endeavour to secure as much external funding as possible. One example was £105K secured this year from the UK Government's Community Renewal Fund to support a Training Programme delivered by Perth Autism and Perth College UHI on Neurodiversity and Cyber Security Skills. Further funding opportunities will be pursued via the new proposed Shared Prosperity Fund and through bids for any other funds that are appropriate.
- 3.8 Looking back over the first year of the Plan and delivery of actions, the three sub-groups have highlighted several Successes, Challenges and Opportunities under each theme.

#### 4. REVIEW OF ECONOMIC WELLBRING PLAN ACTIONS PROGRESS

# 4.1 People Actions Review for 2021/11

#### **Key Successes**

- Significant number of individuals supported into work via Employment Incentives:
  - PKC Rural Incentive 23 into work
  - Young Persons Guarantee Incentive 90 into work
  - NOLB/Adult Wage Incentive 15 into work
  - Four new Adult Skills Academies delivered in partnership with private sector & Perth College UHI
  - HGV/LGV driving course
  - Digital Skills
  - Hospitality
  - o STEM/Green Skills
  - 83 young people supported by Youth Work and 21 moved into positive destinations
  - New Parental Employment Support Programme in place supporting 36 clients to date.

# Challenges

- Late notification of Scottish Government Employability Grant Support, delaying design and delivery of actions
- Key local sectors are struggling to recruit into available vacancies including Care, Health, Distribution, and Hospitality
- Staff workload pressures.

#### **Opportunities**

- High number of local vacancies
- Additional financial resources provided by Scottish Government/UK Government

#### 4.2 Business Actions Review for 2021/22

## **Key Successes**

 Provision of emergency financial support to local businesses impacted by Covid restrictions, £85.5m distributed to more than 7,000 businesses through different schemes.

- Provision of business support to start-ups and businesses willing to grow:
  - Business Gateway: 185 business start-ups and 87 business growth, 62 businesses attending workshops and 114 attending digital boost workshops.
  - GrowBiz: 30 business start-ups, enhanced mentoring programme with 20 new mentors trained.
  - Accelerator: 12-week programme to encourage and support business creation and innovation in food and drink/creative industries/engineering/clean tech.
  - Advanced Growing and International Barley Hub

# Challenges

- On-going Covid restrictions impacting on mobilising resources and potentially slowing down recovery
- Restrictions to export markets beyond Scotland due to Covid and EU Exit
- Greater Covid impact on hospitality sector with slower recovery
- Delayed business and capital investment
- Digitalisation of the economy increasing competition
- Technological changes such as Artificial Intelligence development threatening business prospects and jobs

# 4.3 Place Actions Review for 2021/22

#### **Key Successes**

- Business occupation of space support for business to occupy public space on a temporary basis. The total number of approved requests is 51 (13 in towns and rural locations, 38 Perth city centre) since the launch of the scheme in 2020, with the scheme extended to March 2022 for occupation without the need for planning permission. Applications for permanent occupation of space from businesses have now been submitted given customer popularity, investment in materials, and the opportunity to contribute to greater vibrancy of the city and town centres.
- Marketing of local services in line with the national "Scotland Loves Local" initiative, a series of marketing campaigns were undertaken to provide a platform for local businesses. This included Christmas campaigns in 2020 and 21 with a printed "Gift Guide" featuring over 100 independent businesses distributed to over 70K homes in Tayside & Fife. This has led to increased local expenditure in independent shops, greater on-line sales locally, and improved financial performance.
- Vacant and Commercial Property Adaption and Improvement –
  implementation of Adapt Your Property and Open for Business Grant
  schemes to support property owners to develop new uses for property or
  improve existing commercial premises. 13 applications approved through
  Adapt Your Property fund has resulted in 8 commercial properties being
  brought back into use and a further 5 properties being converted from

- commercial to residential. 14 Vacant Property Feasibility grants were allocated, which has resulted in 23 residential properties, 7 commercial properties and 2 community properties being brought back into use. 51 premises supported by the Open for Business Fund in 2021/22.
- Visitor management greater co-ordination of Council and partner agencies' efforts in developing responses to visitor pressures through ranger services, enhanced waste services, and funding support for infrastructure secured through the Scottish Government's Rural Tourism Infrastructure Fund for three projects at Aberfeldy, Grandtully, and Loch Leven. Further details on outcomes achieved are contained within the Case Study within Appendix 2.

## **Challenges**

- The "stop / start" nature of lockdown restrictions has presented challenges for businesses in respect of marketing communications, with messaging and audience reach having to be adapted and curtailed, as necessary. The implementation of marketing campaigns to local and regional markets, and those undertaken in association with VisitScotland were impacted in this way.
- The release from lockdown also saw significant visitor related pressures being experienced by our rural communities with associated strain on visitor infrastructure. This persisted through 2021 although ameliorated by concerted and co-ordinated efforts by the Council and its partners. It is envisaged, however, that growth in the motorhome market, for example, will continue, with further investment needed in waste disposal, toilet facilities and appropriate stop over and parking facilities.
- International tourism markets are unlikely to return to 2019 values before 2024.
- Worsening outlook for city centre retail in the context of national trends for closures by multiples (e.g., Debenhams) as well as lower consumer confidence and discretionary spend.

### **Opportunities**

- Domestic tourism market recovery and desire for consumer markets to experience rural tourism destinations.
- Place based investment to support economic recovery, including a continued focus on adaptation of commercial property in city and town centres, and emergence of the "20 minute" neighbourhood" agenda of localism.
- Investment in cultural tourism assets through the Tay Cities Deal: City Hall; Pitlochry Festival Theatre; Aerospace Kinross; Innerpeffray Library; and Crieff International Highland Centre.

Further progress updates on all the original Wellbeing Plan actions are provided at Appendix 1 attached.

#### 5. CURRENT ECONOMIC CONTEXT

5.1 The latest Fraser of Allander <u>Economic Commentary</u> (Dec.21) predicted economic growth of 6.4% in 2021 and 4.7% in 2022, with the Scottish economy expected to get back to pre-pandemic levels in May 2022. However,

there are a number of significant challenges which will impact on economic growth going forward, such as rising inflation due to increasing energy prices, escalating transport and food costs as well as the instability caused by the war in Ukraine. All of this will put significant pressures on local businesses and families.

- 5.2 The Economic Wellbeing Plan noted concerns that unemployment would rise sharply when the Furlough Scheme ended last October, although this has not been the case. However, there are signs Scotland may be recovering more slowly than the UK, with both output and earnings lagging behind. The labour market overall is performing better than expected, with job vacancies now reportedly at their highest levels since records began.
- 5.3 At a Perth and Kinross level, unemployment based on those claiming Job Seekers Allowance has continued to fall from a peak during the pandemic of 4595 (5%) in August 2020 5% to 2565 (2.8%) in January 2022. This is nearly back to the pre-pandemic level of 1860 or 2% in March 2020. The highest % rise during the pandemic was for the 18-24 age group which saw a rise from 345 (3.3%) individuals in March 2020 to 1005 (9.7%). Universal Credit claimants (which will include some in work claimants) have significantly increased during the pandemic from 4968 in February 2020 to 9501 in January 2022 (+91%). Of these, 5524 are not in employment (+70%), and 3979 are in employment (+131%). The number of our tenants receiving Universal Credit for housing support has risen by 108% since March 2020, with 32% of these tenants now in arrears.
- 5.4 The table below provides a summary of economic activity before, and during, the peak of the pandemic. Overall, the numbers of those economically active have declined quite significantly (-8.7%), with the biggest change being a 40% decrease in the numbers self-employed in Perth & Kinross. The self-employed were particularly hard hit by Covid restrictions and lockdowns. Research shows that many reported working significantly less hours and receiving less income or have become economically inactive. This is a national trend; however, the numbers in Perth and Kinross have been impacted more significantly.

5.5 In terms of average earnings, Perth and Kinross residents have seen a relative year on year decline compared with Scotland as a whole, further evidence of the need to diversify the economy over time to create more higher skilled, higher paid job opportunities.

# 6. NEW NATIONAL STRATEGY FOR ECONOMIC TRANSFORMATION

- 6.1 Since the Economic Wellbeing Being Plan was published, a new National Strategy for Economic Transformation has been produced by the Scottish Government. A summary of this is outlined below.
- 6.2 An Advisory Council for Economic Transformation was created by the Scottish Government in July 2021 to develop a new National Strategy for Economic Transformation. Following extensive engagement with businesses, unions, and other stakeholders, the strategy was published on 1 March 2022 and sets out an ambitious vision with a focus on five key policy programmes. The full document sets out six programmes, including 18 projects and 77 actions in total.
- 6.3 The vision for Scotland in 2032 is a wellbeing economy: thriving across economic, social, and environmental dimensions, one that delivers economic prosperity for all Scotland's people and places.
- 6.4 When the vision is achieved, Scotland will be recognised at home and throughout the world as:
  - an international benchmark for how an economy can de-carbonise
  - the best place to start and grow a business or social enterprise
  - a magnet for inward investment
  - a great place to live and work with high living standards
  - a nation where people and businesses can continually upgrade their skills
  - a leader in research and development
  - a country where economic power and opportunity is distributed fairly
  - an outward looking nation exerting a meaningful influence
- 6.5 The five key policy programmes are highlighted below and are underpinned by a 6<sup>th</sup> strand focussed on delivery and accountability.



6.6 The key priorities under each programme are summarised below: -

Programme 1 – Entrepreneurial People and Culture

- Entrepreneurial Learning
- Entrepreneurial Infrastructure to support Learning and Company Growth
- Talent Attraction
- Building an Entrepreneurial Mindset

Programme 2 – New Market Opportunities

- Build on strengths to win a greater share of domestic & international market opportunities
- Support the development of Scottish supply chains, laying foundation for a net zero industrial strategy
- Attract and develop significant domestic & international private investment in Scotland

Programme 3 – Productive Businesses and Regions

- Improve connectivity infrastructure and digital adoption across the economy
- Upskill business and public sector leaders, driving productivity improvements
- Realise the potential of different economic and community assets and strengths of Scotland's regions

Programme 4 – Skilled Workforce

- Adapt the Education and Skills system to make it more agile and responsive to our economic needs and ambitions
- Support and incentivise people and employers to invest in skills and training
- Expand Scotland's available talent pool at all skills levels

Programme 5 – Fairer and More Equal Society

- Tackle Poverty through fairer pay and conditions
- Eradicate structural barriers to participation in the labour market

Programme 6 – A Culture of Delivery

- Strengthen accountability and transparency
- Transform the way support is delivered to people and businesses
- Measure success
- 6.7 A review of our current Economic Wellbeing Plan against the new National Strategy shows that it compares well in terms of coverage of the six key programmes or policy areas. However, our current Plan would benefit from further actions to address the NSET programme 5 which seeks to address a "Fairer and More Equal Society" tackling fairer pay and barriers to participation in the labour market. This would link clearly to our new Local Outcome Improvement Plan which seeks to target poverty and equalities as one of its key challenges. The Taskforce are requested to review and add any other actions required once the LOIP has been agreed by the Community Planning Partnership.

## 7. CONCLUSIONS

7.1 The Economic Wellbeing Plan sets out the Council and its partners' proposed response to the economic downturn and recession caused by Covid19. Good progress has been made in the first year of implementation. Further resources have been secured to support its on-going implementation and to develop new projects. The Economic Taskforce continues to meet to review progress and to consider new actions required. The Plan will need to be kept under

constant revision to ensure it includes any new actions or changes required as a result of the new National Strategy for Economic Transformation, and in terms of addressing continuing challenges faced by the local labour market and businesses.

#### **ECONOMIC WELLBEING PLAN CASE STUDIES - PEOPLE**

## Rural Employment Incentive – Support to Gillies and Mackay

Throughout the COVID-19 pandemic, employers around Perth and Kinross were hit particularly hard with some having to shut their doors until the Scottish restrictions were lifted. This luckily didn't affect one of our REI participants, Kieran Bain, who continued to provide an excellent standard of marketing and sales support all while working from home. We have worked alongside Managing Director of Gilles and Mackay, Cara Mackay, to provide job opportunities for young people in rural Perthshire supported by our Rural Employment Incentive funding. Cara approached Business Gateway back in 2020 and was shortly referred on to the Skills and Employment Initiatives team where we managed to identify relevant funding and support for the business. This resulted in a substantial funding package being created to help Cara sustain Kieran throughout his first year in employment. Kieran has now been a part of the #sheddie team for 9 months now, with a second member supported via the REI scheme who has recently joined the Sales and Marketing team.

We look forward to working with Gillies and Mackay for a second year and are proud to deliver savings to rural businesses through the Rural Employment Incentive.

## Parental Employment Support Fund (PESF) Futures For Families – the personal experience of a client.

"Without the support of the Parental Employment Support Fund - Futures for Families Elev8 Grant and the help, support and advice received from Rebecca Hogg, then my dream to be able to apply for the PGDE Primary Teaching course with Perth College UHI would still be a dream. I am 39 years old and have four children who are 12, 11 and 6 years old as well a baby of 10 months. The last 4 years has been an incredible journey, which has been very challenging, especially the last year due to the current Covid situation and home schooling, however I have just managed to finish my BA Honours Education (Primary) Studies degree with the Open University. However, to move forward I need to have Nat 5 Maths as well to be able to continue on the path of becoming a primary school teacher and this qualification was all that was holding me back as I could not afford the course fees. My tutor had saw the Parental Employment Support Fund - Futures for Families Elev8 Grant advertised when she was having her Covid vaccination and emailed me the details! I then contacted Rebecca and the support and advice I have received since then has been amazing. I can now continue with my dream and know I still have the support from Rebecca throughout my journey. I am so very grateful and feel so lucky that I have been provided with the amazing support from Rebecca and the fund, as without it I could never have progressed any further". Claire Rodger

## **CASE STUDIES - BUSINESS - Digitalisation of the economy**

The Perth and Kinross Economic Wellbeing Plan is supporting Perth and Kinross Businesses to take advantage of the opportunities offered by the digitalisation of the economy by creating or developing new products or services and accessing new markets and customers.

#### **Gigabit Connected Perth**:

Perth and Kinross's local Gigabit digital infrastructure has been significantly enhanced by public and private investment via funding from the Department for Digital, Culture, Media, and Sport (DCMS) Local Full Fibre Network programme and the Tay Cities Deal.

Spanning 19.5km, Perth's new, end-to-end full fibre network underpins significant digital infrastructure within the region. Completed by Neos Networks, the network is fully installed and ready for operation. It facilitates next generation technologies such as 5G and Internet of Things (IoT), crucial to future proofing businesses in the area and the region against the ever-growing demands of the digital economy.

Peter Asman, Managing Director for Public Sector & Enterprise at Neos Networks, said: "The importance of effective collaboration and constant customer contact has been key to the success of this project. Working in conjunction with Perth and Kinross Council has been outstanding and is a prime example of how public sector bodies and service providers can work in partnership to transform society and secure a gigabit-capable digital future for the community."

A similar contract has been deployed by BT Telecoms across Perth and Kinross area focusing on our towns and rural communities. In total the project secured significant external funding: £3.9M DCMS and £1M TCD and was completed in November 2021

136 public buildings connected and many 1000's more residential & business premises can now be connected to Full Fibre due to this investment in PKC properties.

#### **Business support:**

A series of actions included in the Economic Wellbeing Plan are supporting local businesses to move into the digital economy. These include: -

Through **the Micro grants scheme** which offers up to £1,000 to stimulate small scale business investment, numerous businesses have developed their offer on online through enhanced websites, CRM systems including social media interface as well as digitalisation of their back-office activities.

Through the **Market Development Grant** which offers grants up to £2,500, local businesses have reached out to customers beyond Scotland and attracted new orders. This is the case for *Make Tech Fly* which was founded by Andrew Douglas and is a Blairgowrie based business which provides technology solutions to the aviation industry. They were winners at Pitch@Revolution.Aero with their web application, AvioNexus, which was created to simplify the process of managing private flights.

Through the **Accelerator Programme** which is 12-week intensive support programme, new entrepreneurs have developed their ideas to set up a business in digital services. This is the case for *Perth Life*, which is an online platform created by Perth businesswoman, Hollie Irvine. The aim of Perth Life is to increase the awareness and engagement in the city's arts, culture & communities. During the COVID-19 pandemic, Hollie wanted to tell the stories that may be missed, and this platform was her answer to solving part of the problem. Hollie received Perthshire Chamber of Commerce Young Entrepreneur Star Awards 2021.

#### **CASE STUDY – PLACE - Rural Tourism Infrastructure Fund**

Successful applications to the <u>VisitScotland's Rural Tourism Infrastructure Fund</u> were made in 2020/21 totalling £900,000 +

### Improvements to Loch Leven Heritage Trail

#### 1. PURPOSE

## 1.1 This report:

 sets out proposals to deliver a comprehensive induction programme to provide the best possible support for new and returning elected members, in particular during their lead up to the summer recess.

#### 2. RECOMMENDATIONS

- 2.1 It is recommended that Council:
  - notes progress to date with the development of induction arrangements for elected members in Perth and Kinross Council following the Local Government Elections on 5 May 2022.
  - approves the proposed draft elected member induction programme set out in Appendix 1.

## 4. BACKGROUND

- 4.1 The Scottish Local Government Elections will take place on 5 May 2022 and it is important to ensure that elected members are able to access support for their own role, and to the various facets of Perth and Kinross Council (PKC), to support this critical period in office.
- 4.2 This is both an exciting and challenging time for the Council, and it is important that the induction programme provides the right information, to the right groups and in the right way. The range and scale of information which elected members need to access is significant, so manageability, pace and convenience were key factors in the design of the programme.

- 4.3 Feedback from previous induction programmes and discussions with existing elected member have provided a good starting point. An exit survey was issued to elected members in March to allow them to reflect on their term of office and the challenges they have had to overcome particularly over the last two years during the Covid pandemic. The feedback offered will help to further shape thoughts and ideas on what the ideal induction and future development programmes should contain.
- 4.4 A number of important themes during discussions with elected members have emerged
  - avoiding information overload in the early stages
  - using a variety of media to keep things interesting and interactive
  - ensuring that information can be accessed easily
  - knowing who to contact within services.
- 4.5 There is an emphasis on the need for councillors to have the skills and tools to carry out their role, and there are a number of checklists for councillors, and for chief officers, on a number of topics
  - Keeping governance up to date
  - Clear roles and responsibilities
  - Effective Scrutiny
  - Partnerships and Arm's Length Bodies
  - The role of Statutory Officers
  - Conduct and working relationships
  - Councillor's skills
- 4.6 There is further emphasis on the need for Council officers to support both new and returning councillors effectively by providing them with clear and understandable information, and access to necessary and essential training to help them fulfil their role.
- 4.7 A draft programme of induction activities focussed on the period to the summer recess has been developed. It is proposed that the majority of the programme will be delivered using internal expertise, and a number of methods will be deployed, such as face to face sessions, hybrid sessions (Councillors can chose to access the session in person in the Chamber or remotely from another location). Some of the sessions will be led by external practitioners for example for Planning and Licensing Board training, the Improvement Service have also been invited to deliver a session on roles and responsibilities. Sessions will be offered in line with the public health guidance at the time so the format, timing and delivery of sessions may be subject to change at short notice. In accordance with current advice, in person sessions may have number restrictions in terms of attendance. In these cases, it is proposed that more than one session be run. All internal sessions will be recorded and made available to view.
- 4.8 The structured programme is designed to ensure that elected members access relevant information and training that they need to fulfil their role and

provide adequate opportunity to develop effective working relationships with other members and officers.

## 5. PROPOSALS

## **Induction Programme**

- 5.1 The proposed induction programme for the first council period is contained at **Appendix 1** to this report. On election, new and returning councillors will be issued with a 'Welcome Pack' containing information on the code of conduct and guidance, the induction timetable and handbook. It is intended that paper copies of documents will be kept to a minimum, with web links being provided as far as possible and information being placed on the Councillors' Help and Information Page (CHIP) on the Council's Intranet.
- 5.2 Initially, the focus will be on supporting elected members to settle into their new role by providing information on the role itself (for example salary, remuneration, personal / professional interests etc). The next stage will be to promote an understanding of the role and responsibilities of an elected member within the context of Council priorities, services provided and the decision-making processes. Then elected members will gain an overview of the various committee structures and the Council's work with Community Planning Partners as well as governance and scrutiny frameworks. In broad terms the programme aims to provide relevant information, in an appropriate and structured way.
- 5.3 During the induction period, Services will be responsible for promoting understanding of the broad range of services and priorities within their own areas. Services will be looking to adopt a creative approach to engaging with councillors, conveners and committees including visits to premises, meeting key employees and short video presentations.
- 5.4 Following the Council's summer recess a programme of workshops and briefings will be delivered on a range of strategic risks and areas of importance. There will also be opportunities for elected members to learn about the statistics, facts and figures for their ward and for officers to showcase how the Council operates and works within wards/ localities and to share the local challenges/opportunities facing the Council.

## **IT Equipment**

- In order to ensure that councillors can participate fully in the developing digital environment, it is essential that they can access information whenever and wherever they need to. To facilitate that accessibility, all councillors will be issued with a Microsoft Surface Pro and offered a smartphone.
- 5.6 We will look to provide Councillors with their devices as soon as practicable after the election Councillors will be able to book a slot to pick up their devices, newly elected members first. IT support staff will provide basic training to ensure that all Councillors are able to log on and use their devices.

Further follow-up sessions will be offered for key tools such as Teams, Outlook and To Do - either one to one/group/remote/in-person, the preference would be for remote sessions to allow councillors to be familiar with using their devices. There are on-line resources available which will be made available to assist councillors to learn at their own pace.

## **Paperless Meetings**

5.7 In common with a number of other Councils, the adoption of a committee management system (CMIS) has allowed the Council to move to issuing papers electronically for Council and Committee meetings, and other meetings hosted by the Council. Training will be provided on options for viewing your papers electronically.

## **Councillors' Caseload Management**

5.8 A small number of councillors have recently been trialling Microsoft To Do which is a task management application, this application will allow Councillors to manage their enquiries from their mobile phones, tablet or computer. You will be able to download an application on your mobile telephones and devices to allow you to access Microsoft To Do direct.

## **Improvement Service**

- 5.9 The Improvement Service launched <a href="https://www.localcouncillor.scot/">https://www.localcouncillor.scot/</a> website in 2016. The website contains information on what a councillor does; what's expected of a councillor; how to become a councillor; and the support for councillors available from the Improvement Service. That support is in 4 key areas
  - <u>Induction Notebooks</u> links to which will be published on the Council's website and on CHIP and will be made available to candidates through the Council's website
  - <u>Briefing and guidance notes</u> covering a wide range of topical issues of interest to councillors
  - <u>Masterclasses</u> held across Scotland covering a mixture of topical and skills-based sessions that will support elected members to address the
  - key issues and challenges confronting local government

## **Specific Training and Development**

- 5.10 It is recognised that the membership of certain Committees, Boards and outside bodies etc. will require elected members to undergo specific training and development. Although this will require to be undertaken by a limited number of councillors, this will be a further time commitment for those councillors potentially quite soon after they have taken up office.
- 5.11 Specific training for Conveners and Vice Conveners has been arranged and will take place once the appointments have been agreed at the statutory meeting of the Council.

## **Personal Development Programme**

- 5.12 As the initial induction programme concludes, the next stage in the development cycle will begin it is anticipated that by September 2022, councillors will be settled in, and therefore ready to build on this more individualised approach to developing into their role.
- 5.13 The Improvement Service are currently developing a political skills assessment document this will enable councillors to consider how to how to take up and carry out different roles and responsibilities. The sole purpose of the assessment is to help councillors reflect on changes they want to make to better serve their constituents. Once the assessment has been completed, the responses can be used to facilitate face to face meeting with officers from Democratic Services and Organisational Development, this will result in the creation of a Personal Development Plan (PDP) which will set out the development opportunities which councillors wish to participate in over a particular time period.
- 5.14 This PDP process helps to inform the design and implementation of the ongoing elected member development programme, which offers a broad range of learning events, awareness raising and information update sessions for elected members.

#### 6. CONCLUSION

- 6.1 By providing a range of practical opportunities suited to both individual and collective needs, the proposed induction programme aims to support new and returning councillors, in particular during the first 100 days in office.
- 6.2 Supporting elected member development continues to be a key priority for the Council. Thanks to the experience and guidance of existing councillors, it is envisaged that this induction programme will provide a robust introduction to the different aspects of life within the Council.
