#### Environment Committee – 28 August 2013

Perth and Kinross Outdoor Access Forum

#### Barbara Renton, Depute Director (Environment)

This report summarises the activities and progress to date of the Perth and Kinross Outdoor Access Forum and recommends the reappointment of two members and the appointment of three new members to the Forum.

#### 1. BACKGROUND / MAIN ISSUES

1.1 Part 1 of the Land Reform (Scotland) Act 2003 requires local authorities to set up at least one local Access Forum and to appoint members to them.

The Act states that the functions of a Forum are:

'To advise the local authority and any other person or body consulting the forum on matters having to do with:

- the exercise of access rights
- the existence and delineation of rights of way or
- the drawing up and adoption of a plan for a system of core paths.
- 1.2 To offer and, where the offer is accepted, to give assistance to the parties in any dispute about the above and the use of core paths in order to resolve the dispute'.
- 1.3 This report follows on from report number 12/240 to the Environment Committee on 13 June 2012.

#### Membership

1.4 The Forum has sixteen members. Twelve members are voluntary and represent the interests of landowners/managers, community and recreation equally. These members are elected at an open meeting and their appointments confirmed by the Council's Environment Committee. The remaining members represent agencies and other bodies and are invited onto the Forum and appointed by the Environment Committee. The list of members and prospective members is shown in Appendix 1.

#### Annual Open Meeting and Election

1.5 The annual open meeting and election was held at Loch Leven Community Campus on 4 April 2013, with forty three people attended the meeting.

In each group, members stood down to vacate seats for the election;

- In the Recreation Group John Andrews (see Appendix 1) was re-elected unopposed.
- In the Communities Group Sandy Simpson (see Appendix 1) was reelected. Dave Prentice stood down on the night and Alison Gibb, who had put herself forward replaced him.
- In the Landowners / Manager's Group Edward Stewart stood down and Jane Anderson was elected in his place.
- In terms of the agencies and other bodies, Scottish Natural Heritage has a corresponding member and Alistair Watson has fulfilled this role since 2011. He has now left the organisation but Karen Mitchell has been put forward as a replacement.

#### Activities between June 2012 and July 2013

- 1.6 Nick Cole and Peter Pearson were elected as Convener and Vice Convener respectively.
- 1.7 Four ordinary meetings of the Forum took place in the period June 2012 to July 2013. The Exemptions and Obstructions Sub Group met on four occasions to assist officers to resolve and prioritise obstructions to public access and in relation to one Exemption Order for the Colin McRae Rally 2012.
- 1.8 Members of the Forum also attended meetings with Scottish Natural Heritage about their work, the Pitlochry Angling Club about an emerging dispute with other river users (see below), the National Access Forum and the Joint National Access Forum/Local Access Forums Meeting in November with reference to National issues.
- 1.9 Following a meeting with officers on 18 July 2012 the Forum wrote to the Council in relation to the Core Paths Implementation Plan on 21 July 2012. In the letter the Convener supported the Plan, stressed the importance of working in partnership with landowners and paths groups, and expressed concern about the resources allocated so far and the time it would take to fully implement the Core Paths Plan. It was noted however that the Council have no legal duty to implement the Core Paths Plan and that progress will be very dependent on the assistance and support available from all stakeholders.
- 1.10 The Forum took note of the legal processes taking place in relation to the dispute between commercial rafting and angling interests on the Upper Tay. Nick Cole was cited to appear as a witness but in the event the case was settled out of court.

- 1.11 Following the Tay Descent (a significant leading sector cance event from Dunkeld to Perth held in October 2012, and important to tourism) the Forum wrote to the Tay Salmon Fisheries Board about a series of incidents on the river. In his reply the Chair of the Board apologised to canceists, outlined the work the Board does to make owners and individual anglers aware of the event and undertook to do more and to plan around the event better in future years.
- 1.12 The Pitlochry Angling Club has asked the Forum for assistance in a dispute with other commercial users of the River Garry. To date that advice has been of a general nature. The Forum has suggested the Club make contact with the other users to discuss the matter.
- 1.13 Two media releases in relation to grouse shooting and deer stalking were issued.
- 1.14 The Forum pages on the website at <u>www.pkc.gov.uk/article/2142/Access-</u> Forum were updated as appropriate.

#### 2. PROPOSALS

2.1 It is proposed that the appointments of new and existing members are confirmed as members of the Forum (see Appendix 1) and that the filling of any casual vacancy arising is filled through recruitment by Forum members as detailed in the Forum's Terms of Reference.

#### 3. CONCLUSION AND RECOMMENDATION(S)

3.1 The Perth and Kinross Outdoor Access Forum has worked effectively during the period covered by this report. It has offered advice to the Council, organisations and the public with reference to access rights.

The Environment Committee is asked to:

- (a) Confirm the appointment of three new members and reappointment of two existing members to the Forum for a period of four years and confirm the members to be retained in their appointments for at least a further year all as recommended in Appendix 1.
- (b) Delegate to the Executive Director (Environment) the filling of any casual vacancy arising in this period through recruitment by Forum members as detailed within the Forum's Term of Reference.
- (c) Note the activities and progress of the Perth and Kinross Outdoor Access Forum from June 2012 to date.
