### PURPOSE OF REPORT

### 1. BACKGROUND / MAIN ISSUES

### **Tayside Procurement Consortium**

- 1.1 The Council established the Tayside Procurement Consortium (TPC) in 2008 (Report No 08/69 refers) to manage collaborative procurement activity on its behalf. The Council agreed the requirement for the TPC to submit a report on an annual basis detailing all collaborative tenders awarded for use by the Council.
- 1.2 The delegated authority to TPC to contract for goods and services is contained within the Council's Scheme of Administration which permits the Executive Director (Housing and Community Care) to approve TPC contracts on behalf of the Council in accordance with the Council's Contract Rules.
- 1.3 The contracts awarded by TPC under delegated authority therefore require to be reported on an annual basis in a Contract Award report to Strategic Policy and Resources Committee. **Appendix 1** contains the TPC contracts awarded between 1 April 2012 and 31 March 2013.
