## (ii) Update on the Community Safety and Environment Group

There was submitted and noted a briefing report by the Depute Director (Housing and Community Care) (14/336) providing the Committee with an overview of the elements of the Community Safety Action Plan presented to the meeting on 16 May 2014 of the Community Planning Community Safety and Environment Group.

## 583. FLOOD RISK MANAGEMENT – PROPERTY LEVEL PROTECTION PILOT SCHEME

There was submitted a report by the Depute Director (Environment) (14/362) on the role that flood protection products – known as Property Level Protection (PLP) - can play in improving the resilience of individual properties against flooding and recommends a pilot scheme for Perth and Kinross.

### Resolved:

- (i) That while Local Authorities and other public agencies had responsibilities to manage flooding, the primary responsibility for avoiding or managing flood risk still remained with the land and property owners be noted.
- (ii) The benefits that PLP can deliver in making properties more resilient to flooding be noted.
- (iii) The proposals for a PLP pilot scheme in Perth & Kinross be approved.
- (iv) The operation of the PLP pilot scheme in Aberfeldy, Comrie, Crieff and Pitlochry be approved.
- (v) That the pilot scheme may be extended to all of Perth and Kinross if it proved to be successful within the selected locations be noted.
- (vi) A further report be submitted to the Committee following the six month period, with recommendations based on the experience of the pilot.

# 584. PERTH AND KINROSS OUTDOOR ACCESS FORUM ANNUAL REPORT 2014

There was submitted a report by the Depute Director (Environment) (14/363) summarising the activities and progress to date of the Perth and Kinross Outdoor Access Forum and the appointment of members to the Forum.

#### Resolved:

- (i) The appointment of two new members; Mark Thomson and Donald Broad, both representing the Landowner/Manager Group as recommended in Appendix 1 of report 14/363, be approved.

- (iv) The filling of any casual vacancy arising in the following year be delegated to the Executive Director (Environment) in accordance with the Forum's Term of Reference.
