The Environment Service Scheme of Charges 2015/16

Report by Depute Director (Environment)

This report provides details of the charges in place for services provided by the Environment Service for financial year 2015/16. The charges are detailed in Appendix 1.

1. BACKGROUND

1.1 A review of charges for services was undertaken by the Scrutiny Committee with the final report "Scrutiny Review Charging for Services 2014" being approved by the Scrutiny Committee on 28 January 2015 (report no 15/65 refers). This report recommended that Services submit a revised scheme of charges annually to the relevant themed committee.

2. PROPOSALS

- 2.1 The Environment Service provide a diverse and wide range of chargeable services to the public and business community ranging from burials and planning fees to parking and commercial waste.
- 2.2 The charging arrangements are set based on a combination of legislative requirements, national policy guidance, market competition and local guidance. As a result there is a mix of discretionary and non-discretionary charges levied by The Environment Service.
- 2.3 All income generated by charges contributes to service budgets and ensures the continued development and delivery of high quality services.
- 2.4 Appendix 1 provides a detailed breakdown of the charges levied with effect from 1 April 2015, for the services areas linked to The Environment Committee.
