

PERTH AND KINROSS COUNCIL**Strategic Policy & Resources Committee****27 November 2013****ANNUAL REPORT FOR FOLLOWING THE PUBLIC POUND 2012/2013****Report by the Head of Legal Services****PURPOSE OF REPORT**

This report describes the Council's arrangements for funding external bodies and Following the Public Pound (FPP) and monitors the Council's performance against the Code of Guidance for Funding External Bodies and Following the Public Pound for the financial year 2012/2013. The report also seeks approval for the minor changes to the Code of Guidance for Funding External Bodies and Following the Public Pound

1. BACKGROUND / MAIN ISSUES

- 1.1 'Following the Public Pound' means ensuring that there is proper accountability for public funds used in delivering services and providing social benefits, irrespective of the means of delivering them.
- 1.2 Each Executive Director is responsible for ensuring that there is clear public accountability for public funds which are provided from their Service budgets to outside organisations.
- 1.3 In common with other local authorities, the Council uses a number of external organisations to assist in the provision of its services. These external organisations include both private and voluntary sector providers.
- 1.4 Many of these arrangements are established through a commercial tendering process which results in formal contracts. The Council also enters into partnerships with service providers, particularly in the voluntary sector, and manages these through Service Level Agreements.
- 1.5 The Council developed a Code of Guidance based on the Code of Guidance on Funding External Bodies and Following the Public Pound issued by the Accounts Commission in co-operation with COSLA. A comprehensive review of the Code is taking place to ensure that it is fit for purpose and relevant to the current operational requirements.
- 1.6 The Code covers all external bodies which receive a grant or financial support from the Council. A 'grant' or 'financial support' does not include payments made under a commercially tendered contract for goods or services.

- 1.7 Discussions have taken place regarding exactly which agreements fall within the scope of Following the Public Pound to ensure that there is no duplication of reporting and adequate monitoring of all funding agreements. Work continues in this area.
- 1.8 The Code details the financial and other checks which are required to be carried out when assessing the suitability of external organisations. The degree of scrutiny is determined by the level of funding to be given to each organisation. This is meant to minimise any risk to the Council and also ensures that the requirements placed on small organisations are not too onerous.
- 1.9 In line with Internal Audit recommendations the Code has been amended to detail an 'explicit right of access' to the Council's External Auditors. In addition the funding band thresholds have been changed to provide clarity in regard to funding amounts. The revised code is attached as Appendix 3 and the changes to the Code have been highlighted for ease of reference.
- 1.10 A further review of the Code is to be carried out before the end of this financial year. This review will be carried out by a small working group comprised of officers of the Following the Public Pound Group and will concentrate on whether the Code's financial scrutiny requirements are fit for purpose. The Following the Pound Group meets quarterly and comprises of officers whose role is to monitor and implement the FPP system.
- 1.11 During the course of the financial year 2012/2013 an organisation in receipt of funding from the Council incurred a significant deficit. A review of the circumstances of this case, relevant to the FPP regime, will be carried out to ascertain what, if any, changes or improvements to the Code are necessary.
- 1.12 The Head of Legal Services is responsible as the compliance officer for Following the Public Pound. The Policy and Governance Group meet quarterly and act as the Project Board for Following the Public Pound. This Group's remit is to ensure that in respect of corporate governance that various regimes, one being FPP, are operating effectively and that they are fit for purpose. In addition the Group can make recommendations to the Executive Officer Team when incidents occur which are the result of a failure of proper corporate governance.
- 1.13 A self-assessment form is issued on a yearly basis to those Services who award monies to organisations covered by the Code. The findings in this report are based on the self-assessment responses.
- 1.14 This report is the fourth annual Following the Public Pound report.

2. CENTRAL REGISTER

- 2.1 The Council developed an electronic register for Following the Public Pound to comply with Audit Scotland recommendations. However the register has not proved as useful as anticipated and a review is currently being carried out

to ensure that it captures all relevant information for Services in a way that is efficient. The main problem has been the lack of a link between the Register information and the Integra Financial system. Work is currently being carried out to ascertain if such a link can be developed.

- 2.2 In addition the review is also considering whether there are other options that can be utilised to store the Following the Public Pound information. One of the options that have been looked at was the possibility to store the FPP information on the Council's Contracts Register. However this option has been discarded as this register would also have to be modified before it could be used.

3. FPP INFORMATION FOR 2012/2013

- 3.1 The information provided by Services has been collated and is summarised below.
- 3.2 During the financial year 2012/2013, the Council provided funding amounting to £10,913,393 to 248 organisations. This compares with £11,515,752 to 271 organisations in 2011/2012 and £10,113,820 to 222 organisations during the financial year 2010/2011.
- 3.3 A complete list of the funding provided during 2012/2013 is attached as Appendix 1.
- 3.4 Any questions about the organisations or the work that they carry out on behalf of the Council should be addressed to the relevant Service.
- 3.5 Audit Scotland recommends that organisations which receive more than one payment in a financial year should be identified. 32 organisations fell into that category during financial year 2012/2013 and are detailed below and highlighted in Appendix 1. The total amounts given were as follows: -

3.6 As indicated earlier, the level of checks is determined by the level of funding given to each organisation. The following funding bands are used to determine the level of checks required:

- Annual Funding in excess of £50,000
- Annual Funding between £15,000 and £50,000
- Annual Funding between £2,000 and £15,000
- Annual Funding below £2,000

3.7 The Council provided funding to 24 organisations in excess of £50,000 during 2012/2013. The total amount paid to these organisations was £9,376,250.

- Written agreements are in place with all these organisations
- A Schedule of Payments is in place and signed for all organisations
- Monitoring Officers have been identified for all organisations and no organisation has been paid without the proper financial checks being completed.

3.8 The Council provided funding to 30 organisations between £15,000 and £50,000 during 2012/2013. The total amount paid to these organisations was £1,008,970.

- Written agreements are in place with all these organisations
- A Schedule of Payments, is in place and signed for all organisations
- Monitoring Officers have been identified for all organisations and no organisation has been paid without the proper financial checks being completed.

- 3.9 The Council funded 51 organisations with between £2,000 and £15,000 during 2012/2013. The total amount paid to these organisations was £435,676
- Written agreements are in place with all these organisations
 - Financial checks have been carried out for all organisations, including review of most recent organisational accounts and confirmation of bank details
 - Monitoring Reports for all organisations have been produced and no organisation has been paid without the proper financial checks being completed.
- 3.10 The Council funded 143 organisations with less than £2,000 during 2012/2013. The total amount paid to these organisations was £92,497.
- Written agreements are in place with all these organisations
 - Financial checks have been carried out for all organisations, including review of most recent organisational accounts and confirmation of bank details
- 3.11 Where the Council has entered into a financial arrangement with an external organisation which results in that organisation being treated as a 'subsidiary' in terms of the Group Accounts in the Council's Final Accounts for 2012/2013, then further scrutiny and reporting is required by means of summarised plans and management accounts. For all such organisations these have been reviewed by a relevant officer in the Finance Division and the results included in the Council's Annual Governance Statement for 2012/2013
- 3.12 A Register of Interests for members participating on external boards or committees is maintained by the Chief Executive's Service. A review is currently underway to ensure that Services record conflicts of interest for all officers who sit on management boards, or who are otherwise involved with Following the Public Pound organisations. This information is to be held centrally until the review into the use of the Central Register is completed.
- 3.13 Services have reported that they do provide assistance in kind to organisations in the form of free meeting rooms, insurance provision and concessionary lets. Services do not record or cost this assistance in kind. A request has been made that Artifax, the room booking system, is amended to ensure that it can provide the necessary information about concessionary lets for inclusion in the 2013/2014 annual report. The total value of Discretionary Rates relief awarded to organisations in receipt of funding for financial year 2012/2013 is detailed at Appendix 2.
- 3.14 Services have reported that all awards of monies have been properly authorised through either a relevant committee or the Financial Assistance Panel.

4. RISK ASSESSMENT

- 4.1 A risk assessment framework is included in the Code of Guidance. The framework has differing requirements determined by the level of funding to the organisation. The risk assessment results should be recorded in the Central Register but a copy of these results will be held centrally under the Central Register when the review is completed.
- 4.2 Services have reported that they have not carried out risk assessments for all organisations that have been funded over £50,000. Services have been asked to ensure that these assessments are carried out before the end of 2013 and that they provide this information so that it can be stored centrally until the review into the use of the Central Register is completed.

5. TRAINING

Services continue to provide staff with training that directly contributes to ensuring that the Following the Public Pound Code of Guidance is fully complied with. During the 2013/2014 financial year Housing & Community Care provided training to seven members of the Commissioning and Contracting Team. Education and Children's Services report that one member of staff has been trained and further training is planned for all Monitoring Officers and Administrative staff directly involved with the monitoring of Service Level Agreements. Therefore, within the last two years a total of 45 members of staff have been trained in addition to training provided to eleven external organisations.

6. CONCLUSION AND RECOMMENDATION(S)

Further work is required to ensure that the FPP system is compliant with Audit Scotland recommendations. This work will be undertaken during the financial year 2013/2014.

EXPLANATION OF TERMS

Certain words assume quite specific meanings in this code and these are set out below.

outside organisation

- Includes all arm-length companies, trusts, voluntary organisations and grant aided bodies

straightforward contract

- An agreement for the provision of good or services between the Council and another organisation as a result of a normal commercial process, such as an open tender.

funding

- Includes monies, grants, capital grants, guarantees, loans, common good fund, shares, assets and assistance in kind

assistance in kind

- Includes
 - all staff time associated costs involved in enabling the outside organisation to carry out its core activities which are essential to its continued existence e.g. administrative support, professional services, advice, accommodation, rates remission, use of equipment, training, preparation of material for reporting to Council etc
- but does **not** include
 - staff time and associated costs involved in supporting and developing groups as part of Council's duty to promote and support community action
 - staff time and associated costs in providing advice on setting up the funding and applications to Council
 - staff time and associated costs incurred in the formal monitoring and review of funding arrangements by Council

substantial to Council

- funding arrangements which are substantial to the receiving organisation are those where funding including assistance in kind, is in excess of £50,000 per annum, whether revenue or capital funding, recurring or non-recurring
- this refers to the total funds received from all sources within Council

substantial to the receiving organisation

- funding arrangements which are substantial to the receiving organisation are those where funding, including assistance in kind, represents at least 30% of the outside organisation's annual funding and is critical to its survival. This applies to revenue, capital, recurring and non-recurring funding
- this refers to the total funds received from all sources within Council

representation

- means acting as a full member of a board or management committee of an outside organisation in a decision-making capacity with full speaking and voting rights

participation

- includes acting as a representative, adviser or observer at meetings of outside organisations

1. SCOPE & SUMMARY

- 1.1 'Following the Public Pound' means ensuring that there is proper accountability for public funds used in delivering services, irrespective of the means of service delivery.
- 1.2 It is the responsibility of each Executive Director to ensure that there is clear public accountability for public funds which are provided from their Service budgets to outside organisations.
- 1.3 The concept of 'Following the Public Pound' applies when the Council decides to fund external organisations which deliver services that might otherwise be delivered by the Council itself. In these arrangements, the Council agrees to provide funds and other resources to companies and organisations for the delivery of specified services.
- 1.4 This does not apply when the Council's financial relationships with external organisations are on a straightforward contractual basis such as those resulting from open tender. It does apply to all other arrangements, ranging from one-off grants to voluntary organisations to large-scale regular contributions to the operating costs of organisations created by the Council to provide services previously provided by them directly.
- 1.5 The Code covers all external bodies who receive a grant or financial support from the Council. As stated above, "grant" or "financial support" does not include payments made under a straightforward contract for goods and services.
- 1.6 The level of financial checks required will be determined by the level of funding given to each organisation. This will minimise the risk to the Council and also ensure that the requirements on small organisations are not too onerous.
- 1.7 The Risk assessment procedures will be based on the funding band and will take into consideration the organisation's performance arrangements.
- 1.8 The Council will provide assistance in kind to outside organisations in line with criteria aimed at securing consistency and equity across Council services. The true cost of assistance in kind, net of contributions by the outside organisations, will be taken into account in the allocation of funding. In determining the true cost of assistance in kind, note will be taken of the Council's corporate policy of charging for Council services on a full cost-recovery basis subject to policy exemptions and in line with statutory requirements and good practice guidance (re property).
- 1.9 Potential conflicts of interest that arise when elected members or officers sit on the boards or committees of outside organisations funded by the Council will be removed through the use of funding agreements. These written agreements will define roles, responsibilities and liabilities and will be used to define clear and unambiguous relationships.
- 1.10 The Council will only seek representation on the board or committee of an outside organisation where

- the organisation clearly contributes to the achievement of the Council's strategic aims,
- the organisation is considered to be a strategic partner and
- it is important for the Council's commitment to be visible or no funding agreement is in place.

Where this situation exists and funds are also transferred to the outside organisation, the Council will contribute management skills to the board.

1.11 To determine the checks required, the following funding bands will be used:

- Annual Funding in excess of £50,000
- Annual Funding between £15,001 and £50,000
- Annual Funding between £2,001 and £15,000
- Annual Funding £2,000 and below

1.12 For all organisations who receive such funding, the Council will identify: -

- The budget holder within the Council Service
- The responsible Accountant(s) and Monitoring Officer
- The budgeted contribution

1.13 The Council will maintain an up-to-date central register of all organisations that receive funding and produce an annual report to the relevant committee.

1.14 The Council will maintain an up-to-date register of interests and indemnity arrangements for those participating on external boards

2. Where Annual Funding is Greater than £50,000 per annum

2.1 Information Required from the Funded Organisation

2.1.1 The following list is the minimum information requirements of the Council and the timescales in which these are required:

- Detailed one year business plan and summary three year business plan provided at least 1 month before the commencement of the Council's financial year.
- Detailed monthly cash flow forecasts for one year as above.
- Six monthly management accounts to be submitted no later than 6 weeks after the period end to which they relate.
- The organisation must provide a Balance sheet or a set of Annual accounts for the preceding financial year audited or verified by an appropriately qualified person independent of the Committee, including capital held on trust, or otherwise. In the case of an organisation recognised as a charity, the organisation will have to follow the guidance from the Office of the Scottish Charity Regulator to check if an audit or an independent examination is required. Accounts are to be submitted as soon as the examination is completed. If accounts are not lodged by 12 months after the year-end, then the Council is advised of the reason for the delay.
- Use of a Quality Assurance System, for example PQasso.

2.1.2 In addition to the minimum requirements as set out above, other appropriate information will be sought as good practice, e.g.:

- Regular performance against pre-defined targets, i.e. visitor numbers, etc.
- Copies of (non-confidential) Minutes of the Board of Directors or trustees meeting.

2.2 Financial Checks to be completed by the Council

2.2.1 The following list details the financial checks that must be carried out by Council staff and the timescales for completing these checks.

2.2.2 Checks required every two years:

- Ensure that the organisation has adequate policies and procedures in place to govern the way their finances are handled
- Ensure that sound accounting practices have been adopted which comply with all relevant Accounting Standards and that adequate accounting and External Audit arrangements are in place

2.2.3 Annual checks:

- Check that the projections in the business plan are realistic and achievable. This should be completed by checking with past performance and extrapolation of current trends.
- Check that sufficient cash exists to ensure the monthly cash flow projections can be financed.
- Check that adequate provision has been made for depreciating fixed assets.
- Ensuring that the organisation has adequate insurance cover to meet all known risks.
- Check that any other material sources of external funding are secure. This should be completed by writing to all other external funding organisations.

2.2.4 When the above annual checks have been completed, an annual risk analysis should be carried out of the organisation's business plan. Where the funded organisation does not meet the risk analysis criteria, future discussions will take place with the organisation to review its business plan and cash flow projections. The purpose of the risk analysis is to assess how changes in income and expenditure will impact upon the organisations future viability.

2.3 Ongoing Checks

2.3.1 The following should be completed on an ongoing basis:-

- Check the six monthly Management Accounts to ensure that there is sufficient cash to meet the organisations outgoings for the forthcoming year. Should there be insufficient funds to meet the organisations projected cash flow, or where a request for additional funding is submitted, the relevant Accountant should be informed.

2.4 Approval, Monitoring & Reporting Process

- 2.4.1 Approval will be given by the Strategic Policy & Resources Committee (if funding from Financial Assistance) or other appropriate Council Service Committee.
- 2.4.2 The monitoring body will be the approving Committee with a half yearly report from the Monitoring Officer.
- 2.4.3 Annual report to the approving Committee.
- 2.4.4 Service level agreement covering a period of 3 years or more where appropriate

3. Where Annual Funding is between £15,001 and £50,000 per annum

3.1 Information Required from the Funded Organisation

- 3.1.1 The following are the minimum information requirements of the Council and the timescales in which these are required.

- The organisation must provide a Balance Sheet or a set of Annual accounts for the preceding financial year audited or verified by an appropriately qualified person independent of the Committee, including capital held on trust, or otherwise. In the case of an organisation recognised as a charity, the organisation will have to follow the guidance from the Office of the Scottish Charity Regulator to check if an audit or an independent examination is required. Accounts are to be submitted as soon as the examination is completed. If accounts are not lodged by 12 months after the year-end, then the Council is advised of the reason for the delay.
- Organisation Strategy
- Organisation risk self-assessment
- Future plans/end of project
- Management and control procedures
- Use of a Quality Assurance System for example, PQasso

- 3.1.2 In addition to the minimum requirements as set out above, other appropriate information will be sought as good practice, e.g.

- Regular performance against pre-defined targets, i.e. visitor numbers

3.2 Financial Checks to be completed by the Council

- 3.2.1 The following details the financial checks that must be carried out by Council staff and the timescales for completing these checks.

3.3 Annual Checks:

- Check that adequate provision has been made for depreciating fixed assets.
- Check that sufficient cash exists to ensure the viability of the organisation throughout the course of the financial year.

3.4 Approval, Monitoring & Reporting Process

3.4.1 Approval by appropriate Council Service Committee, Sub-Committee or through Service-based budget approval process.

3.4.2 The monitoring body will be the relevant Council Service with a half yearly self-monitoring report from the recipient organisation covering service and financial performance and any significant changes.

3.4.3 Annual report to appropriate Council Committee or Sub-Committee.

3.4.4 Service level agreement covering a period of 3 years or more where appropriate

4. Where Annual Funding is between £2,001 and £15,000 per annum

4.1 Information Required from the Funded Organisation

4.1.1 The following are the minimum information requirements of the Council and the timescales in which these are required.

- The organisation must provide a Balance sheet or a set of Annual accounts for the preceding financial year audited or verified by an appropriately qualified person independent of the Committee, including capital held on trust, or otherwise. In the case of an organisation recognised as a charity, the organisation will have to follow the guidance from the Office of the Scottish Charity Regulator to check if an audit or an independent examination is required. Accounts should be submitted as soon as the examination is completed. If accounts are not lodged by 12 months after the year-end, then the Council is advised of the reason for the delay.
- Annual sample of payments checked.
- Organisation risk self-assessment
- Future plans/end of project
- Management and control procedures

4.2 Approval, Monitoring & Reporting Process

4.2.1 Approval by Council Service Committee, Sub-Committee or through Service-based budget approval process.

4.2.2 The monitoring body will be the relevant Council Service with a six-monthly self-monitoring report from the recipient organisation covering service and financial performance and any significant changes.

4.2.3 Annual reporting to Council Head of Service.

4.2.4 Some form of written funding agreement

5. Where Annual Funding is £2000 and below

5.1 Information Required from the Funded Organisation

- 5.1.1 The following determines the minimum information requirements of the Council and the timescales in which these are required.
- The organisation must provide a Balance sheet or a set of Annual accounts for the preceding financial year audited or verified by an appropriately qualified person independent of the Committee, including capital held on trust, or otherwise. In the case of an organisation recognised as a charity, the organisation will have to follow the guidance from the Office of the Scottish Charity Regulator to check if an audit or an independent examination is required. Accounts should be submitted as soon as the examination is completed. If accounts are not lodged by 12 months after the year-end, then the Council is advised of the reason for the delay.
 - An annual sample of payments should be checked
 - Organisation risk assessment
 - Record of money spent
 - Future plans/end of project
 - Management and control procedures

5.2 Approval, Monitoring & Reporting Process

- 5.2.1 Approval through budget process and appraisal by Council Service Officers.
- 5.2.2 The monitoring body will be the relevant Council Service with a six-monthly self monitoring report from the recipient organisation covering service and financial performance and any significant changes.
- 5.2.3 Annual reporting to Council Head of Service.
- 5.2.4 Some form of written funding agreement

6 Payments

- 6.1 A schedule of payments will be agreed with the receiving organisation prior to the commencement of the financial year. The payments should be tailored to meet the cash flow projections as detailed in the business plan. Payments in excess of £10,000 per annum should be least 2 instalments per financial year and preferably made monthly to minimise the Council's exposure in the event of the organisation encountering financial difficulties.
- 6.2 No payments will be made to the organisation until all financial checks have been completed to the satisfaction of Council staff, and all the required information has been submitted by the organisation.

7 Funding Agreement

- 7.1 All organisations covered within the scope of this procedure must have a **Funding Agreement**.

The Funding Agreement can take several forms – Service Level Agreements or, for Grants, the application form and conditions of approval. The length and detail of a Funding Agreement will vary depending upon the nature and size of the funding given. The Funding Agreement should be in place within three months of the date of the decision to provide funding.

7.2 This agreement must include non-financial targets and information, but as a minimum the following must be included:

- Contribution to the Council's strategic aims and objectives
- The purpose of the funding and the expectation of use
- Councils strategy or policy that the funding is linked to
- Service outcomes and targets
- Risk in relation to the Council's strategic aims
- The Council's financial contribution
- Management and Control arrangements
- Accounting, reporting and audit requirements
- Financial requirements
- Operational requirements
- Monitoring and reporting requirements
- Disputes and Complaints procedures
- Evaluation and review procedures
- Ability of the Council to deduct any debts due to the Council prior to making any further grants.
- Access by Council staff, including **an explicit right of access for** Internal and External Audit staff, to the records of the organisation.
- Council representation of Elected Members and Officers
- Procedures for cancelling the Funding Agreement (Exit Strategies)

8. 'Group Accounts' Concept

8.1 Where the Council has entered into a financial arrangement with an external organisation which results in that organisation being treated as a 'subsidiary' in terms of the Group Accounts concept under the Accounting Code of Practice then the following will apply:

- Summarised business plans and management accounts will be reviewed by a relevant officer and the results included in the Annual Governance Statement.

9. Representation & Participation in Outside Organisations

9.1 Where the Council participates as a decision-maker, adviser or observer of the external body, the Council will enter into a written agreement with the external body which will include a

- Relationship Statement
- Job Description
- Induction
- Reporting Requirements
- Speaking and voting Rights

- Observer Status
- Liability & Responsibility Statement
- Evidence of the legal form(s) of the external body
- Evidence of indemnity against liability risks
